INDEPENDENT AUDITORS' REPORT

To the Trustee of
403(b) Thrift Plan of Community Action Program Belknap and Merrimack Counties, Inc.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Community Action Program Belknap and Merrimack Counties, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan of Community Action Program Belknap and Merrimack Counties, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in **Note 4** to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan of Community Action Program Belknap and Merrimack Counties, Inc. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTE 1. DESCRIPTION OF PLAN

The following description of the 403(b) Thrift Plan of Community Action Program Belknap and Merrimack Counties, Inc. formerly; Community Action Program Belknap-Merrimack Counties, Inc. 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which became effective March 12, 1994, is a defined contribution plan covering all eligible employees of Community Action Program, Belknap-Merrimack Counties, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee oversees governance of the Plan, the appropriateness of the Plan's investment offerings and monitors the investment performance.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation up to the maximum annual limit provided by the Internal Revenue Service, as defined in the Plan. Participants may also contribute amounts representing pre-tax distributions from other qualified defined benefit or contribution plans. The Plan provides a matching contribution equal to 100% of the first 5% of a participant's contribution. Contributions are subject to certain limitations as defined in the plan document. Total matching contributions to the Plan for 2024 and 2023, were \$204,964 and \$210,381, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings (losses) and is charged with an allocation of administrative expenses, depending on the participant's choice of investments. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their account and the employer matching contributions. Accordingly, there were no forfeited non-vested accounts.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions to one or more of the investment options offered by the Plan. Participants may change their investment options and make transfers between investments at any time via Mutual of America Life Insurance Company automated system, with Human Resources, or by phone. All investments of the Plan are self-directed.

Plan Loans

The Plan allows for participant loans based on a participant's vested account balance. These loans are issued and held directly by Mutual of America and are collateralized by the Participant's account balance in the Plan. Generally, a participant's outstanding loans may not exceed 50% of a participant's account balance or \$50,000 and are secured by the remaining balance in the participant's account.

Under the Plan agreement the loan requests processed are directly paid to the participant, and the participant's funds equal to the amount of the loan are transferred into the interest accumulation account as security. Participants paid interest at rates ranging between 4.60% and 5.85% on all outstanding loan balances to Mutual of America and earn the then prevailing rate on the interest accumulated account, approximately 2.85% for 2024 and 1.5% for 2023. For the year ended December 31, 2024 and 2023 the Plan loans totaled \$102,812 and \$52,829, respectively, with maturity dates ranging from November 2025 through August 2031.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount, a direct transfer to another qualified retirement account, or a combination of the two, equal to the participant's vested interest in his or her account; or periodic installments over a designated period.

Benefit payments are recorded when paid.

Upon termination of service, a participant, unless electing otherwise, will begin receiving payments as soon as practical based on the preceding valuation date. Employees with a balance of \$1,000 or greater have the right to keep their retirement account in the Plan or elect to have the benefits paid in a lump sum. Participants with a balance of less than \$1,000 automatically receive a lump sum payment as soon as feasible following separation.

In-Service & Hardship Withdrawals

An employee is permitted to take a distribution while being an active participant in the Plan once the age of 59 ½ is attained. Such distributions will not be subject to a 10% excise tax but may be subject to income taxes.

An employee may take a distribution from the Plan if a heavy financial burden, as defined by the Plan, can be demonstrated to the Plan Trustee. Hardship distributions require a written request and are limited to the participant's elective deferrals and are generally subject to income tax, and may be subject to a 10% excise tax.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets during the reporting period. Actual results could differ from those estimates. See **Note 3** for discussion of fair value measurements.

Cash and cash equivalents

Cash and cash equivalents are almost entirely comprised of Mutual of America Life Insurance Company's Interest Accumulation account. This investment does not carry front-end or back-end charges, nor is the interest dependent on a certain holding period. Withdrawals may be made at any time by the participants.

Investment Valuation and Income Recognition

Investments are reported at fair value except the Interest Accumulated Account. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information provided by the custodian. See **Note 3** for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participant's account and amounts reported in the statements of net assets available for benefits.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no material changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds (Level 1): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

Mutual Funds (Level 2): Valued at the closing price as reported by the fund. The level 2 mutual funds are internally managed by the asset custodian Mutual of America Life Insurance Company and are valued based on the underlying assets, which are generally traded in active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. ADMINISTRATIVE EXPENSES

The Company provides certain administrative and accounting services to the Plan at no cost, and pays for the cost of the Plan audit. For the years ended December 31, 2024 and 2023, administrative expenses in the statements of changes in net assets available for benefits consist of loan and withdrawal fees and other investment expenses charged by the asset custodian.

NOTE 6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Mutual of America Life Insurance Company is the asset custodian and third-party administrator, as defined by the Plan. Therefore, those transactions qualify as a party in interest transaction. The Trustee also currently participates in the Plan.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7. TAX STATUS

The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
