### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Walsh Group Employees' Profit Sharing Trust, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Walsh Group Employees' Profit Sharing Trust financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of Plan**

The following brief description of the Walsh Group Employees' Profit Sharing Trust (Plan) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

***General***

The Plan is a defined contribution plan covering all full-time employees of the participating employers under the common control of the Walsh Group (Company) not covered by collective bargaining agreements who have completed at least three months of service, have reached the age of 18 and have made a tax deferred election under Section 401(k) of the Internal Revenue Code (IRC) to have from 1% to 100% of their compensation contributed to the Plan. All non-trade employees hired (or rehired) on or after January 1, 2018, will be automatically enrolled with a pre-tax contribution rate of 4% unless otherwise elected, with an auto-escalation of 1% per year to a maximum of 10%. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

***Employer Contributions***

The Company contributes 100% of the first 4% of compensation that a participant contributes to the Plan.

***Participant Accounts***

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contribution and (b) plan earnings, including increases or decreases in the fair value of investments, and charged with an allocation of plan administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Except for discretionary employer contributions transferred to the Plan from R & L Brosamer, Inc. 401(k) Retirement Plan, participants are immediately vested in their voluntary contributions and employer contributions.

The portion of the participants' accounts attributable to contributions transferred from the R & L Brosamer, Inc. 401(k) Retirement Plan becomes vested based on years of service. A participant is 20% vested after two years of credited service and 20% each year thereafter, becoming 100% vested after six years of credited service.

***Notes Receivable From Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested value of their accounts attributable to elective deferrals including earnings thereon and any rollover contributions including earnings thereon. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50% at December 31, 2024, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through withholdings from participants' paychecks.

***Payment of Benefits***

Upon becoming eligible for payment of benefits, a participant's account may be distributed (a) as a lump-sum amount or (b) in equal annual installments over a period not to exceed ten years.

If a terminated participant has a vested account balance of less than \$5,000 and the participant fails to timely elect to distribute their account, the entire vested account will be rolled over to an IRA selected by the plan administrator.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination or discontinuance of contributions (as defined by the Plan), the vested interest of each participant shall be 100% and will be distributed on receipt of a determination letter from the Internal Revenue Service, less a proportional share of income taxes payable by the Plan, if any.

***Forfeitures***

The nonvested account of a participant shall be forfeited as of the date the participant has ceased to be an employee. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,403 and \$4,274, respectively. Forfeitures are normally used first to reduce the Company profit sharing contributions and any excess is applied to the payment of the Plan's administrative expenses. During 2024 there were no forfeitures utilized to reduce plan administrative expenses. During 2023 there were \$8,260 of forfeitures utilized to reduce the Plan's administrative expenses.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan have been prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices of the registered investment companies are used to determine fair value.

The Plan invests in investment contracts through its guaranteed interest fund, which is fully benefit-responsive and is valued at contract value. Contract value represents contributions made, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

***Administrative Expenses***

Certain plan administrative expenses are paid by the Company. Such expenses include costs related to certain employees of the Company who perform administrative and trustee services for the Plan for which the Plan does not reimburse the Company. All loan, transaction and investment custodial fees are paid by the Plan. Investment custodial fees are included in the net appreciation in fair value of investments.

***Revenue Sharing***

The Plan recognizes the income from revenue-sharing agreements when received. During 2024 and 2023, the Plan received \$828,533 and \$669,131, respectively, of revenue-sharing income, all of which was used during 2024 and 2023 to pay plan expenses.

**Note 3. Information Certified by the Trustee and Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company, LLC, the trustee of the Plan, and New York Life Insurance Company, the custodian, qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024 and 2023
- Investments information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted market prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1).

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date.

**Note 5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 6. Party-in-Interest Transactions**

Certain plan investments are managed by John Hancock Trust Company, LLC, the trustee, as defined by the Plan; therefore, transactions with these parties qualify as party-in-interest transactions. Additionally, notes receivable are extended to participants in the Plan and, therefore, these transactions qualify as party-in-interest transactions. During 2024, expenses paid by the Plan for professional services amounted to \$781,860, net of revenue sharing of \$828,533. During 2023, expenses paid by the plan for professional services amounted to \$968,592, net of revenue sharing of \$669,131.

**Note 7. Tax Status of the Plan**

The Internal Revenue Service has determined and informed the Company by a letter dated March 13, 2023, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Investment Contract With Insurance Company**

The Plan invests in the New York Life Guaranteed Interest Account, which is considered a traditional guaranteed interest account. The account is credited with contributions and earnings on the underlying investments and charged for participants' withdrawals and administrative expenses.

The contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by New York Life Insurance Company, LLC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the Plan's ability to transact at contract value with New York Life Insurance Company. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event which would limit the Plan's ability to transact at contract value with plan participants is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.
