Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of BJB Partners, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Basis for Opinion

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the BJB Partners, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution plan with a 401(k) provision covering all employees, other than collectively bargained employees of the following related companies: BJB Properties, Inc., PR Asset Management, LLC, Drummond Advisors, LLC, BJB Evanston, LLC, PR Accounting, LLC, Timberwolf General Contracting, LLC, Lincoln Park Plaza, LLC, 4200 West Lake, LLC and BJB Florida, LLC (the “Company”). The Company is located within the Chicago metropolitan area. The Plan and the Trust of which it is a part are intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of the Company who have reached 21 years of age and have completed six months of service are eligible to participate in salary deferrals, matching contributions, and any discretionary qualified nonelective contributions and profit-sharing contributions of the Company on entrance dates consisting of the first day of each quarter.

Contributions

Each year, participants may contribute pre-tax and post-tax (Roth) compensation up to the lesser of the Federal Statutory limit or 100% of the participant’s annual compensation, subject to certain limitations, as defined in the Plan. The Plan was amended in 2019 to exclude certain bonuses in the definition of compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans (rollover). The Plan includes an auto-enrollment and auto-escalation provisions whereby all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect to not participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Each year, thereafter, the deferral rate increases by 1% for a maximum deferral of 6%, unless the participant declines the auto escalation provision.

The Company contributes to the Plan the following amounts: a fixed matching contribution equal to the total amount of the salary reduction that a participant elected to defer (not to exceed \$3,500), and may contribute a discretionary qualified nonelective contribution (QNEC) (to satisfy special nondiscrimination rules which apply to the plan), and a discretionary profit sharing contribution. A participant must complete six months of service to share in the matching contributions. A participant must complete 1,000 hours of service and be actively employed on the last day of the Plan year to share in the profit-sharing contributions. The Company did not make any profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

Participants' Investment Options

Participants must direct their salary or wage deferral contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and a maximum of 1) \$50,000 reduced by the excess, if any, of i) the highest outstanding note receivable balance over the prior 12-month period, over ii) the outstanding note receivable balance on the date the new note receivable is made or 2) 50% of their vested account balance, whichever is less. Participant notes receivable are secured by the vested balance in the in the participant's account and bear interest at a rate commensurate with the prime rate (as defined by the Wall Street Journal). Notes receivable repayments are deducted through after-tax payroll deductions over a period not to exceed five years, unless the note receivable is for the purchase a participant's principal residence in the which the case the repayment period may exceed five years.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's matching, profit-sharing and other discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years (must work 1,000 hours during each plan year to earn a year of vesting service) of credited service. Participants are also fully vested upon death, disability or retirement.

Payment of Benefits

Benefits are generally payable upon age 59.5, disability, death, retirement or termination of employment. Benefits equal to the participant's vested account balance may be paid to a participant or beneficiary by lump sum, partial withdrawals or rollover into a qualified plan, subject to regulatory requirements. Required minimum distributions are made to certain participants in the absence of other distribution elections. The Plan administrator may distribute separated participants' account balances that are less than \$1,000 in a lump sum without the participants' consent. The Plan administrator may transfer separated participants' account balances that are at least \$1,000 but less than \$5,000 into an individual retirement account without the participants' consent. In-service distributions of rollover contributions may be made at any time. In-service hardship distributions are permitted if certain criteria are met.

Forfeitures

Forfeitures by participants of unvested Company contributions are retained in the Plan and used to reduce future employer contributions. If additional forfeitures remain after reducing employer contributions, they may be used to offset administrative expenses. Unallocated forfeitures as of December 31, 2024 and 2023 were \$60,008 and \$16,110, respectively. The Company utilized \$9,232 and \$-0- for the years ended December 31, 2024 and 2023, respectively, to reduce employer contributions and offset administrative expenses. If a participant is rehired with five years, any forfeited balance will be reinstated. During 2024, \$1,228 of a participant's account assets were erroneously applied to the forfeiture account. During 2023, \$7,712 of a participant's account assets were erroneously applied to the forfeiture account. These amounts will be transferred back to the participant's account in 2025. Management is currently assessing the amount needed to cure this issue in 2025.

Current Legislation

The SECURE Act 2.0 was signed into law on December 23, 2022. The SECURE Act 2.0 allows more part-time workers to participate, increases the age for required minimum distributions and reduces the penalty for missed minimum distributions, permits plan participants to elect to receive vested employer contributions on an after-tax basis, and allows penalty free withdrawal for terminal illness, effective January 1, 2023. Additionally, it will allow for higher catch-up contributions, allow for matching contributions on student loan payments, permit plan sponsors to add an emergency savings account to their retirement plans, increase the availability of penalty-free withdrawals, and add automatic enrollment error relief provisions, effective January 1, 2024.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the Plan year.

Investment Valuation and Income Recognition (continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any material accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the plan, unless otherwise paid by the Company. The Company absorbs significant costs of Plan administration. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

Risk and Uncertainties

Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Recent Accounting Pronouncements

Presently, Plan Management is not aware of any recent accounting pronouncements from the Financial Standards Board that will have a material impact on the Plan's present or future financial statements.

Subsequent Event

The Plan has evaluated subsequent events through October 14, 2024, the date the financial statements were available to be issued, and no events have occurred through that date that would impact the financial statements.

NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4. INCOME TAX STATUS

Application for an Internal Revenue Service Determination Letter for the Plan has not been made by the Company. However, because the Plan is an adoption, albeit a standardized adoption, of a prototype plan that is the subject of a favorable Determination Letter dated June 30, 2020, the Plan Administrator believes that the Plan is qualified, and the related trust is exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5. INFORMATION CERTIFIED BY THE PLAN TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Ascensus, LLC, an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, the trustees of the Plan.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of Vanguard mutual funds as of December 31, 2024 and 2023. Vanguard, through Vanguard Retirement Plan Services, provides trust and administration services to the Plan. Vanguard Retirement Services has retained Ascensus as a subcontractor to provide these services. Ascensus acts as Trustee for those investments as defined by the Plan. In addition, Vanguard is considered a party-in-interest as defined by ERISA section 3(14)(B). These investments had total market values of \$8,245,608 and \$6,901,168 as of December 31, 2024 and 2023, respectively. Fees paid by the Plan for investment management services amounted to \$20,885 and \$2,065 as of December 31, 2024 and 2023, respectively. Transactions in such investments qualify as party-in-interest transactions which are allowable under Section 408(b)(8) of ERISA and the regulations promulgated thereunder.

NOTE 8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Differences between the financial statement presentation and the Form 5500, Schedule H can occur due to differences in accounting principles and timing differences on the recognition of assets. During the years ending December 31, 2024 and 2023, there were no differences between the financial statements presented and the Form 5500 examined.
