Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Philadelphia Macaroni Company 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the December 31, 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Philadelphia Macaroni Company 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Philadelphia Macaroni Company 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the December 31, 2024 financial statements, and reading the disclosures related to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements are as a whole are presented fairly, in all material respects, in accordance with the accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Auditors Report on the December 31, 2023 Financial Statements

Predecessor auditors performed an audit of the financial statements of Philadelphia Macaroni Company 401k Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated September 15, 2024 indicated that in their opinion (a) the amounts and disclosures in the December 31, 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material aspects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the December 31, 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Their report also indicated that the form and content of the December 31, 2023 supplemental schedule, other than the information in the December 31, 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the December 31, 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 Description of Plan

The following is brief description of the Philadelphia Macaroni Company 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan covering all full-time, non-union and union employees of Philadelphia Macaroni Company (the “Company”). The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s plan administrators.

In April, 2024, the Company was acquired by Winland Foods, Inc. The Plan was merged into the Winland Foods, Inc. 401(k) plan with an effective date of January 1, 2025 based on a Board Resolution of the acquiring company. Assets from the Plan were transferred out of the existing plan on December 31, 2024 (transfer date) and were deposited into the Winland Foods, Inc. 401(k) plan with an effective January 1, 2025. These financial statements for the year ending December 31, 2024 reflect the activity of the Plan for the entire year through the transfer date. Total transferred assets were \$31,429,989 and included participant loan receivables totaling \$700,455.

Eligibility Requirements

Employees were eligible to participate in the plan after they have completed six months of service and were age eighteen or older.

Contributions

Participants may elect to make contributions to the Plan not to exceed Internal Revenue Service limitations (\$23,000 for 2024 and \$22,500 for 2023). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions (up to \$7,500 for 2024 and \$7,500 for 2023). Participants may also rollover amounts representing distributions from other qualified defined benefit plans, defined contribution plans, and Roth elective deferral accounts. The Company may, at its sole discretion, make a discretionary contribution to the plan. During 2024 and 2023 the Company chose to contribute to the plan based on the following - 4% of non-union employees’ eligible compensation up to \$3,000 per calendar year and 1.5% of Local #56 of Greater New York employees’ eligible compensation up to \$3,000 per calendar year. Contributions are subject to certain IRS limitations. The total Company discretionary contribution was \$586,808 and \$633,532 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's elective and rollover contribution, an allocation of (a) the Company's contribution, (b) Plan earnings, (c) forfeitures of terminated participant's non-vested accounts, net of plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may change their self-directed investment options anytime.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions is based on years of continuous service. The vesting schedule for employer contributions and earnings allows for the participant to receive 50% vested interest after one year of service, with such vesting increasing by 25% per year thereafter. A participant is ordinarily 100% vested after three years of credited service.

Forfeited Accounts

Forfeited non-vested employer discretionary contributions resulting from a participants break in service, are used to offset administrative expenses of the Plan and/or the Company's contributions. Employee forfeitures totaled \$18,667 and \$17,394 for the years ended December 31, 2024 and 2023, respectively. Total forfeited non-vested funds used to reduce administrative expenses and employer contributions were \$18,667 and \$35,052 for the years ended December 31, 2024 and 2023, respectively

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, less any outstanding loans. Participants are allowed to have two outstanding loans at any time. All loans must be repaid over no more than a five year period unless it is for the purchase of a principal residence in which case the loan repayment period may not extend beyond 20 years from the date of the loan . The loan interest rate is computed using the prime rate (as specified in the Wall Street Journal) plus 1 percent. Principal and interest is paid ratably through weekly, bi-weekly, semi-monthly, monthly or quarterly payroll deductions. At December 30, 2024 prior to the loan transfer, interest rates ranged from 4.25% to 9.50%.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Additionally, participants who are still employed may make hardship withdrawals (after all loan options have been maximized) as defined by the IRS from their salary deferral account balance. Employees age 59 ½ may withdraw any portion of their vested account balance. Benefits are recorded when paid.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fully benefit responses investment contract, is reported at contract value. As a practical expedient, the fair value of the collective trust fund is estimated using the net asset value ("NAV") per share of the fund. See Note 4 for discussion of fair value measurement.

Purchases are recorded on a trade date basis, and sales of securities are recorded on the settlement date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The net returns from investment activity include realized and unrealized gains and losses from investment activity of the plan's assets. Unrealized gains and losses are calculated as the difference between the current value of investments as of the end of the Plan year and either the current value at the end of the preceding year or the actual cost if such investments were purchased during the current year. Realized gains or losses on sales of investments are calculated as the difference between sales proceeds and the current value of the investments at the beginning of the year or the actual cost of such investments were purchased during the year.

Employer and Employee Contribution Receivables

Employee contribution receivables are recorded when amounts have been withheld from employees prior to the end of the year but were not remitted to the plan until the subsequent year. Employer contribution receivable represents the Company's discretionary contribution for the plan year that was not paid until the subsequent year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There are no excess contribution payable as of December 31, 2024. The Plan distributed the 2023 excess contributions to the applicable participants on February 29, 2024.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 ERISA Section 103(a)(3)(c) Audit

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from Fidelity Management Trust Company (“Fidelity”) in which they certified that the statements furnished for the specified periods, pursuant to 29 CFR 2520.103-5 is complete and accurate reflection of Fidelity’s business records. The information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the supplemental schedule, including investments held at December 31, 2024, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the year ended December 31, 2024 was obtained or derived from information supplied from and certified by Fidelity, the custodian, in accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Note 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – the mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments measured at NAV – consist of collective trusts and are valued at the NAV of units of the collective investment trusts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Collective Trust Fund

The Invesco Stable Value Retirement Trust Fund (the “Fund”), is a collective trust fund managed by Invesco Trust Company and its investment sub-advisor, Invesco Advisors Inc. The Fund invests in a diversified portfolio of investment contracts (wrap contracts) with high quality banks and insurance companies. These contracts provide benefit-responsive liquidity and book-value accounting, meaning the Fund’s value remains stable for participants with a goal of higher returns than money market funds but less volatility than bond funds. The Fund’s primary goal is to protect the invested capital.

Events outside the normal operations of the Fund that cause a withdrawal from an investment contract may result in a negative market value adjustment, which can limit the ability to transact at contract value with the issuers of its investment contracts. Examples of such events include, but are not limited to, partial or complete legal termination of the Fund or a unit holder, tax disqualification of the Fund or a unit holder, and certain Fund amendments if issuers’ consents are not obtained. According to the Fund’s annual report, as of December 31, 2024, the occurrence of such an event is not considered to be probable.

Collective Trust Fund (continued)

Participants may redeem trust units on a daily basis for withdrawal or transfer of all or a portion of their investment at the assets underlying contract value (NAV) without restriction. The NAV per unit is computed by dividing the total fair value of the assets, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in each and included in the determination of unit values.

Note 5 Related Party and Parties-in-Interest Transactions

During the course of the year, the Plan entered into certain party-in-interest transactions with Fidelity Management Trust Company who serve as fund custodian. The Plan also has several service providers in which administrative fees (Note 2) are paid for services provided. As such, transactions in these investments and for services provided qualify as party-in-interest transactions that are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan for the investment management services and auditing services are included in administrative expenses.

In addition, notes receivable from participants, as disclosed in the statements of net assets available for benefits, qualify as party-in-interest transactions.

Note 6 Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although, the Plan has been amended since receiving the determination letter; however, the plan administrator and the Plan's tax counsel believe that the plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, believe that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audit; however, there are currently no audits for any tax periods in progress.

Note 7 Risk and Uncertainties

Investments are subject to market volatility, which could have a material effect on participant accounts. The Plan provides for various investment options. These investment options are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment options and the level of uncertainty related to changes in the value of investment options, it is reasonably possible that changes in risks in the near term could materially affect participant's accounts balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8 Excess Contributions Payable

As of December 31, 2024 and 2023, payables of \$0 and \$154, respectively, are recorded for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the Internal Revenue Service.
