INDEPENDENT AUDITORS' REPORT

Opinion

We have audited the financial statements of Laborers' and Operating Engineers' Utility Agreement Health and Welfare Trust Fund for Arizona, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and its benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTE A – DESCRIPTION OF FUND

The following description of the Laborers' and Operating Engineers' Utility Agreement Health and Welfare Trust Fund for Arizona (Fund) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Fund's provisions.

General – The Fund is a multiemployer defined benefit health and welfare plan that was established January 1, 1987, pursuant to a collective bargaining agreement (CBA) between the Northern Pipeline Construction Company and the Arizona District Council of Laborers, Local 383 and 479 (LiUNA) and the International Union of Operating Engineers, Local Union No. 428 (Operating Engineers). The collective bargaining agreement provides, among other things, for employers of participants to make contributions to the Fund for each hour worked by covered participants. The Fund provides benefits for eligible participants and their dependents and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration of the Fund is the responsibility of the Board of Trustees (the Trustees) and is governed by a joint board consisting of equal representation from the participating employers and LiUNA and Operating Engineers.

On February 16, 2018, the Trustees voted to terminate participation of non-LiUNA and non-Operating Engineers bargaining units, and to stop accepting contributions on behalf of those participants as of July 31, 2018, which would result in those participants being terminated no later than December 31, 2018. The Trustees approved to extend the reporting period for one month to allow for contributions through August 31, 2018 for the non-LiUNA and non-Operating Engineers participants.

By an agreement dated December 31, 2024, the Fund has agreed to be merged into the IPM Health & Welfare Trust of California (IPM Trust) effective on December 31, 2024, and all assets were transferred.

Eligibility – Under a plan of benefit coverage (Plan), participants become eligible for benefits the second month following the month in which the member meets the eligibility requirements (three consecutive months in which the participant worked at least 405 hours for which contributions have been paid). Once the eligibility requirements are met, certain eligible dependents are also covered under the Fund upon submission of the applicable enrollment form and supporting documents to the Fund Administrator.

Generally, a participant will remain eligible as long as actively employed with a participating employer. Participants may also continue to remain eligible for benefits through the use of accumulated eligibility credits (expressed in hours) for times of unemployment (less than full time) (up to a maximum of four months) and upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions – Under the terms of the CBA, participating employers make monthly contributions to the Fund based on hours worked by covered participants. Participant contributions are allowed to provide COBRA benefits.

Benefits – The Plan provides for health benefits (medical, vision, dental, and prescription drugs), life insurance, and accidental death and dismemberment benefits. Additionally, the Plan provides similar benefits during periods of unemployment (accumulated eligibility credits), or upon termination of employment through COBRA.

Insured Benefits – The Plan fully insures the life insurance benefits and accidental death and disability benefits and some of the dental benefits. The Plan purchases annual insurance contracts for these insured benefits. In addition, the Plan purchases stop loss insurance to actively manage catastrophic medical claims.

Self-insured benefits – All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Fund's third-party administrator. The claims processors pay claims directly to or on behalf of participants. The Fund uses a pharmacy benefit manager (PBM), which periodically makes refunds to the Fund based on the Fund's actual utilization pattern of specific drugs.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The accompanying financial statements have been prepared using the accrual basis of accounting.

The Fund maintains its financial records using the modified cash basis of accounting, under which additions and deductions to net assets available for benefits are recognized when measurable and available to finance expenditures of the current period. Expenditures are generally recorded when the liability is paid. Adjustments are prepared at each year-end to adjust the financial records to the accrual method of accounting.

Use of estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of benefits – Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claims payments are recorded when submitted to the Fund. Claims paid by the third-party administrator prior to year-end or claims payments submitted to the Fund that are not yet paid are recorded as an amount currently payable in the accompanying statements of benefit obligations. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

Refunds and rebates – Prescription refunds due from the Fund's PBM are recorded when earned. Refunds due at year-end are recorded as a receivable on the statements of net assets available for benefits, with the offset being netted against claims paid. Pharmacy rebates totaling \$283,051 and \$428,113 have been netted against claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Stop loss – Claims that were already paid from the Fund that exceeded the stop-loss coverage and are due to the Fund at year-end are recorded as a receivable. Premiums for stop-loss insurance are included in the premium payments in the accompanying statements of changes in net assets available for benefits. Stop loss refunds totaling \$0 have been netted against claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

Employers' contributions and related receivables – Employers' contributions receivable are reported based upon actual contributions received subsequent to December 31, for hours worked prior to December 31; therefore, there is no allowance for uncollectible receivables. No provision has been made for subsequent receipt of delinquent moneys covering hours worked during December or prior months, as the financial effect is expected to be immaterial. Employers' contributions are due by the 15th of the month following the month in which the hours were worked, amounts not paid by then are deemed to be delinquent.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Fund's gains and losses on investments bought and sold as well as held during the year.

Subsequent events – The Fund's management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

NOTE C – BENEFIT OBLIGATIONS

Estimated liability for future claims – The estimated liability for benefits reflects the estimated cost to provide benefits for eligible participants based upon contributions received through January of the subsequent year which are for hours worked prior to December 31. These amounts are included in claims payable, claims incurred but not reported in the statements of benefit obligations.

NOTE C – BENEFIT OBLIGATIONS – continued

Claims incurred but not reported – Benefit obligations include health claims currently payable, health claims incurred but not yet reported, and premiums payable. Claims approved for payment that are not paid by the Fund as of year-end are recorded as claims payable and included in claims payable, claims incurred but not reported on the statements of benefit obligations. Premiums not yet paid by the Fund related to coverage at or before year-end are included in premiums due to insurers in the statements of benefit obligations.

Claims incurred but not yet reported are estimated by the Fund's actuary in accordance with accepted actuarial principles based on claims data provided by the Fund Administrator. These amounts are paid by the Fund only if claims are submitted and approved for payment.

Accumulated eligibility credits – The Plan is required to provide benefits to certain members, if such members have accumulated credit amounts (expressed in dollars) in excess of that required for current coverage. Participants draw on their accumulated credits whenever they fail to meet the monthly requirement. The liability for accumulated future eligibility credits reflects the estimated cost to provide benefits for eligible participants who have accumulated eligibility hours for future month's coverage. In addition, future eligibility credits include the estimated liability for benefits based on delinquent contributions reported for hours worked prior to December 31 and which are included in employers' contributions receivable at December 31, 2024 and 2023.

No provision has been made in the accompanying financial statements for any liability which may arise as a result of the subsequent receipt of additional delinquent reports covering hours worked during December 31, 2024 and 2023, or prior months. The financial effects of such reports which are received are expected to be immaterial.

NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Cash and equivalents* – Valued at the closing price reported in the active market in which the individual security is traded.
- *Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Fund are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Fund are deemed to be actively traded.

Transfers between levels – The availability of observable market data is monitored to assess the appropriate classification of financial statements within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may required the transfer of financial instruments from one fair value level to another. The Fund evaluates the significant transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

NOTE E – CONTINGENCIES

Additional benefits coverage must, with certain limitations, be provided for each full 135 hours reported for each eligible participant. Ineligible participant hours are not included in the basis for computing the present liability of future benefits. With the addition of hours worked after December 31, however, these hours may become the basis for additional benefits. The attributable cost which would be due if all such hours subsequently become eligible is estimated to be \$-0- and \$89,200 at December 31, 2024 and 2023, respectively. Such contingency would become an actual liability only to the extent that such hours, together with additional hours included in delinquent reports, would qualify such participants for additional benefit coverage.

NOTE F – TAX STATUS

A determination letter from the Internal Revenue Service (IRS) dated March 13, 1992, exempts the Fund from Federal income taxes under the provisions of section 501(c)(9) of the Internal Revenue Code (IRC). The Fund has been amended since receiving the determination letter from the IRS. However, the Fund administrator (Trustees) and the Fund's counsel believe that the Fund is currently designed and being operated in compliance with the applicable requirements of the IRC. They believe that the Fund was qualified and the related trust was exempted from income taxes as of the financial statement date. No federal or state income taxes have been recorded in 2024 and 2023 for unrelated taxable income.

Accounting principles generally accepted in the United States of America require management to evaluate whether tax positions taken by the Fund and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G – PRIORITIES UPON TERMINATION

Although the board of trustees have not expressed any intent to discontinue the Fund, they may do so at any time subject to the provisions of ERISA and the terms of the CBA. In the event of termination of the Fund, the assets of the Fund would continue to be used to pay reasonable administrative expenses and to distribute and apply remaining surplus as the trustees so determine, until no assets remain.

As discussed in Note A, the Fund merged with IPM Health & Welfare Trust of California effective on December 31, 2024, and all assets were transferred.

NOTE H – PARTY IN INTEREST TRANSACTIONS

The Fund pays fees for several arrangements with service providers, including a third-party administrator, attorneys, actuaries, consultants, and auditors. These transactions are considered exempt party in interest transactions under ERISA.

NOTE I – RISKS AND UNCERTAINTIES

The Fund invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Cash consists of monies held in non-interest-bearing transaction accounts. The Fund places its cash with financial institutions deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000. At December 31, 2024 and 2023, the Fund's cash exceeded federally insured limits by approximately \$0 and \$351,000, respectively.

Contributions from two employers accounted for approximately 94% of total employer contributions collected for the years ended December 31, 2024 and 2023. In the event one or both of these employers were to suspend contributions, the Fund would terminate coverage to the employer's participants as set forth in the Plan document. The Fund would retain the risk of meeting current fixed administrative expenses until the appropriate adjustments were made.

The estimated liability for claims incurred but not reported is based on historical trend information which is subject to change. Due to uncertainties inherent in the estimation process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
