NOTES TO FINANCIAL STATEMENTS

Note 1.

Description of Plan

Effective January 1, 1987, Severson Environmental Services, Inc. (the "Company") started the Severson Environmental Services, Inc. 401(k) Profit Sharing Plan (the "Plan").

The Company has appointed State Street Bank and Trust Company (State Street) as Trustee of the Plan. All assets of the Plan are held and administered by State Street. The Plan has a group fixed annuity contract, guaranteed by Transamerica Financial Life Insurance Company which is presented on the Statements of Net Assets Available for Benefits as a guaranteed investment account. Transamerica Retirement Solutions is the third-party administrator of the Plan. The Plan has adopted the Transamerica Retirement Solutions Pre-Approved 401(k) Profit Sharing Plan.

Employees may enter the Plan, for purposes of salary deferrals and Roth contributions, on the first day of the month coinciding with or next following the completion of three months of service from their date of hire and attainment of age 18. For purposes of employer contributions, employees may enter the plan once they complete one year of service and have attained the age of 18. The entry date for an employer match is the first day of the calendar quarter nearest to the date that they have met the age and service requirements. The entry date for an employer profit-sharing contribution is the first day of plan year nearest to the date that they have met said requirements.

Employees who are leased employees or whose employment is governed by the terms of a collective bargaining agreement are not eligible to participate in the Plan. Employees participating in the Severson Prevailing Wage Pension Plan are eligible to participate in the Plan, but they are not eligible for employer contributions. The Plan allows other companies to adopt its provisions. Other companies who participate in the Plan are: Severson Industrial Services, Inc. and Severson Environmental Services of PA, Inc.

Note 2.

Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements have been prepared on an accrual basis and present net assets available for benefits and changes in those net assets of the Plan.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value (except for the fully benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by investment advisors and trustees, See Note 11 for further discussion of fair value measurements.

Purchases and sales of the investment funds are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 2. **Summary of Significant Accounting Policies** *(Continued)*

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balances plus any accrued interest. Interest income is recorded on an accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Estimates - The preparation of the financial statements in conformity with generally accepted accounting principles requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Benefits Paid - Benefits are recorded when paid (see Note 6).

Operating Expenses - Investment transactions and advisor fees are paid by the Plan. The Company pays all other operating expenses.

Note 3. **Group Fixed Annuity Contract**

The Plan has a group fixed annuity contract with Transamerica Financial Life Insurance Company (TFLIC). The contract date is July 28, 2022, and will remain in force until terminated by TFLIC or the Plan. The group fixed annuity contract is fully benefit-responsive and contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the group fixed annuity contract. The group fixed annuity contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawal, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Interest shall accrue on the contract balance at the initial rate of interest declared by TFLIC prior to the contract date until such time as a new rate of interest shall be declared by TFLIC. The initial declared rate shall be 3.25% per annum. The declared rate shall not be reduced for a period of at least six months, but the declared rate may be increased at any time. In the event of a reduction in the declared rate, TFLIC shall notify the plan of such reduced rate at least 45 days prior to the reset date. No prior notice shall be required for TFLIC to increase the declared rate. In no event may the declared rate be less than the minimum guaranteed interest rate, which is 0% per annum. The declared rate increased to 4.75% on January 1st, 2024. The rate remained the same throughout the plan year.

The contract has provisions that prevent the immediate and full payout of contract value due to plan sponsor-initiated events, including but not limited to, spin-off, layoff, sale or merger. These events will cause there to be a market value adjustment. The Plan believes that these events are not probable to occur, thus the fixed account has been valued at contract value.

Within 30 days of termination of the contract by the Plan, the Plan can elect the payout by six annual installments or lump sum with a market value adjustment in which TFLIC will pay the contract balance less a market adjustment in a single lump sum on the transfer date. In the event that TFLIC has elected to terminate the contract the payout will be by annualization or by installment in six annual installments.

Note 4. **Contributions**

Participants may elect to contribute up to 70% of earnings through pre-tax salary deferrals or after-tax Roth contributions up to the maximum annual limitation as provided by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participant elective contributions and rollover contributions are immediately 100% vested.

The Plan provides for a non-elective employer matching contribution equal to 50% of the salary deferral of each eligible participant who earns less than \$60,000. Only salary deferrals of up to 8% of compensation will be considered in applying this provision. The participant must be employed on the last day of the Plan year and have one year of service to be eligible.

Note 4. **Contributions** *(Continued)*

Further, the Plan allows additional discretionary employer profit sharing contributions and, to the extent necessary, employer contributions to provide the minimum top-heavy contribution. The participant must be employed on the last day of the Plan year and have one year of service to be eligible. The profit-sharing contribution is allocated to participants based upon eligible compensation. Eligible compensation for highly compensated employees will exclude overtime pay and bonus pay. Employer discretionary profit-sharing contributions and matching contributions vest ratably over six years.

Note 5. **Forfeitures and Unallocated Funds**

Forfeitures may be used by the Plan for several purposes such as the payment of Plan expenses. Forfeitures attributable to matching or discretionary profit-sharing contributions not used toward the payment of plan expenses will be used to reduce employer contributions. In 2024 the Plan had forfeitures of \$211,397 (\$16,433 - 2023). For the Plan years ending December 31, 2024 and 2023, unallocated forfeitures amounted to \$287,758 and \$116,484, respectively.

The Plan has unallocated advanced employer funds from time to time. There were unallocated advanced employer funds of \$99 at December 31, 2024 (\$94 - 2023).

Note 6. **Payment of Benefits**

Participants' benefits under the Plan are payable to participants, their beneficiaries, or their estates, upon the severance of employment, normal retirement, disability, death, or hardship. Participants with accounts greater than \$5,000 will automatically receive a lump sum payment unless another alternative form of payment is elected. Alternative forms of payment include a life annuity, joint and survivor annuity or monthly installment payments. Vested accounts of terminated or deceased participants that are \$1,000 or less can be paid by lump sum at any time without consent. Terminated participants with vested account balances between \$1,000 and \$5,000 that do not make a timely distribution or direct rollover election will have their account balance automatically rolled over to an IRA administered by Transamerica. Participants may withdraw the amounts in their rollover accounts at any time.

Note 7. **Notes Receivable from Participants**

The Plan provides for loans to participants which are repaid through payroll deductions. Loans (i) bear a reasonable rate of interest (currently 4.25% to 9.5%), (ii) are secured by the participant's account, (iii) are available to all participants on a reasonably equivalent basis, (iv) are limited to 50% of the participant's vested account balance, (v) provide for repayment over a period not to exceed five years unless such loan is used to purchase a primary residence and (vi) are limited to an amount not to exceed \$50,000.

A loan will not be issued for an amount less than \$1,000, and no loan will be issued to a participant with an existing loan outstanding.

Note 8. **Termination**

The employer shall have the right to terminate the Plan. Upon termination, all amounts credited to participants' accounts will become 100% vested. Participants' accounts will be distributed in a manner permitted by the Plan as soon as practical.

Note 9.

Tax Status

The Internal Revenue Service has determined and informed the Plan by a letter dated June 30, 2020, that the Transamerica Pre-Approved 401(k) Profit Sharing Plan qualifies under applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, the Plan qualifies as tax exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and the Department of Labor. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2022.

Note 11.

Fair Value Measurements

Financial Accounting Standard Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets.

Note 11. **Fair Value Measurements** (Continued)

- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash - The carrying amounts of cash and cash equivalents approximate fair value due to short-term maturity. Interest-bearing cash is classified as a Level 1 investment.

Registered investment companies - Valued at the net asset value NAV of shares held by the Plan at year-end. The NAV is the closing price reported on the active market on which the securities are traded. Registered Investment Companies are classified as Level 1 investments.

Common collective trust fund - Valued at the net asset value (NAV) of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Group fixed annuity contract - Valued at contract value. See Note 3.
