### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Rolling Plains Management 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Management, having determined it is permissible in the circumstances, has elected to have the audits of Rolling Plains Management 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Rolling

Plains Management 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Rolling Plains Management 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

## NOTES TO FINANCIAL STATEMENTS

### Note 1 - DESCRIPTION OF PLAN

The following description of the Rolling Plains Management 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

*General* - The Plan is a defined contribution plan covering all full-time employees, except excluded employees, who have completed 2 months of service and are age 18 or older. The Plan was established effective January 1, 2014, and contributions to the Plan began effective November 1, 2014. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions* - Employees may contribute up to the amount permitted by IRS regulations, which was \$23,000 in 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of an additional \$7,500 in 2024. There are two types of salary deferrals: Pre-tax 401(k) deferrals and after-tax, or Roth 401(k) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contribution into various investment options provided by the Plan.

The Corporation makes a safe-harbor matching contribution dollar for dollar of employee contributions up to 4% of employee compensation. The Corporation may also make a discretionary matching contribution. For the 2024 plan year, the Corporation made a discretionary match of dollar for dollar up to an additional 1% of salary, for a total employer contribution of up to 5% of salary. For 2024 and 2023, the Corporation made employer contributions totaling \$257,771 and \$239,825, respectively, to the Plan. All Corporation contributions are invested at the direction of the participant.

*Participant Accounts* - Each participant's account is credited with the participant's contributions, the Corporation's contributions, and allocations of Plan earnings and is charged with an allocation of operating expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting* - Participants are immediately vested in their voluntary contributions and the Corporation's contributions plus actual earnings thereon.

*Notes Receivable from Participants* - Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commercially reasonable. Principal and interest are paid ratably through payroll deductions.

*Payment of Benefits* - On termination of service due to death, disability, or retirement, vested account balances of \$5,000 or less will be distributed as a lump sum. For vested account balances exceeding \$5,000, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

### Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting* - The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, using the modified cash basis of accounting. Investment income is recognized when received, and disbursements are recognized when made. Additionally, securities investments are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in accordance with accounting principles generally accepted in the United States of America.

*Use of Estimates* - The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded when received. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Investment Valuation and Income Recognition* - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

*Payment of Benefits* - Benefit payments are recorded when paid.

*Operating Expenses* - Plan expenses may be made from the Plan's assets and will generally be allocated among the accounts of all participants in the Plan, either proportionately or as an equal dollar amount, depending on the nature of the expense.

*Subsequent Events* - Management has performed a review of subsequent events through October 10, 2024, the date the financial statements were available to be issued.

### Note 3 - TAX STATUS

The Plan has received a determination letter from the IRS dated November 30, 2020, stating that the Plan is in accordance with applicable sections of the Internal Revenue Code (IRC), and therefore, the related trust is exempt from taxation.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and disclose a tax liability (or asset) if the Plan has taken an uncertain

position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 4 - INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan management instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following information certified by Mid Atlantic Trust Company (MATC), the trustee of the Plan, as complete and accurate, except for comparing such information certified by the custodian with information included in the Plan's financial statements and supplemental schedules:

### Note 5 - FAIR VALUE MEASUREMENT

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

### Note 5 - FAIR VALUE MEASUREMENT (CONT'D.)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market funds:* Classified in Level 1 of the fair value hierarchy as fair value is based on quoted prices in active markets for identical securities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits – modified cash basis.

### Note 7 - RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by either Mutual of America or MATC. As defined by the Plan, Mutual of America is the third party administrator and MATC is the trustee. Therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$24,857 in contract administration fees in 2024.

### Note 8 - PLAN TERMINATION

Although it has not formally expressed any intent to do so, the Corporation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions. All benefits would then be distributed to participants or their beneficiaries at the time and in the manner prescribed by the Plan, ERISA, and the IRC.
