We have performed audits of the accompanying financial statements of Community Options, Inc. 403(b) Custodial Account Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### A. DESCRIPTION OF PLAN

The following brief description of the Community Options, Inc. 403(b) Custodial Account Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

#### **General**

The Plan is a defined contribution plan covering all employees of Community Options, Inc. (the "Company"). Employees are eligible to enroll into the Plan on their hire date and are eligible for matching contributions after one year of service. The Plan is subject to Section 403(b) of the Internal Revenue Code ("IRC") and to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Lincoln Financial Group Trust Company, Inc. (the "Custodian") is the custodian of the Plan. The Plan was amended and restated effective March 1, 2024 to allow for in-plan Roth conversions.

#### **Contributions**

Each year, participants may contribute pretax annual compensation up to the Section 402(g) limit, as defined in the Plan. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans, subject to employer limitations on an operational and nondiscriminatory basis. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a stable value fund as investment options for participants. The Company may contribute a discretionary amount as a matching contribution of up to 4% of employee salary. Highly compensated employees are not eligible for the employer match.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions. Vesting in the Company's discretionary contributions is based on years of continuous service. A participant is 100% vested in the Company's discretionary contributions after six years of continuous service.

#### **Notes Receivable from Participants**

From their fund accounts, participants may borrow a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Under the provisions of the CARES Act, which the Plan adopted during 2020, the maximum loan amount was increased to \$100,000 and the maximum number of outstanding loans was increased to two loans outstanding at one time. Effective July 1, 2022, the Plan's loan policy only permits one outstanding loan at a time and a maximum borrowing of \$50,000 or 50% of the participants account balance. The notes receivable are secured by the account balance in the participant's account. Each note receivable will bear a rate of interest and must be repaid within five years by equal payments at least quarterly, except for a note receivable to buy the participant's principal residence, which can be repaid over more than five years, but within a reasonable timeframe. Notes receivable as of December 31, 2024 and 2023, carried interest rates of 4.25%-9.50% and 3.25%-9.50%, respectively.

#### A. DESCRIPTION OF PLAN (CONTINUED)

##### Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account if the amount of vested interest is \$5,000 or less. If the amount of vested interest is greater than \$5,000, a participant may elect to receive his or her distribution in a lump sum or in monthly, quarterly, semi-annual or annual installments over a fixed period of time that does not exceed the life expectancy of the participant as determined by published life expectancy rate tables. The Plan includes a force-out provision for balances below \$1,000 for separated employees.

##### Forfeitures

Amounts forfeited by Plan participants are allocated to a forfeitures account. Forfeited amounts are used to pay Plan expenses or reduce employer contributions into the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$23,001 and \$23,186, respectively. During the year ended December 31, 2024, \$167,496 of forfeitures were used to pay Plan expenses.

##### Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses, such as brokerage fees, are borne by the participants. The Plan maintains an expense account to pay certain plan expenses. As of December 31, 2024 and 2023, there was \$163 and \$90, respectively, in the Plan expense account. During the year ended December 31, 2024, \$97,772 of Plan expenses were paid through the Plan expense account.

#### B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

##### Investments Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants

Notes receivable from participants are recorded as outstanding principal plus accrued interest. A participant will be considered to be in default with respect to a loan if any scheduled repayment with respect to such loan is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. Such loans are treated as deemed distributions for financial statement purposes.

##### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

##### Excess Contributions Payable

Amounts payable for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

##### Subsequent Events

Management has evaluated subsequent events for potential recognition and disclosure through October 13, 2025, the date the financial statements were available to be issued. No items were determined by management to require disclosure.

#### C. INFORMATION CERTIFIED AND PROVIDED BY THE CUSTODIAN

- Investment information and notes receivable from participants included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### D. INVESTMENT IN LINCOLN STABLE VALUE ACCOUNT

The Plan invests in the Lincoln Stable Value Account (the "Stable Value Account"). The Stable Value Account is a fully benefit-responsive fixed annuity contract that guarantees a fixed rate of interest. The credited interest rate may be based on an index rate specified in the contract or a declared rate, either of which may be changed quarterly and will never be below the guaranteed rate. The Stable Value Account is backed by the general account assets of the issuing company.

Contract value represents the amount participants would receive if they were to initiate a benefit-responsive transaction under the terms of the ongoing plan. Group fixed annuity contracts are between the Plan and the issuer and may not be assigned or sold to another party without the consent of the issuer.

#### E. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in less active markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value of shares held by the Plan at year end.

#### E. FAIR VALUE MEASUREMENTS (CONTINUED)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Changes in Fair Value Levels

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers into or out of Level 3.

#### F. TERMINATION OF THE PLAN

Although it has not expressed any intent to do so, the Company may terminate, amend, modify or suspend the Plan in whole or in part at any time. No such change is currently being contemplated; however, in any such event, the participants' right to their vested benefits is nonforfeitable.

#### G. TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71 or the draft *Listing of Required Modifications* issued April 4, 2009. The Plan is required to operate in conformity with the IRC to maintain tax-exempt status for Plan participants under Section 403(b).

The Plan has been amended since receiving the determination. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

#### **G. TAX STATUS (CONTINUED)**

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **H. CONCENTRATION OF RISK**

The Plan invests in various investment instruments. Investment securities in general are exposed to various risks, such as those involving interest rates, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **I. RELATED PARTY-IN-INTEREST TRANSACTIONS**

The Plan holds shares of a fund managed by the Custodian, therefore, transactions with the Custodian qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan paid the Custodian and its related entities \$182,915 in contract administrator fees.

Newport Capital Group, LLC is the Plan's investment advisor, therefore, transactions between Newport Capital Group, LLC and the Plan qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan paid Newport Capital Group, LLC \$97,772 in investment advisor fees.
