Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Servbank 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Effective July 1, 2024, in connection with the Plan Sponsor's organizational restructuring, the Plan's name was changed from Allied First Bancorp 401(k) Profit Sharing Plan to Servbank 401(k) Profit Sharing Plan.

General

The Plan is a defined contribution 401(k) plan covering all employees of Servbank, and any adopting employers, (the "Company") who have completed three months of service, as defined by the Plan, and have attained at least 18 years of age, except for union employees, nonresident aliens or leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute 100% of their eligible compensation as pre-tax and/or after-tax Roth deferral contributions, as defined by the Plan, up to the maximum amount allowable by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions. For 2024, the Company made a discretionary matching contribution equal to 100% of the participant's deferral contributions up to 4% of eligible compensation. In addition, the Company may make discretionary non-elective contributions to eligible participants who are employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year. For the year ended December 31, 2024, the Company made discretionary matching contributions of \$1,065,396 but did not make any discretionary non-elective contributions. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, if any, and allocations of (a) the Company's discretionary non-elective contributions, if any, (b) reallocations of forfeitures, if any, and (c) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and non-elective contribution portion of a participant's account is based on years of continuous service. Participants vest at a rate of 25% per year beginning with the second year of service and become fully vested after five years of service.

Note 1: Description of Plan (Continued)

Payment of Benefits

On termination of service due to death, disability, retirement, or any other reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, hardship distributions out of the participant's deferral contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2 from the participant's vested account balance and the withdrawal of rollover contributions at any time.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at the Wall Street Journal prime rate at the time the loan is granted. Interest rates on notes outstanding at December 31, 2024 ranged from 3.25% to 9.00%. Principal and interest are paid ratably through payroll deductions. Participants may have up to three loans outstanding at any time.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$105,886 and \$105,610, respectively. Forfeitures can be used to reduce future Company contributions, restore forfeited account balances of participants who are rehired, or to pay administrative expenses of the Plan in accordance with the Plan document. Forfeitures of \$65,812 and \$911 were used to reduce Company contributions and pay administrative expenses related to the Plan ended December 31, 2024, respectively. No forfeitures were used to restore forfeited account balances of participants.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine which optional provisions, if any, to elect in the future.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan invests in a group annuity contract with John Hancock Life Insurance Company. The contract provides for participants to choose to invest their contributions amongst several sub accounts of pooled separate accounts and a guaranteed interest account. Participants hold units of participation in the pooled separate accounts or the guaranteed interest account into which their contributions are invested.

The Plan's investments in pooled separate accounts under the group annuity contract are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of units of participation in the pooled separate accounts are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in the fair value of investments include the Plan's gains and losses on units of participation bought and sold as well as held during the year.

The Plan's investments in the guaranteed interest account under the group annuity contract are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Excess Contributions Payable

As of December 31, 2024, amounts payable to participants totaling \$6,436 for contributions in excess of amounts allowed by the IRS were recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025. There were no excess contributions for the year ended December 31, 2023.

Payment of Benefits

Benefits are recorded when paid.

Note 2: Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in investment income.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Units of pooled separate accounts: Valued at the unit value of the pooled separate account. The unit value, as provided by the issuer of the pooled separate accounts, is based on the net asset value (NAV) of the underlying investments of the pooled separate account and is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell for an amount different from the reported unit value.

Note 4: Guaranteed Interest Account Under Group Annuity Contract

The Plan's investment in the guaranteed interest account under the group annuity contract with John Hancock Life Insurance Company (John Hancock) is maintained in a general account of John Hancock. The account is credited with interest earnings and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed interest account is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is determined monthly at the discretion of the issuer.

Certain events may limit the ability of the Plan or its participants to transact at contract value with John Hancock including Plan termination and other events as specified in the group annuity contract. The Plan administrator does not believe that any events that would limit the Plan's or participants' ability to transact at contract value with the contract issuer are probable of occurring.

Note 5: Information Prepared and Certified by Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and total investment income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock Life Insurance Company, the Custodian of the Plan.

Note 6: Related-Party Transactions and Party-in-Interest Transactions

The investment assets of the Plan are held under a group annuity contract with John Hancock Life Insurance Company, the Custodian of the Plan, and, therefore, transactions with respect to these assets qualify as party-in-interest transactions. Fees incurred and paid by the Plan for investment management and administrative services were \$231,527 for the year ended December 31, 2024. These transactions also qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary matching and profit sharing contributions.

Note 8: Tax Status

The Company adopted a nonstandard pre-approved prototype plan sponsored by Administrative Retirement Services, Inc. The IRS has determined and informed the Company by letter dated June 30, 2020, that the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. In addition, the Company has identified and intends to correct certain operational errors related to Company contributions. The estimate for corrections related to these errors is \$28,553 and has been recorded as an other receivable on the statements of net assets available for benefits. No provision for income taxes has been included in the Plan's financial statements related to these operational errors as the Plan administrator believes the Plan continues to be qualified and the tax status of the related trust continues to be exempt. Subsequent to year end, on June 18, 2025, the Company remitted \$28,553 to the Plan to correct the operation errors.

Note 9: Risks and Uncertainties

The Plan invests in a group annuity contract with John Hancock Life Insurance Company. The underlying investment securities of the pooled separate accounts and guaranteed interest accounts under the group annuity contract are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
