## INDEPENDENT AUDITORS' REPORT

To the Retirement Committee  
Southeastern Kentucky Rehabilitation Industries, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Southeastern Kentucky Rehabilitation Industries, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. Description of Plan**

The following brief description of the Southeastern Kentucky Rehabilitation Industries, Inc. (the "Company") 401(k) Plan (the "Plan"), is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

**General**

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). The Plan is administered by a trust, the trustee of which is Empower Trust Company, LLC. The Board of Trustees is responsible for oversight of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

**Eligibility**

The Plan covers substantially all employees of the Company. The employees are eligible to join the Plan on any entry date on or following the date of one year of service and age twenty-one. The Plan's entry dates are January 1 and July 1.

**Contributions**

Each year, participants may contribute up to 100% of their pretax annual eligible compensation, as defined in the plan agreement, as a before-tax salary deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Effective August 1, 2012, participants may also elect to defer a portion of their after-tax compensation as Roth contributions. The Company makes an annual safe harbor matching contribution for all participants equal to 100% of the first 3% of compensation contributed by the participant, plus 50% of the next 2% of compensation contributed by the participant. Contributions from the participant and the Company for the Plan year cannot exceed the maximum limit determined by Internal Revenue Service regulations.

**Investment Options**

Participants may, upon enrollment in the Plan, elect to invest their contributions and any Company contributions in any or all of the various funds currently offered by the Plan. Participants may also elect to use Empower Advisory Group, LLC to manage their investments, rather than selecting individual funds.

**Participant Accounts**

Participant contributions are credited to the individual accounts. Each participant's account is also credited with Company contributions and allocations of the Plan's earnings or losses. Participant accounts are charged with an allocation of administrative and investment fees that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document.

**1. Description of Plan, continued**

**Benefits and Vesting**

The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested accounts, which includes participant and Company contributions and related earnings thereon. Earnings are allocated based on the individual participant's account balance in relation to total participant account balances. Participants are vested immediately in their contributions and employer safe harbor contributions as well as earnings on those contributions. Vesting in the Company discretionary matching contribution portion of their accounts and earnings on these contributions is 25% after two years of service and vest 25% each additional year of service up to 100% after five years. The nonvested portion of a participant's employer matching account is forfeited upon the distribution of the vested portion of the participant's account.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, or termination of employment, each participant may elect a distribution in the form of a lump sum payment equal to the value of his or her account. Amounts up to \$5,000 will be cashed out if no distribution elections are made. The Plan specifically restricts the timing and method of benefit payments based upon the participant's age, length of service, account value and reason for termination. In the event of financial hardship, the Company may allow a participant to withdraw from his or her account. The amount may not exceed the amount contributed by the participant, or the participant contribution account balance, if less.

**Forfeited Accounts**

Unallocated forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$2,876 and \$2,702, respectively. The amount forfeited was \$135 for December 31, 2024 and 2023 respectively. Forfeitures will be allocated as an additional discretionary matching contribution. The unallocated amount at December 31, 2024 will be reallocated to participants in 2024. No forfeitures were used during 2024 and 2023.

**Plan Expense Account**

A plan expense account is maintained to hold funds available to pay qualified Plan administrative expenses. At December 31, 2024 and 2023, the plan expense account balance was \$22,266 and \$22,083, respectively. For the years ended December 31, 2024, and 2023, the Plan paid no qualified administrative expenses out of the plan expense account.

**2. Summary of Significant Accounting Policies**

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results may differ from these estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for a discussion of fair value measurements.

The net appreciation (depreciation) in fair value for each investment option was determined based on quoted market prices and is included in investment income in the statement of changes in net assets available for benefits. The net appreciation (depreciation) in fair value of investments includes both realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of specific participant transactions, investment advisory and other recordkeeping fees are charged directly to the participant's account and are included in administrative expenses. Fees related to the use of Empower Advisory Group, LLC managed service are also included in the administrative expenses.

**Management's Review of Subsequent Events**

The Plan has evaluated and considered the need to recognize or disclose subsequent events through August 12, 2025 which represents the date that these financial statements were available to be issued. Subsequent events past this date, as they pertain to the year ended December 31, 2024 have not been evaluated by the Plan.

**3. Investments**

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$696,727 as follows:

**4. Fair Value Measurements**

FASB ASC 820-10 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

All assets have been valued using a market approach. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual Funds*

The fair values of mutual funds are valued at quoted market prices, which represents the net asset value of shares held at year end. The mutual funds are deemed to be actively traded.

**5. Guaranteed Investment Contract with Empower Annuity Insurance Company**

The Plan entered into a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company with a contract value of \$1,235,361 and \$915,028 at December 31, 2024 and 2023, respectively. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The actual average yield earned by the guaranteed investment contract was 1.0% and 1.0% for 2024 and 2023, respectively.

This contract meets the fully-benefit responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by the investment Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**5. Guaranteed Investment Contract with Empower Annuity Insurance Company, continued**

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and guaranteed for an agreed period, usually one year. At the end of the period, the issuer determines a new rate which is credited directly to participant's accounts.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Upon occurrence of any of these events, a market value adjustment may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would also limit the ability of the Plan to transact at contract value with the participants. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**6. Transactions with Parties-In-Interest**

The Plan holds a guaranteed portfolio account through Empower Annuity Insurance Company. Empower Annuity Insurance Company is the insurance company of the Plan, and, therefore, these transactions qualify as party in interest transactions.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan.

The Plan pays certain investment advisory, Plan recordkeeping and investment management fees to Empower Advisory Group, LLC, Empower Annuity Insurance Company and Morgan Stanley, which are parties-in-interest to the Plan.

**7. Information Prepared and Certified by Insurance Company and Trustee**

Investments on the statement of net assets available for benefits and the schedule of assets (held at end of year) and investment income and related activity reported on the statement of changes in net assets available for benefits has been derived from information prepared and certified as complete and accurate by the insurance company and trustee of the Plan, in accordance with Section 2520.103-5 of the Department of Labor rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

**8. Tax Status**

The Plan is a prototype plan offered by Empower Trust Company, LLC (formerly Great-West Trust Company, LLC). The prototype plan obtained its latest opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**8. Tax Status, continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes is it no longer subject to income tax examinations for years prior to 2021.

**9. Risks and Uncertainties**

The Plan provides for participant directed investment options and non-participant directed investment options in any combination of twenty-six funds. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of the investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

**10. Priorities upon Plan Termination**

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the rights of all affected participants to amounts contributed by them and the sponsor and related earnings thereon would become fully vested.

**11. Non-participant Directed Investments**

Certain participants have elected to participate in investment management services provided by Empower Advisory Group, LLC. Empower Advisory Group, LLC directs the participants investments on behalf of the participants for a fee. Information about the net assets and the significant components of the changes in net assets relating to the nonparticipant-directed investments are as follows:
