INDEPENDENT AUDITORS' REPORT

To the Board of Trustees of
Painters and Allied Trades Local 1959 Retirement Plan

Opinion

We have audited the accompanying financial statements of Painters and Allied Trades Local 1959 Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Painters and Allied Trades Local 1959 Retirement Plan as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Painters and Allied Trades Local 1959 Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Prior Period Financial Statements

The financial statements of Painters and Allied Trades Local 1959 Retirement Plan as of December 31, 2023, were audited by other auditors whose report dated October 7, 2024, expressed an unmodified opinion on those statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Painters and Allied Trades Local 1959 Retirement Plan ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A – DESCRIPTION OF PLAN

The following description of the Painters and Allied Trades Local 1959 Retirement Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement and Summary Plan Description for a more complete description of the Plan's provisions.

General – The Plan is a multiemployer defined contribution plan that was established effective March 1, 1992, pursuant to a collective bargaining agreement (CBA) between the Alaska Chapter (for the employers) and the International Union of Painters and Allied Trades (AFL-CIO), Local No. 1959 (Union) (for the employees). The Plan covers all members and employees of the Union employed under the terms of the collective bargaining agreement and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration of the Plan is the responsibility of the Board of Trustees (Trustees) and is governed by a joint board consisting of equal representation from the participating employers and the Union.

Contributions – Under the terms of the collective bargaining agreement or special agreements, participating employers shall contribute monthly contributions to the Plan based on hours worked by covered participants.

Participant accounts – Each participant's account is credited with employer contributions and an allocation of plan earnings, net of expenses. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

All investments, other than administrative funds held in the common collective trust fund are participant directed.

Vesting – Participants who became eligible prior to December 31, 2016, are 100% vested in their accounts at all time. Participants who join the Plan on or after January 1, 2017, and work a combined total of 1,000 or more hours, in two consecutive plan years, become fully vested. Forfeiture will occur to non-vested account balances following five consecutive breaks in service.

Payment of benefits – The Plan's normal retirement age is 59 ½. At that age the retired participant will be entitled to 100% of their account balance. The participant may elect to receive his or her account balance in one of the following payment options:

- a joint and survivor annuity;
- a single lump sum payment in cash;
- purchase of a different form of annuity;
- installments over a period of not more than assumed life expectancy determined at time of distribution.

If the participant's vested benefit is \$5,000 or less, it shall be paid in a single lump sum, and the other optional forms of payment shall not be available. A married participant with a vested balance greater than \$5,000 must provide written consent from their spouse prior to distribution.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan.

Basis of accounting – The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities; and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employers' contributions and related receivables – Employers' contributions receivable is based upon actual contributions received subsequent to December 31, for hours worked prior to December 31 therefore there is no allowance for uncollectible receivables. Those receivables typically are collected within 20 days. No provision has been made for subsequent receipt of additional delinquent monies covering hours worked during December or prior months, as the financial effect is expected to be immaterial.

Payment of benefits – Benefit payments to participants are recorded upon distribution.

Administrative expenses – Expenses of administering the Plan and those which are directly related to investment transactions are paid out of the assets of the Plan.

Subsequent events – Plan management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

NOTE C – PRIORITIES UPON PLAN TERMINATION

The Board of Trustees intends that the Plan continue indefinitely. However, in the event of termination of the Plan, the assets remaining in the Plan, after providing for administrative expenses, shall be allocated among the participants in accordance with the Plan provisions, except that all individual accounts shall, to the extent funded, become non-forfeitable. No part of the assets will be returned to any employer.

NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other meansIf the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common collective trust* – Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the Plan less its share of liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

Transfers between levels – The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. The Plan evaluates the significance of transfers between levels based on the nature of the financial instrument and size of transfer relative to total net assets available for benefits.

(a) *Morley Stable Value Fund* is a common collective fund offered by the Principal Global Investors Trust Company. The objective of the fund is to provide preservation capital, relatively stable returns consistent with its comparatively low risk profile and liquidity for benefit responsive plan or participant payments. Redemption frequency related to participant transactions (purchases and sales) may occur daily with no advance notice required. Redemption frequency related to full redemption for reasons other than benefit payments or transfers shall be made as soon as practical upon receiving advance written notice but it requires a twelve month advance written notice.

NOTE E – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE F – TAX STATUS

The Plan obtained its latest determination letter on September 9, 2015, in which the Internal Revenue Service (IRS) states that the Plan has received a favorable determination based on the amendments provided and was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE F – TAX STATUS - continued

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan pays fees for several arrangements with service providers, including a third-party administrator, attorneys, actuaries, consultants, and auditors. These transactions are considered exempt party in interest transactions under ERISA.
