### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**NOTE A - DESCRIPTION OF PLAN:**

The following description of the Sovereign Distributors Inc., T/A Avalon Flooring 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, adopted by Sovereign Distributors Inc., is a defined contribution plan covering substantially all employees. Employees are eligible to participate as follows:

- For employee deferral contributions, employee rollover contributions, qualified employer non-elective contributions and employer matching contributions, there is no employee age or service requirement- employees are eligible to participate at their hiring date.
- For employer non-elective contributions there is no employee service requirement, however employees must have attained age 21.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and cash equivalents as investment options for participants.

The Plan contains an automatic enrollment feature. If employees have not provided a deferral election form, 5% of their compensation is deferred.

The Employer may make discretionary matching contributions based on eligible compensation deferred by employee into the Plan. For the year ended December 31, 2024, employer discretionary matching contributions were \$0-.

The Company, at its discretion, may also make qualified non-elective contributions or non-elective contributions to the Plan. For the year ended December 31, 2024, there were no qualified non-elective contributions or non-elective contributions made by the Company.

Contributions are also subject to certain limitations as indicated in the Plan document. For the years ended December 31, 2024 and 2023, there were excess contributions in the amount of \$0-, and \$0-, respectively, which are shown on the statements of net assets available for benefits as excess contributions payable. These excess contribution amounts at December 31, 2024 and 2023 include earnings/(losses) of \$-0- and \$-0-, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution, and an allocation of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their contributions plus earnings thereon. Participants are also 100% vested in qualified employer non-elective contributions. Employer matching contributions and employer non-elective contributions and earnings thereon are subjected to the vesting schedule indicated in the Plan document.

A participant is also fully vested in the full value of their account if a participant attains normal retirement age, as defined in the Plan, or becomes permanently and totally disabled. Notwithstanding such events, a participant becomes fully vested in employer profit sharing contributions after six years of service.

Participant Loans

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. Notes bear interest at rates commensurate with local prevailing rates as determined quarterly by the Plan administrator. At December 31, 2024, the interest rate ranged from 4.25% to 9.50%. Principal and interest is paid ratably through biweekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum equal to the value of the participant's vested interest in his or her account. The form of payment for such distributions may be made as a rollover to an IRA or to another qualified plan, or can be paid directly to participants subject to Federal withholding requirements, or by a combination of the aforementioned methods. Participants who have attained age 59½ can receive in-service distribution of all or any portion of their vested account balances. In-service hardship withdrawals are also permitted from participant's deferral account only, subject to a \$500 minimum.

Forfeited Accounts

Any forfeitures occurring during a Plan year shall be applied to reduce the contributions of the employer. If so directed by the employer, forfeitures shall first be used to pay administrative expenses under the Plan. For the year ended December 31, 2024, \$15,824 of forfeitures were applied to administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,671 and \$890, respectively.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

Date of Management's Review of Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. The Plan accrues interest at prevailing rates on participant loans from the time funds are borrowed until the account is fully paid. The amount of participant loans past due more than 90 days, based on contractual terms, and still accruing interest is \$-0- and \$-0- at December 31, 2024 and 2023, respectively.

Notes receivable from participants are stated at the amount the Plan expects to collect from outstanding balances. The Plan provides for probable uncollectible amounts through a valuation allowance and a charge to benefits paid based on its assessment of the current status of individual accounts and the terms of the Plan document. Balances that are still outstanding after use of reasonable collection efforts are written off against the valuation allowance. At December 31, 2024 and 2023, all participant loans are fully collateralized by participant's remaining account balance and no allowance for probable uncollectible amounts is deemed necessary.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note C for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. Benefit payment checks which remain outstanding after requisite procedures to contact the recipient, are shown on the statements of net assets available for benefits as benefits payable to participants.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. The Company and participants pay the Plan's administrative expenses.

**NOTE C - FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Issuances and redemptions (any time upon 10 business days' notice) of participant units are made on each business day ("valuation date"). Units of the Fund are valued each day on which the New York Stock Exchange ("NYSE") is open for trading in accordance with the valuation procedures established by the Trustee. The NAV per unit is calculated as of the close of trading on the NYSE (generally, 4:00 p.m. U.S. Eastern time). The GG Metlife Stable Value Fund files as a direct-filing entity (DFE). The fund has no unfunded commitments.

Investment contracts are valued at contract value principally because unitholders are able to transact at contract value when initiating benefit-responsive withdrawals, taking loans or making investment option transfers permitted by the participating plan. A benefit-responsive withdrawal includes a payment to a unitholder arising from retirement, termination of employment, disability or death. In the normal course, unitholder events are predictable (for unitholders as a group) such that the economic integrity of investment contracts is largely unaffected by unitholder withdrawals.

Employer initiated events, if material, may affect the underlying economics of investment contracts. These events include plant closings, layoffs, plan termination, bankruptcy or reorganization, merger, early retirement, incentive programs, tax disqualification of a trust or other events. The occurrence of one or more employer initiated events could limit the Trust's ability to transact at contract value with plan unitholders.

For example, retirement benefit payments which occur because an employer has offered a subsidized early retirement program will not transact at contract value unless the scope of the program is not material or the investment contract includes a “contract value corridor.” Whether an employer initiated event is probable is foremost within the knowledge of the employer, but in the normal course may be communicated to the investment manager of the Trust. While the investment manager may take action to minimize or eliminate the impact of the employer initiated event, there is no assurance that the issuer will continue to transact at contract value once the corridor is used. In that case, the Trust would be unable to maintain the ability to transact at contract value. As of December 31, 2024, the Trust’s management believes the occurrence of an event that would limit the ability of the Trust to transact at contract value with the unitholders in the Trust is not probable.

The fund invests in wrapper contracts (also known as synthetic guaranteed investment contracts). There could be events that would permit a wrapper contract issuer to terminate a wrapper contract upon short notice due to the plan’s loss of its qualified status, material breaches of responsibilities that are not cured, or material and adverse changes to the provisions of the plan. If one of these events was to occur, the wrapper contract issuer could terminate the wrapper contract at the market value of the underlying investments (or in the case of a traditional guaranteed investment contract, at the hypothetical market value based upon a contractual formula).

A participating trust is required to give the Trustee 12 months’ irrevocable written notice of intent to redeem all or a portion of its participation in the Trust.

**NOTE D - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:**

The following transactions are considered to be related party transactions and party-in-interest transactions that are exempt from the ERISA prohibited transaction rules.

Certain Plan investments are shares in mutual funds managed by Fidelity Investments. Fidelity Investments is the trustee as defined in the Plan and therefore, these transactions qualify as party-in-interest transactions.

**NOTE E - PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE F - TAX STATUS:**

The Internal Revenue Service has determined and informed the Plan sponsor by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code

(IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**NOTE G - RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
