We have performed audits of the financial statements of Central Plumbing & Heating, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Central Plumbing & Heating, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering certain employees designated by Central Plumbing & Heating, Inc. (the "Sponsor" or "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility

All employees are eligible to participate in the Plan upon obtaining employment with the Company. To qualify for profit sharing contributions the employee must be at least 19 years of age, have completed 1,000 hours and twelve consecutive months of service as well as be employed by the Company on the last day of the plan year. There are no eligibility requirements for the Sponsor's prevailing wage contributions, if the employee performs work on prevailing wage contracts.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make prevailing wage and discretionary profit sharing contributions to the Plan.

The Sponsor suspended the safe-harbor employer matching contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. During the year ended December 31, 2024, the Company made prevailing wage contributions and discretionary profit sharing contributions of \$522,978 and \$1,028,371, respectively.

Investment Options

Participants direct how their and the Sponsor's contributions are invested among several options that cover a wide range of fund objectives, risks and returns. All investments are participant directed.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Plan prevailing wage contributions, and allocations of (a) the Plan's discretionary profit sharing contribution and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans to participants are treated as a separate investment of the participant and all principal and interest payments on loan balances are credited to the participant account from which the loan was made. The loans are secured by the vested balance in the participant's account and bear interest at a fixed rate determined by the plan administrator based on prevailing market conditions. Interest rates on existing loans range from 4.25% to 9.50%. Participants may only have one loan outstanding at any particular time. Principal and interest is paid ratably through weekly payroll deductions.

Vesting

Participants are vested immediately in their contributions plus actual earnings (losses) thereon as well as prevailing wage contributions from the Sponsor. Vesting in the Sponsor's profit sharing contribution portion of a participant's account is based on the number of years of service.

Sponsor contributions vest according to the following schedule:

1 year	25%
2 years	50%
3 years	75%
4 years or more	100%

Upon a participant's death, total disability, or attainment of normal retirement age of 65, a participant's accrued benefit is 100% vested.

Forfeitures

Employees who terminate employment before they are 100% vested, forfeit all or a portion of their Sponsor contributions depending on their years of service. Unallocated forfeitures totaled \$16,586 and \$10,876 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, Company contributions were not reduced from forfeited nonvested accounts.

Note 1: Description of Plan (Continued)

Payment of Benefits

On termination of service due to death, disability or retirement, a participant or beneficiary may receive a lump-sum amount equal to the value of their vested interest in their account. A participant who is required to receive lifetime required minimum distributions may receive installments payable in monthly, quarterly, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or defer the distribution to retirement if the account balance is greater than \$7,000. The Plan provides for normal retirement benefits upon reaching age 62. Participants may also take in-service distributions if they experience a qualifying financial hardship.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract ("FBRICs")). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the contract.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded or deemed necessary.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan through an allocation to participant accounts. Per-use fees are charged directly to the participant accounts. The Sponsor pays certain professional fees and other plan expenses, which are excluded from the accompanying financial statements. Investment related expenses are allocated proportionately to plan participants based on their respective account balances and are included in investment income/loss. During the year ended December 31, 2024, \$107,092 of operating expense were paid by the Plan and included in administrative expenses.

The Secure 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Mutual funds held in pooled separate accounts: Fair value is estimated using NAV per unit by the issuer of the pooled separate accounts. The NAV is used as a practical expedient to estimate fair value. Fair value is based on the fair value of underlying investments held by the pooled separate accounts.

Common/collective trust funds: Valued at NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. These funds are stable funds and their NAVs are based on the underlying investments held by the fund less its liabilities. Note 5: Fully Benefit-Responsive Investment Contract (FBRIC)

The Plan has a guaranteed investment contract (GIC) which provides a guarantee of principal and interest by the general account assets of Empower Annuity Insurance Company of America ("Empower"). Contract value represents contributions made under the contracts, plus earnings (losses), less withdrawals and administrative expenses. Subject to plan or IRC limitations, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of Empower or otherwise. The contract value as of December 31, 2024 and 2023 was \$754,434 and \$787,544.

Certain events limit the Plan's ability to transact at contract value with Empower including Plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit Empower to terminate the agreement prior to the scheduled maturity date.

The average yield earned by the Plan and the average interest rate credited to the participants' accounts for the year ended December 31, 2024 was 1.41%.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 7: Tax Status

The Company adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Party-in-Interest Transactions

Certain plan services are provided by JCCS, PC. JCCS, PC is a service provider, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for the services provided during the plan year ended December 31, 2024, were offset against earnings.

Certain plan services are provided by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Empower Annuity Insurance Company of America and Empower Trust Company, LLC are service providers, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for the services provided during the plan year ended December 31, 2024 was \$107,092.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
