We have performed audits of the accompanying financial statements of Virginia Mirror and Associated Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### Note 1 – Plan Description

---

The following description of the Virginia Mirror and Associated Companies 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of Virginia Glass & Mirror Intermediary, LLC, (the “Company” or “Plan Sponsor”) who have one month of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Administration*

The Company is the Plan Administrator. All assets of the Plan are held by the Plan’s Trustee, Ascensus Trust Company.

#### *Participant Contributions*

Participants may contribute up to 100% of their eligible compensation on a pretax or after-tax basis as defined by the Plan, subject to certain limitations. The statutory maximum amount of contributions allowed was \$23,000 for the year ended December 31, 2024. Participants may also contribute (rollover) amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan includes an automatic enrollment provision which stipulates that eligible Plan participants are deemed to have made a 3% pretax salary deferral election in the event the participant fails to make a salary deferral election and does not affirmatively elect out of participating in the Plan. The Plan also includes an automatic escalation provision which stipulates each participant’s salary deferral percentage will automatically increase annually on March 1 by 1%, up to a maximum contribution percentage of 6%, unless a participant elects a different contribution percentage.

#### *Catch up Contributions*

For the year ended December 31, 2024, if a participant is eligible to make deferrals and reaches age 50 before the end of the calendar year, the participant could defer an additional \$7,500 into the Plan subject to certain *Internal Revenue Code (IRC)* limitations. Effective January 1, 2025, participants aged 60 to 63 are permitted higher catch-up limits in accordance with Secure 2.0.

#### *Company Matching Contributions*

The Plan provides for a discretionary matching provision. The Company contributed an amount equal to 50% of the first 6% of each participant’s compensation contributed for 2024. The Company may also make a discretionary profit-sharing contribution in an amount determined annually by the Company. There was no discretionary profit-sharing contribution made during 2024.

### *Participant Accounts*

Each participant's account is credited with the participant's contributions, Company contributions, and an allocation of Plan earnings. Participant's accounts are charged with participant's distributions and an allocation of Plan expenses. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Eligible compensation is defined as wages subject to federal income tax. For the employee's first year of participation, compensation is recognized as of the first date the participant entered the Plan. Compensation was subject to a limitation of \$345,000 for 2024, as prescribed by the Internal Revenue Service (IRS) regulations.

### *Investment Options*

A participant may direct the investment of their account into any one or combination of investment fund options. Participants may change their investment elections at any time. Transfers of account balances between elected investment options may also be made at any time.

### *Notes Receivable from Participants*

The Plan does not permit participant loans.

### *Vesting*

A participant normally becomes eligible for benefits after reaching age 65 or meeting the vesting requirements. A participant who becomes permanently disabled, dies, or reaches the normal retirement date while in the employment of the Company will have a 100% vested interest in his or her account.

Each participant is immediately 100% vested in his or her salary reductions and rollover contributions, and, in accordance with the vesting provisions of the Plan, the Company matching and discretionary profit-sharing contributions after completion of three years of service.

### *Benefit Payments*

Distributions can be made due to retirement, death, disability, or termination of employment and are subject to the applicable provisions of the Plan agreement. Up to 100% of the participant's account balance can be paid in a lump-sum, direct rollover to another qualified plan, or installments to the participant or their beneficiaries. A participant may withdraw funds while still employed if he or she has attained age 59½.

### *Hardship Withdrawals*

The Plan allows, in certain hardship situations as defined in the Plan, participants to withdraw from their account balances while actively employed. These hardship withdrawals are subject to *IRC* restrictions and penalties. The Plan's provisions for hardship withdrawals comply with the Bipartisan Budget Act of 2018.

### *Forfeitures*

Plan forfeitures may first be used to pay Plan expenses, and then used to offset the Plan Sponsor contribution obligation. During the year ended December 31, 2024, the Plan used \$19,373 of terminated non-vested account balance forfeitures to pay Plan expenses. During the year ended December 31, 2024, the Company used \$1,248 of terminated non-vested account balance forfeitures to offset the Plan Sponsor contribution obligation. As of December 31, 2024 and 2023, there was \$16,288 and \$14,990, respectively, of unallocated forfeited Plan Sponsor contributions available to be used to reduce future Plan expenses or Plan Sponsor contributions.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments

### *Excess Participant Contributions*

In order to pass compliance testing for the year ended December 31, 2023, excess participant contributions totaling \$22,811 were refunded in the current year.

## **Note 2 – Summary of Significant Accounting Policies**

---

### *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan's Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### *Fair Value Measurements*

The Plan follows the Fair Value Measurements topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodology used at December 31, 2024 and 2023.

### Cash and Cash Equivalents

The Plan considers instruments purchased with original maturities of three months or less to be cash equivalents. During 2024 and 2023, the Plan was invested in the Federated Hermes Government Obligations Fund. This is an interest-bearing cash sweep account intended to provide participants with an investment vehicle for cash not yet invested in mutual fund options. Interest rates are determined by the bank. Cash accounts are insured by the FDIC up to \$250,000 for each financial institution.

### Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Collective Trust Funds

Valued based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets and may also include insignificant adjustments to market observable inputs. The collective trust funds invest in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While underlying asset values are quoted prices, the net asset value (NAV) of a unit in this fund is not publicly quoted. Units can be issued and redeemed on any business day at

the NAV. All earnings and losses are included in the computation of the NAV and are realized by the participant upon withdrawal. No distributions of income and gain or loss are made to participants.

### *Investment Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Payment of Benefits*

Benefits are recorded when distributed to participants.

### *Subsequent Events*

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

### Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account. The Plan Administrator will facilitate the distribution of account balances in single lump-sum payments to each participant in accordance with Plan provisions until all assets have been distributed by the Trustee.

### Note 6 – Income Tax Status

The IRS has issued an opinion letter dated June 30, 2020, indicating that the non-standardized pre-approved Profit-Sharing Plan document adopted by the Plan, as then designated, qualifies under the applicable sections of the *IRC*. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the *IRC* and has no income subject to unrelated business income tax, and therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no tax audits in progress.

### Note 7 – Related Party and Parties-in-Interest Transactions

Certain expenses are paid by the Plan to Ascensus, LLC, an authorized representative of the Trustee, Ascensus Trust Company, for services provided. Therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid to Ascensus, LLC were \$19,373 for the year ended December 31, 2024.
