### A. Description of the Plan

The following brief description of the HPI Real Estate 401(k) Plan (plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

#### General

The plan is a defined contribution plan covering all employees of HPI Real Estate Management, Inc. who have completed three months of service. Employees may begin participating in the plan once the eligibility requirements have been met and the entry date has been reached. Plan entry dates are the first day of each quarter of the plan year. The following affiliated employers adopted the HPI Real Estate 401(k) Plan: HPI Corporate Services, LP, Air Austin Services, Inc., HPI Residential LLC, HPI Finance Austin, LLC, HPI Strategic Investments, Inc., HPI Real Estate, Inc., HPI Retail Properties, LP, HPI Commercial Real Estate, LLC, HPI Multifamily LLC, and HPI Opportunity Platform & Promote LLC. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### Contributions

Eligible participants may elect to defer any percentage of compensation up to the IRS maximum allowable limit. In addition, participants age 50 and older as of the end of the plan year are permitted to make elective catch-up contributions. Participants may also contribute rollovers representing distributions from a former employer's qualified retirement plan.

This plan also contains an automatic enrollment feature. Unless a participant makes an affirmative election, the company will begin to automatically deduct 5% from compensation on a pre-tax basis as a deferral contribution. The initial automatic deferral will increase by 1%, up to a maximum of 15%, on April 1 of each year.

The employer will make a safe harbor matching contribution to the account of each eligible participant in an amount equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participants compensation.

#### Participant's accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their safe harbor contributions, elective deferrals and rollover contributions, if any, plus actual earnings thereon. The following vesting schedule applies in determining non-forfeitable interest in employer derived account balances other than those fully vested when contributed:

#### Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

#### Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions. However, if the loan is for the purchase of your principal residence, the administrator may permit a longer payment term.

#### Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$52,599 and \$47,521, respectively. These accounts will be used to reduce future employer contributions (other than contributions that must be fully vested when contributed) or to pay administrative expenses of the plan. Forfeitures of \$10 were used during 2024.

### B. Summary of Significant Accounting and Reporting Policies

#### Basis of accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. See Note C for a discussion of fair value measurements.

##### **Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment valuation and income recognition**

Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold, as well as held during the year.

##### **Payment of benefits**

Benefits are recorded when paid.

##### **Operating expenses**

Certain administrative expenses of maintaining the plan are paid by the company. Contract administrative fees are paid by the plan.

##### **Subsequent events**

The plan has evaluated subsequent events through August 05, 2025, the date the financial statements were available to be issued.

##### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

#### **C. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

*Common Collective Trust:* The funds are collective investment funds which do not have a readily determinable fair value and are valued based on a NAV practical expedient and included as a reconciling item to the fair value table. There are no participant redemption restrictions for these investments.

**D. Guaranteed Investment Contract with Principal Life Insurance Company**

In 2022, the plan entered into a fully benefit-responsive interest account with Principal, which maintains the contributions in a general account totaling \$3,953,049 for 2023 and \$3,345,439 for 2022. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The crediting interest rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### **E. Related Party and Party-In-Interest Transactions**

During 2024 and 2023, the plan investments were managed by Principal Trust Company. Principal is a custodian as defined by the plan and, therefore, a party-in-interest with respect to the plan. These transactions are covered by an exemption from the "prohibited" transaction provisions of ERISA and the IRC.

#### **F. Plan Termination**

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

#### **G. Tax Status**

On June 30, 2020, the IRS stated that the prototype adopted by the plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The plan has not received a determination letter specific to the plan itself; however, the plan administrator and the plan's tax counsel believe that the plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the plan's financial statements. Although the plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **H. Risks and Uncertainties**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **I. Custodial Certification**

The plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Principal Trust Company and was not subjected to any auditing procedures performed by the independent public accountants:

- a.* Total investments as shown in the accompanying statements of net assets available for benefits of \$26,369,199 as of December 31, 2024, and \$22,421,551 as of December 31, 2023.
- b.* Net investment income as shown in the accompanying statement of changes in net assets available for benefits of \$2,449,334 for the year ended December 31, 2024.
- c.* All investment-related information in the accompanying supplemental Schedule H, Line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024.

#### **J. Change in Service Provider**

The employer changed payroll providers during 2024 from ADP to Paylocity.

#### **K. Failure to Timely Transmit Participant Contributions**

The Company failed to remit to the Plan certain participant contributions during 2023 totaling \$61,765 within the period prescribed by the DOL's regulations. Plan officials adopted stricter oversight in this area and made contributions to the affected participants' accounts to compensate those participants for potential lost earnings and corrected the prohibited transaction by filing Form 5330 Return of Excise Taxes Related to Employee Benefit Plans.
