We have performed audits of the financial statements of Dixon Schwabl Advertising, Inc. 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE A: DESCRIPTION OF THE PLAN

The following description of the Dixon Schwabl Advertising, Inc. 401(k) and Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Dixon Schwabl Advertising, Inc. (the “Company”) who have attained twenty-one years of age. Employees are eligible to enter the Plan anytime following the date the employee satisfies the eligibility requirements. All eligible employees will be automatically enrolled in the Plan at a contribution rate of 4% of their wages unless they elect to not participate or elect to contribute at a different percent of wages. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions

Participants may contribute up to 96% of their annual wages subject to Internal Revenue Service (“IRS”) limitations. Participants direct all investment contributions into various investment options offered by the Plan. Participants are eligible to receive employer contributions in which the employer will match 25% of the first 8% of the employees’ contribution to the Plan. In addition, the Company may make a discretionary qualified non-elective contribution based on an amount determined by management. The discretionary qualified non-elective contribution shall be allocated to only non-highly compensated employees that were an active participant during the Plan year. For the years ended December 31, 2024 and 2023, the Company did not make a discretionary qualified non-elective contribution.

Participant accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company’s contribution and Plan earnings or losses and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become vested in employer matching and discretionary non-elective contributions plus actual earnings thereon based on years of service, as shown below:

Participant notes receivable

Participant notes receivable are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Participants are entitled to borrow from their vested retirement plan account subject to certain limitations. Loans should not exceed a payable term of 5 years, participants are limited to two loans during any 12-month period and should not have more than two outstanding loans at any time. Loans should not be issued for amounts less than \$1,000 and should not be issued for more than, the lesser of, 50% of the Participant's Vested Account, reduced by any outstanding loan balance, or \$50,000, reduced by the highest outstanding loan balance during the one-year period.

Payment of benefits

Upon retirement, death, termination of employment or permanent and total disability, a participant is entitled to receive a lump-sum distribution or a series of equal payments over a period of time, equal to the value of the participant's vested balance in their account. In addition, lump-sum distributions may be made from vested account balances in excess of \$5,000, with participant consent, under the following conditions: separation of service; upon participants' attainment of age 59½ with continued employment; upon participant's attainment of age 65 ("normal retirement"); upon hardship of a participant as provided for in the Plan and in performing qualified military service. Participants are required to begin receiving benefits on April 1<sup>st</sup> following the calendar year the participant attains the age of 72. Effective January 1, 2023, in conjunction with SECURE 2.0 Act, the age for required distributions rose to 73. Participants may withdraw any part of their elective deferral or rollovers at any time but are limited to the number of occurrences in a twelve-month period. Vested balances of less than \$5,000 upon separation of service will be paid in a lump-sum distribution in accordance with the provision of the Plan. Benefits paid to participants are recorded as of the date paid.

Forfeitures

Forfeitures of non-vested and excess employer contributions may be used to reduce future employer matching contributions or pay plan expenses. At December 31, 2024 and 2023, the Plan had \$3,401 and \$6,420, respectively, in non-vested or excess employer contribution forfeitures. During 2024, forfeitures totaling \$27,076 were utilized to reduce employer contributions or pay plan expenses.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition

Investments held by the Plan are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of common/collective trusts are valued at the net asset value of share held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when earned. Historical cost is used to determine the net appreciation or depreciation of investments, as reported by the Plan's trustees.

Plan expenses

Administrative expenses incurred by the Plan are paid by the employer except for certain professional fees. Expenses that are paid directly by the employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits. These expenses are party-in-interest transactions.

Use of estimates in the preparation of financial statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through October 7, 2025, which is the date the financial statements are available to be issued. No subsequent events requiring disclosure were noted.

NOTE C: FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establishes a hierarchal disclosure framework which prioritizes and ranks the level of market price observance used in measuring investments at fair value. Market price observability is affected by a number of factors, including the type of investment and the characteristics specific to the investment. Investments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are actively traded open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to report their daily net asset value ("NAV") and to transact at that price.

*Common/Collective Trusts:* The trusts are valued at the NAV of the units held by the Plan at year end and the NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments comprising the trusts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to amounts presented in the statement of net assets available for benefits.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts and their accounts will be paid to them as provided by the plan document.

NOTE F: TAX STATUS

The Internal Revenue Service has determined and informed the Plan applicant by a letter dated June 30, 2020, that the non-standardized pre-approved Plan adopted by the Company is designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving that determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G: TRANSACTIONS WITH PARTY-IN-INTEREST

The Plan considers “prohibited transactions” as reportable party-in-interest transactions. As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA. Except as noted in Note B, the Plan had no other reportable party-in-interest transactions.

NOTE H: RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The classification of the change in net assets available for benefits for the year ended December 31, 2024 differs between the financial statements and Form 5500. However, the total change in net assets for the year then ended agreed between the financial statements and Form 5500.

NOTE I: RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
