Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Open Dental Software 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1) Description of the Plan

The following description of Open Dental Software 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the commonly controlled companies Open Dental Software, Inc. and Oregon Cryonics (collectively, the “Company” or “Employer”). Employees may enter the Plan on the first day of the month that coincides with or follows the date on which they begin employment. The Employer serves as the Plan Administrator. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year may make catch-up elective deferral contributions subject to Internal Revenue Code (the “Code”) limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes a discretionary matching contribution of 100 percent of the first three percent and 50 percent of the next two percent of the pretax annual compensation that a participant elects to contribute. An employee is eligible to receive an employer matching contribution upon entry to the Plan.

Amounts deferred as catch-up contributions are also considered for matching contributions purposes. For the years ended December 31, 2024 and 2023, safe harbor matching contributions totaled \$575,031 and \$516,710, respectively.

The Company may make non-elective contributions which are made solely at the discretion of the Board of Directors. No discretionary non-elective contributions were made in 2024 and 2023.

Contributions are limited to the maximum amount which will not cause the Plan to violate the provisions of the Plan or cause the Plan to exceed the maximum amount allowable as a deduction to the employer under Code Section 404.

Funding Policy

It is the policy of the Company to fund contributions to the Plan on a regular basis as soon as employee deferrals are made, and employer contributions are elected.

Investment Options

Participants are allowed to invest in a variety of investment choices as more fully described in the Plan’s literature.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and plan earnings (losses), less an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Vesting

Participants are vested immediately in their contributions and any Company safe-harbor matching contributions, plus actual earnings thereon. Vesting in any Company non-safe harbor nonelective contribution portion of their accounts is based on continuous years-of-service during which the participant is credited with at least 1,000 hours of service at a rate of 20 percent each year after the first year, becoming 100 percent vested after six years of service credited. Additionally, a participant will be fully vested upon death or disability.

Payment of Benefits

On termination of service or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or partial distribution thereof, or paid out in installments over a certain period. A participant who is still an employee and has reached age 59 ½ may request an in-service distribution of all, or a portion, of the participant's vested interest in his or her account in the form of a lump sum amount. Terminated participants with account balances less than \$5,000 are subject to mandatory "cash-out" provisions. As of March 1, 2024, the plan increased the threshold to \$7,000.

The Plan also provides a participant who demonstrates "financial need," as defined by the Plan, with the option of taking a withdrawal from the participant's vested account balance.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50 percent of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate of interest which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See additional information in the "Fair value measurements" note to the financial statements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the company. Distribution fees and fees related to the administration of notes receivable from participant's are charged directly to the participant's account and are included in administrative expenses. Expenses that are paid by the company are excluded from these financial statements. Other investment related expenses are included in net appreciation of fair value of investments, while those paid directly are separately stated.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

4) Information Certified by the Trustee (Unaudited)

Ascensus Trust Company, the trustee, holds all investments and executes all investment transactions on behalf of the Plan. Information regarding the value of all cash, investments, participant notes receivable, interest and dividend income and net appreciation/depreciation in the fair value of investments has been certified by Ascensus LLC, as authorized agent for Ascensus Trust Company, as complete and accurate in accordance with 29 CFR Section 2520.103-5c of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

5) Related-Party and Party-In-Interest Transactions

Certain plan investments are shares of mutual funds held by the trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Other parties-in-interest include the Plan's sponsor, participants, and anyone performing services for the Plan.

6) Plan Termination

Although it has not expressed any intent to do so, Open Dental Software 401(k) Plan has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of total or partial plan termination, affected participants will become 100 percent vested in their accounts.

7) Tax Status

The Company adopted a prototype non-standardized profit-sharing plan effective June 1, 2021, on which the IRS issued an opinion letter dated June 30, 2020, indicating that the form of the specimen plan, as then designed, is acceptable under Section 401 of the Internal Revenue Code. Although the plan has been amended since receiving the opinion letter, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
