To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Honolulu Community Action Program, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Honolulu Community Action Program, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Honolulu Community Action Program, Inc. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Honolulu Community Action Program, Inc. Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Honolulu Community Action Program, Inc. Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about of Honolulu Community Action Program, Inc. Retirement Plan ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) (modified cash basis) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. DESCRIPTION OF THE PLAN

The following description of the Honolulu Community Action Program, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

a. General

The Plan was established by Honolulu Community Action Program, Inc. (HCAP) in 1972. The Plan is a money purchase pension plan, which is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974.

b. Eligibility for Elective Deferral and Employer Contributions

An employee is eligible for participation in the Plan upon the completion of 1,000 hours of service within 12 consecutive months beginning with the employment commencement date or, if 1,000 hours of service are not completed during such a period, then the employee will qualify as soon as 1,000 hours of service are completed in any succeeding 12-consecutive-month period beginning on the anniversary of the employment commencement date.

c. Contributions

The Plan allows the participant to authorize the employer to deduct the maximum allowable deduction of three percent of total wages as the participant’s contribution. The employer’s contribution is two times the amount of the active participant’s contributions, but not to exceed six percent of total wages from which the participant’s contributions are deducted. Contributions commence with the pay period during which the participation date occurs. The Plan was frozen on September 1, 2006. No contributions were made subsequent to September 1, 2006.

d. Plan Benefits

Participants are entitled to the portion of their account balances to which they have a vested right. Participants’ vested balances will be equal to 100 percent of their contribution and the applicable percentage of HCAP’s contribution in accordance with the following schedule:

e. Allocation of Contributions

The entire Plan operates as a single fund, where individual recordkeeping accounts are maintained for each participant. Each participant's account is credited with the participant's contribution and an allocation of HCAP's contribution and Plan earnings.

f. Forfeitures

Participants forfeit nonvested portions of employer contributions when they terminate employment before satisfying the Plan's vesting requirements. In accordance with the Plan document, forfeitures may be used to pay eligible Plan administrative expenses or to reduce future employer contributions. For the year ended December 31, 2024, the amount forfeited totaled \$1,702. No forfeitures were recorded for the year ended December 31, 2023. As of December 31, 2024 and 2023, forfeitures available for use totaled \$41,294 and \$37,567, respectively.

g. Death, Disability and Retirements

Benefits in the event of the participant's death, disability, retirement, normal or postponed retirement or reduction in force or transfer termination, the vested balance shall be equal to the full amount credited to the member's account (100 percent of participant's share and 100 percent of HCAP's share).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of Accounting

The accompanying financial statements have been prepared in accordance with the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under this method, revenues are recognized when received and expenses are recognized when paid, with certain modifications to reflect the recording of investments at fair value.

b. Investment Valuation

Investments are stated at fair value, which is the amount would be received from selling an asset as of the measurement date. The Plan 's valuation policies utilize information provided by its investment custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation or depreciation in the fair value of investments reflects both realized gains and losses on investments sold during the year and the change in unrealized gains and losses on investments held at year- end.

c. Administrative Expenses

The Plan's expenses are paid by the Plan, as provided by the plan document. Expenses include maintenance charge, separate account charge at an annual rate ranging from 1% to 1.25% of the average daily net asset value of separate account, and cash surrender or withdrawal charge. Charges against separate accounts paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits

d. Payment of Benefits

Participant benefits are recorded when paid.

e. Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of Plan assets and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

3. INFORMATION CERTIFIED BY CUSTODIAN

The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023 and for the years then ended, included in the Plan's financial statements and supplemental schedules, that was prepared by or derived from information prepared by AIG VALIC, the custodian of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certification from the custodian that such information is complete and accurate.

4. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated September 30, 2005, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. PARTY-IN-INTEREST

The Plan's investments are managed by VALIC, custodian as defined by the Plan and, therefore, the transactions qualify as party-in-interest transactions. Fees for the administration services amounted to \$14,068 and \$22,975 for the years ended December 31, 2024 and 2023, respectively. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

6. FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024.

- Mutual Fund: Valued at fair value based on quoted market prices
- Fixed Interest Options: Valued at fair value based on contract values

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2006, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with VALIC AIG Retirement Services. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investment and charged for administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 were \$1,550,699 and \$1,764,065, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 2%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with VALIC. Such events include, but not limited to: mergers, layoffs, bankruptcy, or plan termination, as that term is defined under federal law and regulations promulgated thereunder, or comparable person as allowed by applicable law. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Either party to the group annuity contract may terminate the contract with written notice to the other party. The contract termination date shall be any business day on or after the expiration of the 30-day notification period.

8. CHANGE IN FAIR VALUE OF INVESTMENTS

10. PLAN TERMINATION

Although it has not expressed any intent to do so, HCAP has the right under the Plan at any time to terminate the Plan by delivering to the trustee and administrator written notice of such termination. Upon termination of the Plan, the interest of each participant becomes fully vested and shall not be subject to forfeiture. Furthermore, with respect to priorities in the event of a plan termination, HCAP would direct the distributions of the assets of the trust fund to participants in a normal manner, which is consistent with the Plan's distribution of benefits provisions.

11. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

12. SUBSEQUENT EVENTS

Management evaluated events and transactions that occurred after the balance sheet date for potential recognition and disclosure through October 3, 2025, the date on which the financial statements were available to be issued.
