Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hillis-Carnes Engineering Associates, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hillis-Carnes Engineering Associates, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Hillis-Carnes Engineering Associates, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 **Description of Plan and Significant Accounting Policies**

Description of the Plan - The following description of the Hillis-Carnes Engineering Associates, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. All non-union employees of Hillis-Carnes Engineering Associates, Inc. and subsidiaries (collectively, the Company) are eligible to participate after 60 days of service and attaining age 18. Employees are eligible to enroll the first day of each month on or following the date the employee meets the eligibility requirements.

Basis of Accounting - The financial statements of the Plan have been prepared on the accrual basis of accounting.

Administration - A third-party administrator processes and maintains the records of participant data. The Company has contracted with Principal Trust Company to act as the trustee and custodian. Substantially all the third-party fees incurred for administering the Plan are paid via Plan assets. Other Plan expenses, such as annual audit fees, are paid by the Company.

Contributions - Each calendar year, participants may authorize the employer to withhold from their compensation up to the maximum dollar amounts permissible under Code Section 402(g), not to exceed the limits of Code Sections 401(k), 404 and 415. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan currently offers money market funds, pooled separate accounts, mutual funds and investments in a common/collective trust. Participants may change their investment allocations daily. The Company may make matching contributions or profit sharing contributions at its discretion based on a percentage determined each year. For 2024 and 2023, the Company matched 50% up to 4% of employee contributions with a maximum of 2%, computed each payroll. The Company made matching contributions of \$464,586 and \$454,053 for 2024 and 2023, respectively. The Company made no profit sharing contributions during the years ended December 31, 2024 and 2023.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$500 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The term of the loan is limited to five years except where a loan is taken for the purchase of a participant's principal residence. The number of outstanding loans for a participant is limited to one. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate determined by the administrator based on prevailing market rates. The specific terms and conditions of such loans are established by the Plan administrator. Interest rates range from 4.25% to 9.50% for loans outstanding. Principal and interest are paid ratably through payroll deductions. Participant loans are classified as a note receivable from participants and measured at their unpaid principal balances plus any accrued interest. Notes receivable due from participants on the Statements of Net Assets Available for Benefits, were \$424,271 and \$429,698 as of December 31, 2024 and 2023, respectively. Periodically, the Plan administrator reviews its receivables and at December 31, 2024, management had determined that all receivables are fully collectable; accordingly, no allowance for doubtful accounts is considered necessary. Delinquent loans are treated as distributions based upon the terms of the plan document regarding defaults.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the Company's contributions portion of their accounts as follows:

Payment of Benefits - The Plan permits withdrawals when a participant terminates employment, retires, becomes disabled or deceased. In service withdrawals are also permitted for certain financial hardships or when a participant attains age 59 ½. Benefits are payable in lump-sum payments with certain exceptions allowed. Benefits are recorded when paid.

Forfeitures - Forfeitures of non-vested employer matching contributions are used to reduce administrative fees and the Company matching contributions. Non-vested forfeiture account balances were \$68,845 and \$55,294 as of December 31, 2024 and 2023, respectively.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value except for the guaranteed investment contract account which is stated at contract value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Participant loans are valued at their outstanding principle balances plus accrued but unpaid interest, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year.

Risks and Uncertainties - The Plan invests in various investment securities. These investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level associated with certain investment risks, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits. Plan assets may have changed in value since December 31, 2024 due to normal market fluctuations.

NOTE 3 **Guaranteed Investment Contracts**

Investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

The Plan invests in investment contracts (which may include traditional guaranteed investment contracts (GICs), separate account insurance contracts and wrapper contracts (synthetic GICs), and wrapper contracts) through participation in the Principal Life Insurance Company's Principal Fixed Income Guaranteed Option, which is a fully benefit responsive guaranteed investment contract. Principal Life Insurance Company maintains the contributions in a general account which are allocated to each participant's individual account and credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2024 and 2023, respectively, there was no significant difference between the contract value and fair market value of the investment contracts.

Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with the Plan's participants is not probable.

NOTE 4 **Fair Value Measurement of Investments**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are as follows:

- Level 1: Quoted market prices in active markets for identical assets and liabilities.
- Level 2: Observable market based inputs or unobservable inputs that are corroborated by market data.
- Level 3: Unobservable inputs that are not corroborated by market data.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the quoted market price of the fund which represents the net asset value of the shares held by the fund at year-end.

Collective Trusts and Pooled Separate Accounts: Valued using the net asset value (NAV) as a practical expedient which represents the price at which the Fund is able to initiate a transaction. These investments are excluded from the fair value hierarchy.

The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024 and 2023, there were no transfers into a Level 3 investment.

For all Plan investment categories, there are no unfunded commitments and investments are redeemable on a daily basis.

NOTE 5 **Tax Status**

Effective February 1, 2010, the Plan adopted a nonstandard prototype plan. The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has relied on this opinion letter. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan Administrator does not believe that the Plan has any uncertain tax positions.

Required IRC annual top heavy and non-discrimination testing has not been completed for the Plan years 2023 and 2024 as of the date of these financial statements. The Plan administrator is actively working with the provider to complete this testing and does not expect any significant excess contributions that will have to be paid to participants as of December 31, 2024.

NOTE 6 **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 **Related Party Transactions**

Certain Plan investments are managed by Principal Trust Company, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Principal Trust Company for contract administrative services totaled \$91,483 for the year ended December 31, 2024.

NOTE 8 **Subsequent Events**

Subsequent events have been evaluated through October 13, 2025, the date the audited financial statements were available to be issued. The Plan administrator is not aware of any subsequent events, which would require recognition or disclosure in the financial statements.
