Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Freudenberg Companies 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. DESCRIPTION OF PLAN

The following description of Freudenberg Companies 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and includes employees of Freudenberg Household Products LP (plan sponsor), Freudenberg Filtration Technologies LP, Freudenberg Flow Technologies Inc. (previously Freudenberg Oil & Gas Technologies), Freudenberg Performance Materials LP, Freudenberg Texbond, LP, Kluber Lubrication NA, LP, Tobul Accumulator Incorporated, Capol LLC, Chem-Trend Limited Partnership, SurTec, Inc., XALT Energy MI, LLC, and Freudenberg Battery Power Systems, LLC (collectively, the Employers). Effective January 1, 2024, the Plan was restated to add Precote USA, PPA Industries, Inc., Filters Now, LLC, and CTM Enterprises, Inc. as participating employers. Also effective January 1, 2024, Low & Bonar Inc. employees became employees of Freudenberg Performance Materials LP and became eligible to participate in the Plan. The Plan excludes union, part-time/temporary/seasonal employees, non-resident aliens, employees classified as "Assignees" per the Freudenberg Long-Term International Assignment Policy and employees who are residents of Puerto Rico. Interns and co-ops who complete less than 1,000 hours during the relevant eligibility period are also excluded. Effective January 1, 2024, the Plan also excludes collectively bargained employees of Freudenberg Performance Materials LP. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was restated effective January 1, 2023 and again on January 1, 2024. Significant changes to the plan provisions as a result of the restatements are disclosed in each applicable area.

Plan Transfers

During 2024, due to changes in job positions within the Employers, one participant transferred to the Plan from Freudenberg Companies 401(k) Retirement Plan (Freudenberg Retirement Plan). The net assets of the transferred in participant totaled \$443,628.

During 2023, due to changes in job positions within the Employers, one participant transferred to the Freudenberg Retirement Plan. The net assets of the transferred out participant totaled \$13,365.

Plan Transfers (Continued)

Effective December 31, 2023, the Low and Bonar Inc., Retirement Savings and 401(k) Plan (L&B Plan) was merged into the Plan (L&B Plan merger). Upon merger, all L&B Plan participants' prior employer service was credited for eligibility and vesting requirements in the Plan. Net assets totaling \$1,734,100 were received by the Plan prior to December 31, 2023, with the remaining \$10,894,469 received by the Plan on January 2, 2024.

Effective December 31, 2023, the Protect Plus Holdings Corp. Savings Plan (Protect Plan) was merged into the Plan (Protect Plan merger). Upon merger, all Protect Plan participants' prior employer service was credited for eligibility and vesting requirements in the Plan. Net assets totaling \$130,136 were received by the Plan prior to December 31, 2023, with the remaining \$1,935,318 received by the Plan on January 2, 2024.

Effective December 31, 2023, the Precote USA 401(k) Plan (Precote Plan) was merged into the Plan (Precote Plan merger). Upon merger, all Precote Plan participants' prior employer service was credited for eligibility and vesting requirements in the Plan. Net assets totaling \$476,066 were received by the Plan during January 2024.

Management of the Employers believe that the plan transfers and plan mergers were tax-exempt transactions under the applicable provisions of the Internal Revenue Code (IRC) and, therefore, are not subject to federal income tax.

Contributions

Each year, participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan. Participants are permitted to designate a portion or all of their deferral contributions as Roth 401(k) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan includes an auto enrollment provision for employees who have a hire or re-hire date after January 1, 2018. These participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants generally have their deferral rate increased at a rate of 1% per year on January 1, up to a maximum of 5% of eligible compensation unless otherwise elected by the participant except for the following Employers:

- Employees of Tobul Accumulator Incorporated have their deferral rate increased up to a maximum of 6%.

- Employees of Kluber Lubrication, LP, Capol LLC, Chem-Trend Limited Partnership, SurTec, Inc., and Precote USA have their deferral rate increased at a rate of 1% per year on April 1 annually, up to a maximum of 10% of eligible compensation, unless otherwise elected by the participant.
- Employees of Freudenberg Texbond LP do not receive automatic increases.
- Former employees of Low & Bonar Inc. who became employees of Freudenberg Performance Materials LP and participants who were employees of Precote USA as of the merger date are not subject to the automatic deferral provisions unless they incur a severance from employment and are subsequently rehired.
- Participants of the Protect Plan and who were employees of Protect Plus Holdings Corp. as of the merger date will defer at the automatic deferral rate applicable under the Protect Plan on December 31, 2023, increased by 1% effective January 1, 2024.
- Effective January 1, 2024, newly hired and rehired employees of PPA Industries, Inc., CTM Enterprises, Inc., and Filters Now, Inc. will be subject to the terms of the automatic deferral provisions of the Plan on the date they satisfy the eligibility and entry date requirements of the Plan.

The Employers contribute a safe harbor match of 100% of the first 3% and 50% of the next 2% that a participant contributes to the Plan.

Some Employers also may make nonelective contributions. For eligible hourly participants who are employees of Freudenberg Filtration Technologies LP or Freudenberg Performance Materials LP (excluding participants who were employed by Low & Bonar, Inc., who became employees of Freudenberg Performance Materials LP unless they incur a severance from employment and are subsequently rehired), a 3% nonelective contribution is made to hourly employees hired on or after January 1, 2007, regardless of years of service.

For all other eligible participants of Freudenberg Filtration Technologies LP, Freudenberg Performance Materials LP, and Freudenberg Texbond, LP a nonelective contribution is made based on the following schedule:

Eligible participants employed by Kluber Lubrication NA, L.P. Capol, LLC, Chem-Trend Limited Partnership, and SurTec, Inc., receive a fixed non-elective contribution equal to 70% of the participant's "contribution rate" multiplied by the participant's eligible compensation. The participants must be employed on the last day of each of the semi-annually computation periods to receive the semi-annual non-elective contribution. The participant's "contribution rate" is based on the following:

The Employers may elect to make discretionary non-elective contributions to eligible participants. Eligible participants must be employed on the last day of the plan year and have accumulated a specific number of service hours, based on Employers' requirements to receive the non-elective contribution, unless the participant incurs a severance from employment due to death, disability, attainment of normal or early retirement age, or an authorized leave of absence (Freudenberg Flow Technologies Inc.). Freudenberg Flow Technologies Inc. does not have an hours of service allocation condition but does have a last day requirement. Effective January 1, 2023, Freudenberg Filtration Technologies LP, Freudenberg Performance Materials, and Freudenberg Texbond LP do not have an hours of service allocation condition or last day requirement. For employees of Freudenberg Household Products, LP, XALT Energy LLC, Freudenberg Battery Power Systems, LLC and Tobul Accumulator, Inc., no discretionary non-elective contributions were made for the years ended December 31, 2024 and 2023, respectively. No discretionary non-elective contributions were made for employees of PPA Industries, Inc. or CTM Enterprises, Inc. for the year ended December 31, 2024.

Contributions are subject to certain limitations as mandated by the IRC.

Investment Options

Participants may direct all their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provisions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employers' contribution(s) and (b) plan earnings (losses) and charged with the participant's benefit payments and an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their account balance, less defaulted loans (if any). Participants can have only 1 loan outstanding at any time. The loans are secured by the balance in the participants' account and bear interest at rates of prime plus 1%. The term of the loan may not exceed 5 years or 15 years if the loan proceeds will be used to acquire the principal residence of the participant. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are vested immediately in their contributions and employer safe harbor matching contributions plus actual earnings (losses) thereon. For all participants not listed below, vesting in the Employers' nonelective contribution portion of their account is based on the following schedule:

Freudenberg Household Products LP nonelective contributions made prior to January 1, 2017 are 100% vested at all times. Matching contributions which were transferred to the Plan from Freudenberg Texbond, LP 401(k) Plan, Tobul Accumulator, Inc. 401(k) Retirement Plan, and XALT Energy, LLC 401(k) Plan are subject to a six-year graded vesting schedule. Participants who participated in the Chem-Trend Retirement Plan 401(k) Plan or the SurTec Inc. 401(k) Profit Sharing Plan and Trust will be 100% vested in non-safe harbor matching contributions.

Payment of Benefits

On termination of service, death, disability, retirement, or attainment of age 59½, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a reasonable period of time. A participant that terminates employment whose account balance is less than \$7,000 (\$5,000 during 2023) will receive a distribution of their vested aggregate account balance without the consent of the participant. If the distributions is less than \$1,000 the distribution will be made in the form of lump sum cash. If the distributions is greater than \$1,000, but less than \$5,000, the Plan will pay the distribution in an automatic direct rollover to an individual retirement account (IRA). Under certain conditions, participants may receive a hardship distribution if certain criteria are met

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$353,943 and \$404,175, respectively. These amounts will be used in accordance with the applicable plan provisions. During 2024 and 2023, forfeitures of \$269,49 and \$1,999,610, respectively, were used to reduce the Employers' contributions. Additionally, during 2024 and 2023, forfeitures of \$23,982 and \$11,247, respectively, were used to pay administrative expenses of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America (US GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Advisory Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest less amounts defaulted (if any). Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Loan administration and distribution fees are charged directly to the participant's account and are included in administrative expenses. The Plan also pays certain investment advisory and plan administration fees from plan assets. Certain investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Recent Accounting and Regulatory Pronouncements

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor (DOL). The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the years ended December 31, 2024 and 2023. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

3. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the fully benefit-responsive investment contract was \$130,145 for the year ended December 31, 2023. The contract was terminated during 2024 and participants with funds invested in the fully benefit-responsive investments contract transferred to other investment options during 2024 and there was no balance remaining as of December 31, 2024.

3. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)

The traditional investment contract held by the plan was a guaranteed investment contract. The contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than 0%. The crediting rate was reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,
- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the US Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. FAIR VALUE MEASUREMENTS (Continued)

Collective trust funds: Investments are valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV is a readily determinable fair value and is the basis for current transactions. Were the Plan to initiate a full redemption of the stable value collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Pooled separate account: Investments in units of pooled separate accounts held with an insurance company are stated at estimated fair market value and are valued by the insurance company based on the NAV of units held by the Plan at year end. The NAV is determined by the insurance company based on the market value of the underlying investments held in the pooled fund.

Stable value collective trust: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the stable value collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. CERTIFICATION OF FINANCIAL INFORMATION

The financial data included in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023 and supplemental schedule of assets (held at end of year) as of December 31, 2024 has been certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, qualified institutions. The following certified information was obtained by management and agreed to or derived from information certified as complete and accurate, and has not been audited by the independent auditors for the Plan: investments at fair value, investments at contract value, notes receivable from participants, interest and dividends, interest on notes receivable from participants, and net appreciation in fair value of investments.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employers may determine.

7. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Empower Trust Company, LLC, the trustee, or Empower Annuity Insurance Company of America, the custodian, or an affiliate, and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. The Plan issues loans to participants, which are secured by the vested balance in the participants' accounts and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Employers. These transactions qualify as party-in-interest. Employees of the Employers provide administrative services to the Plan for which no fees are charged.

In addition, the Employers are eligible for expense reduction credits from the custodian. These credits are allocated to Plan participants based on the average daily account balance of the participant invested in the revenue sharing investment option. For the years ended December 31, 2024 and 2023, expense reduction credits totaling \$104,800 and \$120,516, respectively, were allocated to participant accounts.

8. TAX STATUS

The Employers adopted a non-standardized pre-approved plan document, which received an opinion letter dated November 14, 2022, in which the IRS stated that the non-standardized pre-approved plan document was in compliance with applicable requirements of the IRC. The Plan has not received a determination letter specific to the Plan itself and has been amended since adopting the non-standardized pre-approved plan document; however, the plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. In April 2025, the Plan was notified that it was selected for a DOL audit. The DOL has begun their fieldwork, however, have they have not communicated any violations or assessed any penalties as of the date of the report.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances, and the amounts reported in the statements of net assets available for benefits.

10. PROHIBITED TRANSACTIONS

During 2024, 2023, and 2022 the Employers failed to remit to Empower contributions totaling \$2,358,451, \$5,292,494, and \$54,424, respectively, within the period prescribed by Department of Labor's regulations. Delays in remitting contributions to the trustee were due to administrative errors, and the Employers have made or will make contributions to the affected participants' accounts to compensate for potential lost income due to the delays.

11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2025, which was the date that these financial statements were available for issuance and determined that there were no significant nonrecognized subsequent events through that date.
