We have performed an audit of the financial statements of Purflux USA, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE:

1. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of Purflux USA, Inc. 401(k) Plan (the Plan) are prepared under the accrual method of accounting.

Statement of Net Assets Available for Benefits – The Statement of Net Assets Available for Benefits is not shown in comparative format because 2024 is the initial year of the plan resulting from a spinoff during the year. All amounts for the prior year were zero and have been omitted from this presentation.

Investments – Investments are reported at fair value, except for the fully-benefit-responsive annuity contract, which is reported at contract value (see Note 9). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Contributions – Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses – Administrative expenses are shown on the statement of changes in net assets available for benefits. This amount represents administrative costs paid to third-party service providers for financial advisory, legal consultation, and recordkeeping services. The employer absorbs all other costs of the Plan.

Risks and Uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statement of net assets available for benefits.

Subsequent Events – The Company has evaluated events and transactions that occurred through October 13, 2025, which is the date the financial statements were available for issue.

2. Plan Description

The following description of the Purflux USA, Inc. 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Purflux USA, Inc. (Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Spinoff - During 2024, Sogefi Air & Cooling USA, Inc. sold their filtration division, located in West Virginia, to Purflux USA, Inc., an unrelated party. Following the sale, the Sogefi USA Retirement Plan (EIN #80-0519639) was split into two separate plans and the accounts of the employees at the West Virginia filtration division were transferred to Purflux USA, Inc. 401(k) Plan, a new plan resulting from the spin-off.

Eligibility – Non-salaried employees of the Employer are eligible to participate in the Plan three months from the date of hire, while salaried employees are immediately eligible to participate in the Plan, excluding employees covered by collective bargaining agreements. There is no minimum age requirement to participate in the Plan. Entry into the Plan is the first day of the month coincident with or following the service requirement.

Contributions – Contributions to participants' accounts may be made through voluntary reductions in their compensation, rollover contributions from other qualified plans, as well as discretionary employer matching contributions. Employees participating in the Plan may contribute up to 100% of their before-tax compensation up to the limit in effect for the year (\$23,000 in 2024). Participants aged fifty or older may make an additional "catch-up" contribution (\$7,500 for 2024). The Company contributed a safe harbor match equal to 100% of participant contributions, not to exceed 5% of participant compensation during 2024. Additional amounts may be contributed at the option of the Company.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of the (a) employer's contribution, (b) Plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All contributions are invested based on participant-directed investment programs.

Investment Options – Participants' accounts are self-directed within a limited number of investment options offered by the Plan. Participants may change their investment elections at their discretion.

Vesting – Participants' contributions, the employer match contributions, and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Payment of Benefits – Participants or their beneficiaries may receive distributions of their account balances in a lump sum upon the earlier of reaching age 59 1/2, permanent disability, death, or termination of service, as defined in the Plan. Further, the trustee may permit a participant who experiences a qualified financial hardship, as defined by the Plan, to receive a distribution of all or a portion of the participant's elective account balance.

Notes Receivable from Participants – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate determined to be reasonable based upon similar loans offered by other lenders. Principal and interest are paid through payroll deductions.

3. Related Party and Party-In-Interest Transactions

Certain Plan investments are managed by Principal Trust Company or its affiliates, and therefore, these transactions are considered to be party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. The Plan uses the staff, resources, and facilities of the Plan Sponsor to perform certain administrative activities related to the Plan. These transactions qualify as party-in-interest transactions. Participant notes receivable are classified as both related party and party-in-interest transactions.

4. Tax Status

The Pre-Approved Plan obtained its latest opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Certification of Financial Information

The following information included in the accompanying financial statements and supplementary schedule as of December 31, 2024 and for the period from September 1, 2024 to December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, the trustee of the Plan: investments, notes receivable from participants, interest and dividends, and net appreciation in fair value of investments.

7. Non-Participating Participant Account Balances

Included in the net assets available for benefits at December 31, 2024 are balances due to participants who had terminated employment with the employer, and are no longer participating. These accounts are payable on request.

8. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable input (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets, 2) quoted prices for identical or similar assets or liabilities in inactive markets, 3) inputs other than quoted prices that are observable for the asset or liability, 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Pooled Separate Accounts: Investments in shares of pooled separate accounts held with an insurance company are stated at estimated fair market value and are valued by the insurance company based on the net asset value of shares held by the Plan at year end. The net asset value is determined by the insurance company based on the market value of the underlying investments held in the pooled fund.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Fully Benefit-Responsive Annuity Contract

The Plan entered into a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal Life). The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. As of December 31, 2024, the contract value of the fully benefit-responsive investment contract was \$1,065,333.

The traditional investment contract held by the plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or a merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the contract issuers and with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of a material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.
