Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Pre-Paid Legal Services, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained a certification from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C)



Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of PPLSI the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the financial statements.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

1. Description of the Plan

The following description of the PPLSI 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document or summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on January 1, 1988, and subsequently amended, for the benefit of the employees of Pre-Paid Legal Services, Inc. and its subsidiaries (dba LegalShield) and EAP, Inc. (dba CLC), collectively hereinafter referred to as the “Company”. The Plan is a safe harbor plan which is administered by a committee (the “Committee”) of four employees appointed by the Company. Effective November 8, 2021, the Plan was amended to modify the definition of eligible employees to exclude those who became employees due to the acquisition of the assets of Yourself.online and recognize prior service with Yourself.online for purposes of eligibility and vesting for those employed as of the date of acquisition.

The Plan covers certain employees of the Company and employees of affiliated companies which are included in the Company’s consolidated tax return. The Plan contains an automatic enrollment feature by which eligible employees at least 21 year of age and who have completed 90 days of service are enrolled in the Plan, with a portion of their eligible contribution automatically withheld and contributed. Automatic deferrals begin at 1% of eligible compensation, and escalate by an additional 1% yearly, up to a maximum of 4%. Employees wishing to defer a different amount or to opt out of participation in the Plan may do so by completing a salary deferral agreement.

Enrolled employees must complete 1 year of service to be eligible for matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Changes to the Plan

Effective January 1, 2022 (per a Plan amendment adopted in November 2021), the Plan name changed from LegalShield 401(k) Plan to PPLSI 401(k) Plan. Additionally, the Plan was amended April 25, 2023, to meet the SECURE Act requirements, with the amendment applied retroactively effective January 1, 2021.

Contributions

The Plan allows participants to contribute from 1% up to the lesser of Internal Revenue Service (“IRS”) limitation in any Plan year or 80% of compensation. Participants reaching age 50 by the end of the calendar year may also make an additional catch-up contribution up to IRS limits for the plan year. Participants may also make rollover contributions. Participant contributions can be made to the Plan on a pre-tax and Roth basis. All investments of contributions are participant-directed.

The Company makes safe harbor matching contributions equal to 100% of each participant’s elective deferrals that do not exceed 6% of their compensation. See Note 8 for discussion of the annual true-up of the safe harbor match. The Company may also make discretionary additional matching contributions and discretionary non-elective contributions. Such discretionary non-elective contributions will be allocated to participants on a pro-rata basis based on each participant’s compensation as a percentage of total compensation of all participants eligible to share in the contribution.

1. Description of the Plan (continued)

Participant Accounts

Separate accounts are maintained for each participant in the Plan. Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, Company discretionary contributions (if any), an allocation of Plan earnings, and is charged with any benefit payments and an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their own and Company safe-harbor and additional matching contributions. Participants become vested in Company non-elective discretionary contributions ratably (20% per year) over a five year period beginning after 1 year of service. Prior to January 1, 2017, participants were fully vested in their own contributions but vested in any Company contributions ratably (20% per year) over a five year period beginning after 1 year of service. This vesting schedule remains intact for Company contributions received prior to January 1, 2017.

Forfeited Accounts

Upon termination of a participant's employment with the Company, the nonvested portion of their participant account is forfeited. Plan provisions provide that forfeitures may be used to pay Plan expenses or reduce Company non-elective contributions. At December 31, 2024, there was no unallocated forfeitures. Forfeitures were not used during the 2024 Plan year to pay Plan recordkeeping expenses.

Notes Receivable from Participants

Participants may typically borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are permitted for any general purpose and are treated as directed investments. One outstanding loan is permitted per participant. Loan provisions typically require at least quarterly payments over a term no greater than five years, unless the loan is taken for the purchase of a primary residence. The loans are secured by the balance in the participant's account. The loans bear interest at a rate set by reference to the bank prime rate plus 1%, as declared quarterly. Current outstanding loans have interest rates of 5.25% to 10.5%. Principal and interest are paid ratably through payroll deductions.

Interest income is recorded on the balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024. At December 31, 2024, outstanding loans to participants amounted to \$811,048.

In certain circumstances as defined by the Plan, a loan that is in default may be deemed to be a distribution to the participant. Deemed distributions amounted to \$62,048 for the year ended December 31, 2024.

1. Description of the Plan (continued)

Notes Receivable from Participants

Upon termination of a participant's employment with the Company, the participant may elect to have the vested benefit distributed as soon as administratively feasible following such termination of employment. A participant may elect to receive a distribution as a single lump sum payment, ad-hoc payments, or in installment payments. If the value of the participant's vested benefit does not exceed \$5,000, then it is automatically rolled over to an IRA unless the participant makes a different election. Benefits are recorded when paid. There were no distributions requested in 2024 which were not paid until 2025.

Administrative Expenses

The Company may elect to pay costs associated with administering the Plan although it is not obligated to do so. Any expenses not paid by the Company are to be paid by the Plan. The Company paid \$20,000 in trustee administrative fees during 2024, for expenses including administration, mailers and disclosures, recordkeeping fees, and trust and custody fees. Expenses that are paid by the Company are excluded from these financial statements. During 2024, the Plan and Plan participants paid \$71,534 for transaction, loan administrative, maintenance, and other trustee fees.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates and Uncertainties

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date, and interest income is recorded on the accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. Corrective distributions payable generally represent the distribution of certain assets to employees in order for the Plan to comply with nondiscrimination rules.

3. Investments

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$3,562,872. Dividends reinvested into the Plan were \$1,714,185 over the same period.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted observable quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Basis of Fair Value Measurement

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Inputs to the valuation methodology include observable inputs other than quoted active market prices, including quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, and inputs derived principally from or corroborated by observable market data by correlation or other means;
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

1. Mutual Funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
2. Common Collective Trusts: Valued utilizing the net asset valuation as a practical expedient. Fair value is measured at the NAV per unit based on the fair value of the underlying investments using information reported by the investment advisor.

5. Tax Status

The Company adopted a Prototype Non-standardized Profit Sharing Plan with CODA sponsored by The Prudential Insurance Company of America. The Internal Revenue Service has determined and informed the sponsor by a favorable opinion letter dated April 29, 2014, that Prototype Plan is designed in accordance with the applicable sections of the Internal Revenue Code (the "Code"). This opinion letter is being relied upon by the Plan. The Plan has been amended since receiving the opinion letter. However, the Company and Committee believe that the Plan is designed and being operated in compliance with the applicable requirements of the Code and, therefore, believe the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Amendments and Termination

The Company may amend the Plan at any time, including amendments to conform to the Internal Revenue Code, Treasury Regulations and Rulings thereunder. Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Upon termination or permanent suspension of contributions, the accounts of all participants will become 100% vested and will be distributed.

7. Information Certified by the Trustee

Newport Trust Company was the trustee of the Plan for the period January 1, 2022, to December 31, 2024. The plan administrator has elected the method of annual reporting compliance permitted by 29 CFP 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustees certified that the following data (for their respective years of coverage) included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024.
- Net investment activity and interest income on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the footnotes and supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year), as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

8. Compliance Testing

Per Internal Revenue Service (“IRS”) regulations, the Plan must perform compliance testing comparing the contributions made by and for highly compensated employees (“HCEs”) (as defined by the IRS) to those made by and for non-highly compensated employees (as defined by the IRS) to ensure the Plan does not disproportionately benefit the HCEs. The compliance testing was passed for the 2024 Plan year.

As part of compliance testing procedures, the company and third party administrator determined the additional employer contributions necessary to true-up the safe harbor matching contributions based on annual compensation. The true-up contributions necessary for the 2024 Plan year totaled \$22. This is reflected within other employer contributions receivable on the accompanying financial statements.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

10. Related Party Transactions & Transactions with Parties of Interest

All Plan investments as of December 31, 2024, are held within mutual funds and a common collective trust fund that are issued or managed by the Trustee or an affiliate thereof.

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. No such officer or employee receives compensation from the Plan. Also, the Plan Administrator representative and all of the Plan Committee members are currently participants in the PPLSI 401(k) Plan.

11. Subsequent Events

The Company has evaluated all events subsequent to the balance sheet date of December 31, 2024, through October 13, 2025, the date the financial statements were issued, and determined there were no events requiring additional disclosure.
