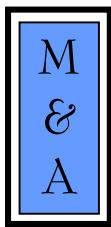

Qualified Opinion

We have audited the financial statements of Holy Cross Electric Association, Inc. Medical and Dental Benefits Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), which comprise the statements of net assets available for benefits and plan benefit obligation as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, except for the omission of the information described in the *Basis for Qualified Opinion* section of our report, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years ended in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Basis for Qualified Opinion

As discussed in Note 2.E to the financial statements, the required actuarial present value of the Plan's benefit obligation was not available for the years ended December 31, 2024 and 2023. We have reviewed the procedures applied in valuing the benefit obligation and have inspected the underlying documentation. In our opinion, those procedures are not adequate to determine the actuarial present value of the Plan's benefit obligation in conformity with U.S. GAAP. The effect on the financial statements of not applying adequate procedures to determine the fair value of the benefit obligation is not determinable.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("U.S. GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued

1. Description of the Plan

The following description of Holy Cross Electric Association, Inc. Medical and Dental Benefits Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

A. General

The Plan provides medical and dental benefits to eligible current and former employees and eligible Directors of the plan sponsor, Holy Cross Electric Association, Inc. (the “Corporation”), a Colorado non-profit corporation which does business under the trade name Holy Cross Energy. The Plan, which was established by the Corporation on July 1, 1983, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan’s Trustees, who are appointed by the Corporation, are also employees of the Corporation and participants in the Plan.

B. Benefits

The Plan provides medical, dental, and prescription drugs benefits for active and eligible retired employees of the Corporation, retired Directors, and their dependents. Coverage for eligible retired employees and Directors extends one year for every three years of service with the Corporation, or until eligible for Medicare benefits. An unlimited maximum annual benefit per covered individual is available under the Plan. Plan benefits terminate at the date the participant ceases to be eligible for coverage, dies, or the Plan is terminated; whichever occurs earlier.

C. Contributions

The Plan is funded by contributions from the Corporation and participants. For 2024 and 2023, participant contributions under the traditional PPO plan were calculated at 10% of estimated premiums. Effective January 1, 2020, the Plan added a high deductible health plan as an alternative option to the traditional PPO. For 2024, participant contributions under the high deductible health plan were calculated at 7.03% of estimated premiums for employee-only (2023 – 8.09%), 6.97% of estimated premiums for employee-plus-one (2023 – 8.02%), and 7.19% of estimated premiums for family plans (2023 – 8.05%).

D. Contributions

The Corporation has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, remaining net assets (after payment of outstanding Plan claims) may be distributed to the Corporation and the Corporation would assume any liabilities.

2. Summary of Significant Accounting Policies

A. Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting which recognizes revenues (increases in net assets) when earned, and expenses (decreases in net assets) when incurred.

B. Cash and Cash Equivalents

The Plan considers all non-interest bearing checking accounts to be cash equivalents for the purpose of the Statement of Cash Flows, since all such funds are highly liquid.

Interest-bearing checking, savings and money market accounts, as well as certificates of deposit held for investment that are not debt instruments and with original maturities of greater than 90 days when purchased are reported as "Investments – Other" in these financial statements.

C. Investments

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

D. Receivables and Allowance for Credit Losses

The Plan utilizes the allowance method of recognizing uncollectible amounts, whereby an allowance for possible future uncollectibility of accounts receivable is established when collectibility becomes doubtful. No such allowance was required at December 31, 2024 and 2023, as all receivables were considered to be collectible.

E. Plan Benefit Obligations

Generally accepted accounting principles require the Plan to report the actuarial present value of the following benefit obligations: claims payable, claims incurred but not reported, and premiums payable to insurance companies. In the Plan's financial statements, claims incurred but not reported include only those claims reported between the Plan's year-end and the date the financial statements were prepared. An actuarial study – which would estimate the amount of claims incurred during the Plan year but not reported for periods extending beyond the date of the financial statements – was not available at December 31, 2024 and 2023; therefore, the amount of the Plan's benefit obligation may be understated.

F. Income Taxes

The trust established under the Plan to hold the Plan's assets is intended to qualify under section 501(c)(9) of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Corporation believes that the Plan, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code granting tax-exempt status to the Plan.

G. Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Actual results could differ from those estimates.

H. Comparative Balances

The financial statements and related notes include certain prior year comparative information. Accordingly, such information should be read in conjunction with the Plan's financial statements as of and for the year ended December 31, 2023, from which these amounts were derived. Certain amounts presented in the prior year data have been reclassified in order to be consistent with the current year's presentation.

I. Subsequent Events

Management has evaluated subsequent events through October 10, 2025; the date these financial statements were available to be issued.

3. Investments - Other

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 – *Fair Value Measurement* – of the Accounting Standards Codification (the "ASC"), issued by the Financial Accounting Standards Board ("FASB"), are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. Investments – Other (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Demand deposits, savings accounts and money market deposits: Measured at the amount payable on demand at the measurement date.

Fixed-maturity certificates of deposit: Valued using the rates currently offered for deposits of similar remaining maturities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Credit Risk and Repurchase Agreement

The Federal Deposit Insurance Corporation ("FDIC") insures up to \$250,000 per depositor at each separately chartered FDIC-member financial institution, without regard to the nature of the accounts. The Plan's uninsured cash balances totaled \$74,807 at December 31, 2024 (2023 – \$47,627).

4. Credit Risk and Repurchase Agreement (continued)

The Plan has entered into a Sweep and Repurchase Agreement with Alpine Bank, under which funds in excess of a specified threshold are invested by Alpine Bank in obligations issued or guaranteed by the United States government or its agencies, with all such invested amounts available to the Plan upon demand (the "Underlying Securities"). At December 31, 2024 and 2023, the Sweep and Repurchase Agreement had a maximum balance of \$2,000,000. Alpine Bank has granted the Plan security interests in the Underlying Securities, but the Underlying Securities are not the property of the Plan. Amounts invested under the terms of the Sweep and Repurchase Agreement are not insured by the FDIC and are not guaranteed by the United States government or its agencies.

Alpine Bank's obligations pursuant to the Sweep and Repurchase Agreement are general obligations secured by the Underlying Securities. Prior to any event of default, the Plan will be paid the repurchase price from the general assets of Alpine Bank rather than from proceeds resulting from the sale of the Underlying Securities. However, in the event of a default, the Plan will be entitled to its ratable portions of the proceeds from the sale of the Underlying Securities in an amount equal to the repurchase price, if sufficient, and the Plan shall become a general, unsecured creditor to Alpine Bank. To the extent that the Plan's ratable share of the proceeds from any sale of the Underlying Securities is not sufficient to cover Alpine Bank's obligation, the deficiency, if any, shall be paid from the general assets of Alpine Bank.

In October 2021, the Plan entered into an Insured Cash Sweep Agreement with Alpine Bank, under which funds from the Plan's operating account are deposited into money market deposit accounts across multiple financial institutions, or members, that participate in the Insured Cash Sweep Network. Because each deposit with participating members in the Insured Cash Sweep Network is less than \$250,000, all amounts deposited under the terms of the Insured Cash Sweep Agreement are fully insured by the FDIC.

5. Excess Loss Insurance Premiums

The excess loss insurance limits the amount of claims to be paid by the Plan to \$90,000 per participant per year for 2024 (\$90,000 – 2023), and to an aggregate of \$4,875,000 per year for 2024 (2023 – \$4,297,000). Claims in excess of the specified and aggregate dollar amount are paid by the insurance.

6. Administration

Effective January 1, 2020, the Plan entered into an agreement with HealthComp Holding Company, LLC and its subsidiary Benefit Administrative Systems, LLC (collectively, "HealthComp") for the administration of the Plan. The agreement has an initial one-year term, and automatically renews for successive one-year terms unless otherwise terminated. HealthComp's responsibilities under the agreement include claims supervision, accounting, and other administrative services. HealthComp's compensation is paid as a monthly fee and is determined using an agreed-upon rate per participant and number of dependents.

Effective midnight of December 31, 2024, the agreement with HealthComp was terminated, due to the Plan transitioning to a fully insured plan. HealthComp will administer the run-out claims for one year beyond the termination date.
