Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Diamond Materials, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from American United Life Insurance Company (AUL) as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

1. DESCRIPTION OF THE PLAN

The following description of the Diamond Materials, LLC 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Diamond Materials, LLC (the Company) who have one year of service and twenty-one years of age or older.

Contributions

Each year, the participants may elect to contribute from 1% to 100% of their annual compensation, subject to deferral limitations under Federal law. The Company makes safe-harbor contributions equal to 100% of the participants' salary deferral contributions that did not exceed 3% of the participants' compensation and 50% of the participants' salary deferral exceeding 3% but not greater than 5% of the participants' compensation. Discretionary amounts determined each year by the Company can also be added to the Plan and allocated among participants as profit sharing or qualified non-elective contributions, subject to allocation and vesting requirements of the Plan. In 2023, the Company made contributions in the amount of \$500,024, net of forfeitures applied.

Participant accounts

Each participant's account is credited with the participant's contributions, allocations of (a) Company contributions and (b) Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, safe-harbor contributions, and actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions is based on years of continuous service. A participant is fully vested after 5 years of service. Participants are 100% vested in special non-elective contributions at the time of contribution.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount. For termination of service due to other reasons, a participant will receive the value of the vested amounts in a lump sum distribution.

Non-terminated employees may receive a hardship distribution for certain qualifying events or circumstances as defined by the Plan.

Participants' notes receivable

The Plan does not permit participant loans.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100 percent vested in their accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value, except for fixed option investments, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Payments of benefits

Benefits are recorded when paid.

Operating expenses

Administrative costs are paid by the Sponsor except for fees for certain transactions initiated by participants which are charged directly to participant accounts.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding deduction from net assets.

Subsequent events

Subsequent events were evaluated through September 5, 2025, the date the financial statements were available to be issued.

3. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

4. INFORMATION PREPARED AND CERTIFIED BY TRUSTEES (UNAUDITED)

As permitted by 29 CFR 2520, 103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Trustee, American United Life Insurance Company (AUL), has certified the following information, which has not been subject to audit by independent auditors, to be complete and accurate:

- Investment balances included in the statements of net assets available for benefits at December 31, 2024, and in the related notes to the financial statements.
- Investment income (loss) included in the statement of changes in net assets available for benefits for the period beginning January 1 through December 31, 2024, and in the notes to the financial statements.
- Information included in the accompanying schedule of assets (held at end of year).

5. TAX STATUS

The Plan obtained its latest determination letter August 19, 2020, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the letter of determination. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

In accordance with ASC 740, Income Taxes, the Plan has evaluated all uncertain tax positions and deems that more likely than not, all positions taken will be sustained under examination. Positions taken prior to 2021 are no longer subject to examination. The Plan recognizes interest accrued related to unrecognized income tax benefits in interest expense and penalties in administrative expense. No such interest or penalties were recognized during 2024. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

6. FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

Investments held by the Plan are included in a group annuity contract. Investments within the contract consist of mutual funds and a fixed option investment, in pooled separate accounts (sub-accounts). Investments are participant directed.

Under the terms of the contract, participant-initiated transactions for the purpose of receiving benefits allowed under the plan, such as retirement, death, hardship, loan, required minimum distribution, allowable in-service withdrawals, are completed at contract value without conditions, limits, or restrictions. Benefits related to termination of employment receive the same treatment unless a termination is associated with a full or partial plan termination, the insolvency of the plan sponsor, or aggregate terminations in any contract year exceed 20 percent of the full contract value as determined on the first day of that contract year. Under those unlikely events, the provisions related to full contract termination may apply. Plan management believes that the occurrence of such events is not probable.

7. FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts - The fair value of the mutual funds included in the underlying assets is used to determine the net asset value (NAV) of the account. In accordance with ASU Update 2018-09, investments with readily determined fair values are not considered to be valued using the NAV practical expedient.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.
