In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Monarch 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Monarch 403(b) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

December 31, 2024 and 2023

### (1) Plan Description

The following description of Monarch (the "Company") 403(b) Plan provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan covering all eligible employees of the Company who have attained age eighteen. In order to be eligible for matching contributions, employees must complete one year of service as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### (b) Contributions

Participants may elect to make contributions up to \$23,000 of their eligible compensation, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan and may change their investment options at any time. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a deferral rate set at 1% of their eligible compensation, unless they elect not to participate in the Plan. In addition, the Company may make a discretionary matching contribution each year, to be determined by the board of directors. This matching Company contribution is allocated to the participant account using the current investment direction. Contributions are subject to certain limitations. The Company elected a matching contribution for the 2024 plan year. The Company did not elect a matching contribution for the 2023 plan year.

#### (c) Participant Accounts

Each participant's account is credited with the participant's contribution, the matching Company's contribution, and Plan earnings. Each participant's account is also charged with an allocation of investment expenses. Allocation of the Plan earnings is based upon actual earnings of the investments. The benefit to which a participant is entitled is the benefit from the vested participant's account.

#### (d) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in the Company's contributions plus actual earnings thereon according to the following table:

If a participant dies or becomes disabled while still employed by the Company, their entire Plan interest becomes 100% vested.

#### (e) Notes Receivable From Participants

Participants are permitted by the Plan to borrow from their vested account balance up to the lesser of 50% or \$50,000. The minimum amount which may be borrowed is \$1,000. Loan transactions are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the trustees. Interest rates currently range from 4.25% to 9.50%. Principal and interest are paid ratably through bi-weekly payroll deductions.

#### (f) Payment of Benefits

Upon separation of service, due to termination of employment, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account balance or payments under a variety of installment options. Distributions are subject to the applicable provisions of the Plan agreement.

#### (g) Forfeited Nonvested Accounts

Forfeited nonvested participants accounts as of December 31, 2024, were \$4,930. There were no forfeited nonvested participant accounts as of December 31, 2023. The Plan allows for forfeitures to first pay for the Plan expenses. Any remaining forfeitures will be used to reduce future Company contributions.

#### (h) Expenses of Plan

Administrative fees are paid by both the Company and the Plan.

#### (1) Plan Description, Continued

##### (i) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' balances will be distributed in accordance with the Plan document.

#### (2) Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

##### (a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### (b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

##### (c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors, custodians and trust company. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### (2) Summary of Significant Accounting Policies, Continued

##### (d) Payment of Benefits

Benefit claims are recorded as expense when they have been approved for payment and paid by the Plan. There were no benefits payable at December 31, 2024 and 2023.

##### (e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### (f) Certified Investments

Certain information related to investments and notes receivable disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information supplied to the plan administrator and certified as complete and accurate by American Trust Company (“American Trust”).

#### (3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. These are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These investments are deemed to be actively traded.

*Money market:* Valued as cash and cash equivalents.

#### **(4) Related Party Transactions**

At December 31, 2024 and 2023, plan assets included investments in funds managed by American Trust. American Trust is the current custodian of the plan, and as such, transactions with the custodian qualify as party-in interest transactions under ERISA. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### **(5) Tax Status**

Effective January 1, 2017, the Plan adopted a volume submitter plan sponsored by BB&T. These volume submitter plans have received an opinion from the Internal Revenue Service as to the Plan's qualified status dated July 24, 2017. The volume submitter plan opinion letter has been relied upon by this Plan. The plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(6) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

#### **(7) Subsequent Events**

The Company has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued. There were no significant events identified which require disclosure in the financial statements or footnotes.
