## REPORT OF INDEPENDENT AUDITOR

TO THE TRUSTEES AND PARTICIPANTS OF  
ALLEGHENY BRADFORD 401 (K) RETIREMENT PLAN

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

I have performed audits of the financial statements of the Allegheny Bradford 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In my opinion, based on my audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

I conducted my audits in accordance with auditing standards generally accepted in the United States of America (GAAS). My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of my report. I am required to be independent of the Plan and to meet my other ethical responsibilities, in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for at least one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of my report, my objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, I

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

My audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that I identified during the audit.

**Other Matter - Supplemental Schedule Required by ERISA**

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF PLAN

The Allegheny Bradford 401(k) Retirement Plan (the Plan) was established effective January 1, 1997 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code. The Plan is a defined contribution pension plan established to cover employees of Allegheny Bradford Corporation and ABC Actini, LLC (the Employers or the Plan Sponsor).

The following description of the Plan provisions only provides general information. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

#### PARTICIPATION

All employees of the Plan Sponsor who have completed 90 days of service, are eligible for participation in the Plan. Plan entry dates are the first day of each month.

#### CONTRIBUTIONS

Participants may elect to defer a specified percentage of compensation, not to exceed Internal Revenue Code limitations. Participants may also make after-tax Roth elective contributions.

Through 2023, the Plan Sponsor withheld 4% of compensation for any new or rehired participants, unless the participant affirmatively elected a different percentage. On January 1, 2024, any participants not deferring at least 6% were automatically enrolled at 6%, unless an alternate election was made. This 6% automatic enrollment applies to any new or rehired participants after this date. In addition, any participants automatically enrolled on or after January 1, 2024 will be automatically increased by 1% on January 1<sup>st</sup> of each Plan year, up to a maximum of 10%.

The Plan Sponsor makes matching contributions in an amount equal to 50% of an employee's elective deferral contribution, disregarding any elective deferral contribution in excess of 4% of the employee's compensation.

## NOTES TO FINANCIAL STATEMENTS (CONTINUED)

### 1. DESCRIPTION OF PLAN (CONTINUED)

#### VESTING

Participant elective deferral contributions are 100 percent vested upon contribution. The participant's vesting percentage in matching contributions is shown in the following schedule:

#### FORFEITURES

Participants who leave the Plan Sponsor with less than three years of service forfeit the nonvested portion of the matching contributions. Forfeitures will be used to reduce future matching contributions. Approximately \$11,800 and \$7,400 of forfeitures were used to offset employer contributions during 2024 and 2023, respectively. There were no unutilized forfeitures as of December 31, 2024.

#### PLAN TERMINATION

The Plan Sponsor intends to continue the Plan indefinitely, but reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination, participants will become fully vested in their accrued benefits.

### 2. SIGNIFICANT ACCOUNTING POLICIES

#### BASIS OF ACCOUNTING

The accounting records are maintained on the accrual basis.

#### VALUATION OF INVESTMENTS

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

### 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants for contributions in excess of the amounts allowed by the IRS are recorded as a liability with a corresponding increase in distributions. The plan distributed the 2024 and 2023 excess contributions to the applicable participants in 2025 and 2024.

#### USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts and disclosures reported in the financial statements. Actual results may differ from management's estimates and assumptions.

#### SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through the audit report date, the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 *Fair Value Measurements* (ASC 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The financial instruments' fair value measurement level is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 - Other significant observable inputs (including quoted prices in active markets for similar financial instruments), or other inputs that are observable or can be corroborated by observable market data.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### 3. FAIR VALUE MEASUREMENTS (CONTINUED)

- Pooled separate accounts – The Plan's units of participation are valued using net asset value as a practical expedient, as reported by the investment manager. These net asset values generally represent amounts at which units are redeemed on a regular basis.
- Registered investment companies – Fair value is based on quoted net asset values of the shares held by the Plan.
- Common collective trust – The plan's units of participation are valued using net asset value as a practical expedient, as reported by the fund manager. The net asset value generally represents the amount at which units are redeemed on a regular basis.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 4. INVESTMENTS

All investment information disclosed in the accompanying financial statements and schedule, including investments held at December 31, 2024 and 2023, and net investment gain (loss) from pooled separate accounts, common collective trust & registered investment companies, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan (qualified institutions).

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 5. CONTRACT WITH INSURANCE COMPANY

Certain of the Plan's assets are maintained under contract with Principal Life Insurance Company (Principal). Under the terms of this contract, certain investments may be subject to withdrawal restrictions.

The guaranteed interest accounts were non-fully benefit responsive as withdrawals prior to maturity for events other than death, disability, termination or retirement may be subject to a surrender charge. As such, these investment contracts were recorded at fair value. Starting in 2019, no new deposits were made to this investment option. The final contracts matured December 31, 2022 and were sold in January 2023.

### 5. CONTRACT WITH INSURANCE COMPANY (CONTINUED)

The Principal Stable Value Fund (the "Trust") is a common collective trust which invests primarily in investment contracts offered by insurance companies and commercial banks. At December 31, 2024, there were no unfunded commitments related to these investments and units could be redeemed on a daily basis. Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, could limit the Plan's ability to transact at net asset value with the Trust. Starting in 2025, the Plan replaced the Principal Stable Value Fund as an investment option for stability of principal. Plan-level transfers from the Trust could be subject to a 12-month hold period. During July 2025, the Plan notified the Trust of its intent to withdraw all funds from the Trust and balances will be transferred in July 2026. Plan participants may still transact with the Trust at net asset value.

While the contract allows Principal to defer payment of withdrawals from certain separate account investment options (generally up to 270 days), no such restrictions were implemented at December 31, 2024. At December 31, 2024, there were no unfunded commitments related to these investments and units could be redeemed on a daily basis.

### 6. PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan's investments are held in pooled separate accounts and a common collective trust managed by the Principal Life Insurance Company, one of the custodians of the Plan. Therefore, these transactions and account balances qualify as party-in-interest.

Fees incurred by the plan for investment advisory, administration, and recordkeeping services are reimbursed indirectly through revenue sharing from the underlying Plan investments. These costs are not reflected separately, but are included in the net investment return of these investments.

If revenue sharing is not sufficient to cover the cost of such services, the amounts will be allocated against participant accounts. Expenses of approximately \$6,500 and \$5,800 were allocated against participant accounts in 2024 and 2023, respectively.

Other direct expenses paid from Plan assets consist of benefit processing fees and early withdrawal fees. Any other costs of plan administration are paid by the Plan Sponsor.

### 7. TAX STATUS

The Plan has received an opinion letter from the Internal Revenue Service dated July 13, 2021, stating that the written form of the underlying pre-approved document is qualified under Section 401(a) of the Internal Revenue Code (the "Code"), and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. Therefore, the related trust is exempt from taxation. Subsequent to the issuance of this opinion letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator has indicated that it will take the necessary steps to maintain the Plan's qualified status.

The Plan Sponsor has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes it is no longer subject to tax examinations for reporting years prior to 2021.
