We have performed audits of the financial statements of the Tenable, Inc. 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## **Notes to the Financial Statements**

### **1. Description of the Plan**

The following description of the Tenable, Inc. 401(k) Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement and any amendments thereto for a more complete description of the Plan's provisions.

#### ***General***

Effective January 1, 2006, Tenable, Inc. established the Plan as a defined contribution plan covering substantially all employees of Tenable, Inc. and Tenable Public Sector, LLC (collectively, the Company) who are age 18 or older. Employees who are covered by a collective bargaining agreement, leased employees, and nonresident aliens are excluded from plan participation. Interns, part-time employees and temporary employees are eligible if they have attained age 21 and have completed 1,000 hours of service with the Company. Eligible employees may enroll in the Plan on the first day of each month immediately following their date of hire. The Plan was most recently amended and restated on March 23, 2022, pursuant to the provisions of Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan was amended on March 7, 2024, to allow for a plan merger of the portion of ADP TotalSource Retirement Savings Plan, a multi-employer plan, attributable to the employees of Ermetic Inc. (Ermetic Inc. Retirement Plan) effective May 15, 2024. Plan assets of Ermetic Inc. Retirement Plan totaling \$287,579 were merged into the Plan on May 23, 2024.

#### ***Trustee, Custodian, and Administration of the Plan***

The trustee and custodian of the Plan is Fidelity Management Trust Company, LLC (FMTC). The recordkeeper of the Plan is Fidelity Workplace Services, LLC, for which FMTC served as Trustee (collectively, Fidelity). The administrator of the Plan is the Company. Fidelity holds all assets of the Plan in accordance with the service provider contract with the Company. The Company's Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### ***Contributions***

Participating employees may elect to make before or after-tax contributions to the Plan from 1% to 86% of pretax compensation as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to 100% of eligible compensation. The Plan also allows for Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

## **Tenable, Inc. 401(k) Plan and Trust**

### **Notes to the Financial Statements**

The Plan provides for a Safe Harbor Employer matching contribution whereby the Company makes a 100% vested, dollar-for-dollar matching contribution for all participating employees on the first 4% of each employee's eligible compensation. The Company may make additional voluntary discretionary profit-sharing contributions to all participants who are employed on the last of the year; however, no such contributions were made for 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### ***Participant Accounts***

Contributions made to the Plan and earnings thereon are maintained in separate accounts for each participant. Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, and the Company's matching contributions, as well as allocations of the Company's profit-sharing contributions, if any, and Plan earnings.

Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their voluntary contributions, rollover contributions and Safe Harbor matching contributions, plus actual earnings thereon. Vesting in the employer's profit-sharing contributions is ratable over four years of service with the Company.

#### ***Forfeitures***

Participants terminating employment before they are fully vested forfeit the nonvested portion of their accounts. Forfeitures may be used to pay administrative expenses of the Plan or may be applied to reduce the amount of future employer contributions. For the year ended December 31, 2024, the Plan applied forfeitures of \$59,140 to reduce employer contributions.

As of December 31, 2024 and 2023, unused and unallocated forfeitures available to reduce future employer contributions or pay Plan expenses totaled \$1,043 and \$33,836 respectively.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance, or \$50,000 reduced by the highest outstanding balance of any prior loans from the Plan during the prior one-year period. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. All notes are payable within

five years unless the note was made to purchase a principal residence, in which case the note may be repaid over a period not to exceed ten years. Principal and interest payments are made ratably through semi-monthly payroll deductions. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC. Each participant may not have more than one loan outstanding at any time.

### ***Payment of Benefits***

Amounts credited to an individual participant's account are eligible for distribution upon termination of employment, retirement, death, or disability, generally as a lump sum.

In certain hardship situations, as described by the Plan, participants may withdraw part of their account balances while actively employed. The hardship withdrawal may be subject to a 10% excise tax imposed by the IRC and a minimum of \$500 must be withdrawn.

A qualified reservist distribution from the Plan is available to a person who, because he or she is a member of a reserve component, was ordered or called to active duty for more than 179 days (or for an indefinite period), and the qualified reservist distribution was made during the period that began or begins on the date of the order or call to duty and ended or ends at the close of the active-duty period.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$7,000, their vested balance may be automatically rolled into an IRA unless otherwise elected.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

### ***Revenue Credits***

The Plan's trust agreement with Fidelity provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds. Unallocated revenue credits at December 31, 2024 and 2023 were \$43,768 and \$18,363, respectively. During 2024, the Plan received credits of approximately \$25,405, of which \$0 was used to pay administrative expenses. Administrative expenses are presented net of revenue credits in the statement of changes in net assets available for benefits.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from the estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). See Note 4 for additional information related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at the unpaid principal balances plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to their fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Mutual funds represent investments with various investment managers. The fair value of these investments is determined by reference to the fund's underlying assets, which are principally marketable securities and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at net asset value (NAV).

*Collective Trust Funds:* Valued at NAV per unit. Units of each fee class of each Fund are valued each day on which the New York Stock Exchange (NYSE) is open for trading in accordance with the valuation procedures established by the Trustee. The NAV per unit is calculated as of the close of trading on the NYSE each day. The NAV per unit is computed by dividing the total fair value of the assets of a Fund, less its liabilities, by the total number of units outstanding at the time of such computation. There are no unfunded commitments associated with these collective trust funds and they are direct filing entities.

The preceding methods described, may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and/or terminate the Plan subject to the applicable provisions of ERISA. In the event of Plan termination, participants would be 100% vested in their employer contributions.

### 6. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Fidelity or its subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Fidelity by participants. The Plan also receives revenue credits from Fidelity. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 1, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### **7. Income Tax Status**

Effective March 23, 2022, the Plan adopted the Non-Standardized Pre-Approved Profit-Sharing Plan with CODA (Pre-Approved Plan) established by Fidelity Management & Research Company. The IRS ruled on June 30, 2020, that the Pre-Approved Plan, including related amendments, as designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes the Plan is currently designed and is being operated in accordance with the IRC.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### **9. Operational Compliance**

During the year ended December 31, 2024, the Plan received a transfer of assets from Ermetic Inc. Retirement Plan. Certain transferred contributions were not initially mapped to the proper contribution source. The Plan sponsor, in coordination with the recordkeeper, has reclassified the affected participants and implemented procedures to prevent recurrence. This matter did not materially impact participant's account balances or the Plan's financial statements.

### **10. Subsequent Events**

Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements except as noted below.

The Plan was amended on May 8, 2025, to allow for a plan merger a of the portion of TriNet 401(k) Plan, a multi-employer plan, attributable to the employees of Vulcan Cyber Inc. (Vulcan Cyber Inc. Retirement Plan) effective June 15, 2025. Plan assets of Vulcan Cyber Inc. Retirement Plan, totaling \$550,560, were merged into the Plan on July 2, 2025.
