## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Copeland, Cook, Taylor and Bush, P.A. Salary Reduction Plan  
Ridgeland, Mississippi

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Copeland, Cook, Taylor and Bush, P.A. Salary Reduction Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Copeland, Cook, Taylor and Bush, P.A. Salary Reduction Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

**Note 1: Description of Plan**

The following description of the Copeland, Cook, Taylor and Bush, P. A. (“Firm”) Salary Reduction Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan covering all employees of the Firm who have completed one year of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

b. Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan and not to exceed IRS limits. Voluntary after-tax contributions are also allowed. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Firm contributes 100% of the first 4% of compensation that a participant contributes to the Plan. Contributions are subject to certain statutory limitations.

c. Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Firm’s matching contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

d. Vesting

Participants are immediately vested in their voluntary contributions and employer contributions plus actual earnings thereon.

e. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to 50% of their vested account balance. The total amount a participant may have outstanding during any 12-month period may not exceed \$50,000. The loans are secured by the balance in the participant’s account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

f. Payment of Benefits

Upon termination of employment, if a participant’s vested interest in their account exceeds \$5,000, no distribution will be made to the participant before they reach the age of normal retirement or receipt of consent to pay out by the participant and their spouse, if applicable. If a participant’s vested account is less than \$5,000, the vested account balance is paid out in the form of a lump sum distribution or may be rolled over to an individual retirement arrangement designated by the Plan Administrator.

**Note 2: Summary of Significant Accounting Policies**

a. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting modified by the recognition of unrealized gains and losses on asset values at year end and by the recognition of the payment of benefits as a reduction in net assets when they are disbursed to the participants.

b. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America with the Department of labor's Rules and Regulations for Reporting and Disclosure under ERISA requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during reporting period. Significant estimates included the valuation of the Plan's investments. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Investments in common/collective trust funds are an indirect investment in a fully benefit responsive investment. The common/collective trust is valued using Net Asset Value (NAV) as a practical expedient and is recorded at the Plan's proportionate share of the contract value as determined by the fund manager.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Cash surrender value of life insurance is valued at the cash surrender value as reported by the issuer of the policy. Management has identified that the Plan's life insurance contract was not explicitly included as a permitted investment in the most recent restated Plan document. The Plan Sponsor has initiated a corrective retroactive amendment to include this provision, consistent with past plan operations. No impact to the Plan's financial statements has been identified.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

Loan repayments are generally made through payroll deductions and are applied first to interest and then to principal. Delinquent participant loans are evaluated in accordance with the terms of the Plan and the requirements of the Internal Revenue Code Section 72(p). Loans that are not repaid in accordance with their terms are considered in default and are treated as deemed distributions based on the applicable regulatory guidance.

During the audit, it was noted that two participant loan repayments were not initiated through payroll deduction at the time of loan origination. The plan administrator reviewed the affected loans, and, in October 2025, remitted the missed repayments and related lost earnings to the impact participant

accounts in accordance with the Department of Labor's Voluntary Fiduciary Correction Program (VFCP) guidance. The total amount of lost earnings contributed was not material to the Plan's financial statements.

The plan administrator periodically reviews participant loans for compliance with repayment terms and timely remittance of payroll deductions. Corrections for identified repayment delays or administrative errors are made in accordance with the Department of Labor Voluntary Fiduciary Correction Program (VFCP) guidance, which may include the calculation and remittance of lost earnings to participant accounts.

Two participant loans related to employees who terminated employment prior to the Plan's year-end were not treated as deemed distributions at the time of termination, as required by the Plan document and Internal Revenue Code Section 72(p). The Plan Sponsor evaluated these loans and, in October 2025, processed them as deemed distributions then issued the related Forms 1099-R for the appropriate tax year. These corrections did not have a material effect on the Plan's financial statements.

e. Payment of Benefits

Benefits are recorded when paid.

f. Terminated Participants Accounts

Vested account balances of terminated plan participants totaled \$4,005,185 and \$4,102,913 as of December 31, 2024 and 2023, respectively.

g. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Firm and are therefore excluded from these financial statements. Investment-related expenses are included in administrative expenses.

**Note 3: Tax Status**

The Internal Revenue Service has determined and informed the Firm by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving this determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities: however, there are currently no audits for any tax periods in progress.

**Note 4: Plan Termination**

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Firm may determine.

**Note 5: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 6: Information Certified by the Plan Trustee**

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$18,560,844 and \$17,890,294 at December 31, 2024 and 2023, respectively, and related investment income of \$2,525,975 and \$2,576,978 for the years ended December 31, 2024 and 2023, respectively.

**Note 7: Party-in-Interest Transactions**

Certain Plan investments are held in funds managed by Mid Atlantic Trust Company, the trustee, as defined by the Plan, and therefore, qualify as party-in-interest transactions. The Plan's party-in-interest transactions include administrative fees paid to Mid Atlantic Trust Company for the years ended December 31, 2024 and 2023.

**Note 8: Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. Fair value refers to the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants in the market in which the reporting entity transacts. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Investments with readily available active quoted prices or for which fair value can be measured from actively quoted prices will have a higher degree of market observability and a lesser degree of judgment used in measuring fair value. Investments carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 – inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access,

Level 2 – inputs consist of observable market-based inputs or unobservable inputs that are corroborated by market data,

Level 3 – inputs are unobservable and are not corroborated by market data.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily closing price and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 9: SECURE Act 2.0**

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions included both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan documents accordingly. Certain provisions became effective in 2024. There is no material impact to the Plan's 2024 financial statements.

**Note 10: Subsequent Events**

Events that occur after the Statement of Net Assets Available for Benefits date but before the financial statements are available to be issued must be evaluated for recognition or disclosure. The effects of subsequent events that provide evidence about conditions that existed at the Statement of Net Assets Available for Benefits date are recognized in the accompanying financial statements. Subsequent events which provide evidence about conditions that existed after the Statement of Net Assets Available for Benefits date require disclosure in the accompanying notes. Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued and concluded that no subsequent events have occurred that would require recognition in the financial statements.
