Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of BL Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements December 31, 2024 and 2023

Note 1 - Description of Plan

The following description of BL Companies 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) retirement plan established effective January 1, 1996 and most recently amended and restated effective February 18, 2022. Employees of BL Companies, Inc. (the "Company") become eligible on the first day of employment excluding bargaining employees, nonresident aliens or leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

Contributions

Each year, participants may contribute up to 100% of their compensation, subject to certain Internal Revenue Service ("IRS") limitations, as defined in the Plan agreement. Participants may also make post-tax contributions into the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make contributions from other qualified defined benefit or defined contribution plans (rollover).

The Company makes safe harbor matching contributions in an amount equal to 100% of participant elective deferral contributions that are not in excess of 3% of the participant's Plan compensation, plus 50% of participant elective deferral contributions which are in excess of 3% but do not exceed 5% of the participant's Plan compensation. The Company may also make discretionary employer matching contributions, as determined by the Company. The Company did not make discretionary employer matching contributions for the years ended December 31, 2024 and 2023.

Participants direct the investment of their contributions, safe harbor matching contributions and discretionary employer matching contributions, if any, into various investment options offered by the Plan. The Plan currently offers mutual funds, common/collective trust funds and a guaranteed investment contract as investment options for participants.

Participant accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant's earnings, account balances or specific transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions and safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary employer matching contribution is based on years of service, as defined in the Plan agreement. Participants are 25% vested after one year of service, 50% vested after two years of service and 100% vested after three years of service for any discretionary employer matching contributions. However, if an active participant dies or becomes totally and permanently disabled prior to the normal retirement age, the participant's account becomes 100% vested.

Forfeited accounts

Forfeitures result from contributions remaining in the Plan from terminated employees who had nonvested discretionary employer matching amounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1 and \$9, respectively. In 2024 and 2023, Company contributions were reduced by \$17,971 and \$9,896 from forfeited nonvested accounts, respectively.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. A participant may have two loans outstanding at any time. Interest rates are determined by the current federal prime lending rate, plus 1% at the time of the loan upon approval by the Plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of benefits

On termination of employment, retirement, the attainment of age 59½, death, or permanent and total disability, a participant with a vested account balance greater than \$5,000 can choose to receive a lump-sum amount equal to the vested portion of their account, or a direct rollover distribution. A participant with a vested account balance of \$1,000 or less will receive a lump-sum distribution. Participants with a vested account balance between \$1,000 and \$5,000 who do not elect a form of distribution will have their vested balance rolled over to an individual retirement account. Participants may also take hardship distributions from their vested account balances. Distributions are subject to the applicable provisions of the Plan agreement.

Note 2 - Summary of accounting policies

Basis of accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and insurance companies. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and capital gains include the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Discretionary matching contributions from the Company, if any, are recorded in the year in which participants compensation is earned.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income (loss) and interest income on notes receivable from participants for the years then ended, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

Note 4 - Fully benefit-responsive investment contracts

The Plan was invested in the Principal Fixed Income Guaranteed Option Fund ("PFIGO") and Principal Guaranteed Option Fund ("PGO") during 2024. Effective October 10, 2024, the Plan's investment in the PFIGO terminated and assets transferred to the PGO. Both investments are guaranteed investment contracts offered by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal").

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. For the PFIGO, the crediting rate was based on a formula established by the contract issuer but may not be less than .15% or greater than 3%

effective for the year ended December 31, 2023 and for the period from January 1, 2024 through May 30, 2024. Effective June 1, 2024, the crediting rate may not be less than .10% or greater than 3%. Effective October 10, 2024, the amounts held in the PFIGO transferred to PGO. For the PGO, the crediting rate is based on a formula established by the contract issuer but may not be less than .15% or greater than 3% effective October 10, 2024 through December 31, 2024. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code ("IRC") or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

Note 5 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds: Valued at the NAV of units held at year-end. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 6 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 - Related party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds, common/collective trust funds, and a guaranteed investment contract managed by Principal. Principal is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. As described in Note 2, the Plan made a direct payment to the third-party administrator of \$6,378 and \$4,613 during

2024 and 2023, respectively, which was not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations with the exception of loan administration fees and benefit payment transaction fees.

Principal provides certain administrative services to the Plan pursuant to a Service and Expense Agreement ("Agreement") between the Company and Principal Life Insurance Company ("Principal Life"). Principal Life receives revenue from mutual fund and common/collective trust fund service providers for services that are provided to the funds. This revenue is used to offset certain amounts owed to Principal Life for its administrative services to the Plan.

If the revenue received by Principal Life from such mutual fund or collective trust fund service providers exceeds the amount owed under the Agreement, Principal Life remits the excess to the Plan's trust on an annual basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, excess amounts were \$12,943 and \$0, respectively, and allocated to participant accounts. The Plan or Company may make a payment to Principal Life for administrative expenses not covered by revenue sharing.

Note 8 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the discretionary matching employer contribution portion of their accounts.

Note 9 - Tax status

The prototype plan document, which the Plan has adopted in a nonstandardized adoption agreement, obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan's adoption agreement has been amended and restated since receiving the opinion letter on the prototype plan, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
