### Note 1: Description of Plan

The following description of the Shodair Hospital Employees Tax Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all eligible employees of Montana Children's Home and Hospital doing business as Shodair Children's Hospital (the "Employer" or "Hospital"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### Eligibility

Employees are eligible to participate in salary reduction contributions on their first day of employment with the Hospital. Employees are eligible for Employer contributions after they have completed one year of service. A year of service for purposes of eligibility is a period during which the employee has completed 1,000 or more hours of service by the anniversary of their hire date. Employees may enter the Plan for Employer contributions on the first day of January or July coinciding with or following the date they satisfy the Plan's eligibility requirements.

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Hospital may make a discretionary non-elective contribution. For the year ended December 31, 2024, the Hospital contributed 6% of a participant's eligible compensation. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of (a) the Hospital's discretionary non-elective contributions, (b) plan earnings (losses). Participants are charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are fully and immediately vested in all contributions, plus actual earnings (losses) thereon.

#### **Notes Receivable From Participants (Continued)**

Participants may borrow from their fund accounts, a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance of the participant's account and bear interest at rates at prime for loans with Empower Retirement, LLC, 5.5% for ReliaStar fixed contracts, and 8.0% for ReliaStar variable contracts. For loans with Empower Retirement, LLC, principal and interest is paid ratably through payroll deductions over a period not to exceed five years. For loans with ReliaStar, principal and interest is paid by the participant directly to ReliaStar over a period not to exceed five years. Loans can exceed five years only if the proceeds of the loan were used to acquire the participant's residence, in which case the loan will be 20 years. A participant may have no more than three outstanding loans at any one time.

Under the provisions of the CARES Act, the Plan Sponsor allowed loan limits to be increased to \$100,000 or 100% of account balances for loans taken during the 6 months following March 27, 2020. In addition, qualified participants were given the ability to suspend loan payments for the period March 27, 2020 through December 31, 2020.

#### **Payment of Benefits**

Participants may elect to receive a lump-sum amount equal to the value of their vested interest or partial payments from time to time as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

### **Note 2: Summary of Significant Accounting Policies (Continued)**

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable are recorded when a distributable event occurs.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at fair value based on the NAV units as determined by the insurance company. NAV is based on the observable market prices of the underlying assets within the account less liabilities. The NAV for the underlying assets of the account is readily determinable measure of their fair value and is the basis for current transactions.

### Note 4: Fully Benefit-Responsive Investment Contracts (FBRICs)

The Plan entered into fully benefit-responsive guaranteed investment contracts (GIC) with Empower Annuity Insurance Company ("Empower") and ReliaStar Life Insurance Company ("ReliaStar"). Empower and ReliaStar maintain the contributions in general accounts, which are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1% for Empower and varies by participant for ReliaStar Life. Such interest rates are reviewed on a quarterly basis for resetting.

Because the GICs are fully benefit-responsive, contract value is the relevant measure for the GICs. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuers' ability to meet financial obligations. The issuers' ability to meet its contractual obligations may be affected by future economic and regulatory developments.

### **Note 4: Fully Benefit-Responsive Investment Contracts (FBRICs) (Continued)**

A contract provision with Empower that might limit the ability of the Plan to transact at contract value with the issuer states that certain employer-initiated events with respect to the contract assets that are not an election of contract termination will be assessed a market value adjustment. No similar provisions for ReliaStar Life were noted.

The contract with Empower permits the insurance company to terminate the agreement with 75 business days advanced written notice. The contract does not stipulate any event or circumstance that would cause the issuer to terminate and settle at an amount different from contract value.

The contract with ReliaStar Life permits the insurance company to terminate the agreement if the participant to the contract has not made any purchase payments for two full years and monthly benefits are less than \$20 after age 71 or at the end of the 12th contract year, whichever is later.

### **Note 5: Information Prepared and Certified by the Custodians**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, fully benefit-responsive investment contracts, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by ReliaStar, Empower and Empower Trust Company, LLC, the Custodians of the Plan.

### **Note 6: Related-Party Transactions and Party-In-Interest Transactions**

Certain plan investments are managed by ReliaStar, Empower and Empower Trust Company, LLC. ReliaStar, Empower and Empower Trust Company, LLC are the Custodians, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Empower Retirement, LLC is the record-keeper, as defined by the Plan and qualifies as a party-in-interest. Fees incurred and paid by the Plan for administrative expenses were \$26,469 for the year ended December 31, 2024.

Notes receivable from participants qualify as party-in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 7: Tax Status**

The Hospital has adopted a nonstandard pre-approved document with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Plan has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 10: Secure 2.0**

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.
