NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Grupo Alberic Cash or Deferred Income Plan (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, a cash or deferred contribution plan established by Alberic Group and its affiliated entities, as applicable (the "Sponsor") that became effective January 1, 2004, and covers substantially all its employees who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), and structured pursuant to Section 1165 and other applicable sections or subsections of the Puerto Rico Internal Revenue Code of 1994, as amended (PRIRC). Benefits under the Plan are provided by a Trust Fund with individual account balances.

The following corporations that form the Alberic Group are the participating employers:

Alberic Chrysler Jeep Dodge Plymouth, Inc.
Alberic Motors, Corp.
Easeway of Puerto Rico, Inc.
ABAB Corporation
Premium Professional Services, Inc.

Contributions

Each year, participants may contribute up to \$15,000 if pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

Contributions (continued)

Matching employer contributions will be determined on an annual basis upon discretion by the employers. Employers have not made any contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

Payment of Benefits

On termination of service due to termination of employment, death, disability, or retirement, participants receive a lump-sum amount equal to the value of the participants' vested interest in his or her account. Annuities are allowed.

Forfeitures

Forfeitures of contributions other than matching contributions shall be allocated to all participants eligible to share in the allocations by crediting each participant with such pro rata part of such forfeiture in the same proportion as the total employer contribution to all such accounts, if one were made on that date, would have been allocated to each such account. Forfeitures of matching contributions shall be allocated to all participants eligible to share in the allocations in proportion to each such participant's compensation for the year.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their accounts up to 80 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest, which are commensurate with local prevailing rates as determined quarterly by the plan's administrator. Principal and interest is paid ratably through monthly payroll deductions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payments of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – INVESTMENTS

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by the trustee.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the assets or liability.

NOTE 4 – FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted net asset value of shares held by the plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED PARTY TRANSACTIONS

Plan investments are shares of mutual funds managed by Popular Fiduciary Services. Popular Fiduciary Services is the custodian and record keeper of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in the net appreciation in the fair value of investments.

NOTE 6 – PLAN TERMINATION

Although the Grupo Alberic intends to continue with the Plan indefinitely, they have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – INCOME TAXES

On May 11, 2004, the Plan received a ruling pursuant to the Commonwealth of Puerto Rico Income Tax Act of 1994 as amended (Act), whereby the Plan qualified under Section 1165 of the Act and is, therefore, not subject to income taxes under the present laws. The plan administrator believes the Plan is designed and is currently being operated in compliance with applicable requirements of the Act.

Subsequent to December 31, 2014, the Plan applied for amendment and qualification under the new Tax Code of Puerto Rico Section 1081.01.

NOTE 9 – RISK AND UNCERTAINTIES

The Plan invests in various investments securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balance and the amounts reported in the statement of net assets available for benefits.

NOTE 10 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events from the date of net assets available for benefits through September 24, 2025, date which the financial statements were available to be issued. During this period, no material recognizable subsequent events were identified.
