We have performed audits of the financial statements of The R & R Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The R & R Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-12 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following description of The R & R Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1989 that provides retirement benefits for eligible employees for the following companies: R&R Partners, California, Inc., R&R/CRR Holdings, LLC dba b&p Advertising, R&R Resources+ Nevada, LLC, and R&R Partners, Inc., which includes R&R Public Affairs, LLC, V, LLC, and R&R Utah Government Affairs, LLC (the "Participating Employers").

The Plan has appointed the Trustees of the American Association of Advertising Agencies (AAAA) Retirement Fund for Member Agencies to hold the office of trustee for the Plan. The trustee is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Effective January 17, 2024, the Plan terminated the participation agreement of R&R Resources+ Nevada, LLC as a result of employer abandonment. The Plan provided for 100% vesting of all participants' accounts as of that date.

Eligibility

An employee is eligible to become a participant in the Plan on the first day of the month coinciding with the completion of three consecutive months of service or a total of one year of service, whichever comes first.

Contributions

Each participant who is eligible is subject to an automatic deferral provision of 6%, unless otherwise elected by the participant. Each year, participants may contribute up to the maximum dollar amount not to exceed the annual permissible dollar limit under the Internal Revenue Service (IRS), as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). All employees who are eligible to make salary-deferral contributions under the Plan and who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions.

Notes To Financial Statements (*Continued*)

Except for R&R/CRR Holdings, LLC dba b&p Advertising, the Participating Employers match 25% of salary-deferrals for employees with less than 10 years of service and 50% for employees with 10 or more years of service. The match is limited to a salary-deferral rate of 12% of compensation or the IRS maximum 402(g) limit of \$23,000 for 2024 and \$22,500 for 2023. Management, at its discretion, may elect an additional matching contribution of a discretionary percentage not to exceed 12% of compensation. R&R/CRR Holdings, LLC dba b&p Advertising is not required to match salary-deferrals for its employees, but may make matching contributions based on a discretionary percentage. The Participating Employers did not elect to make discretionary contributions during the years ended December 31, 2024 or 2023.

Payment Of Benefits

For termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or payments over a certain period in monthly, quarterly, semiannual or annual cash installments. For termination of service for other reasons, a participant may receive the value in his or her account as a lump sum distribution.

Participant Accounts

Each participant's account is credited with the participant's salary deferral contribution, any participant's rollover contributions, the Participating Employer's matching contribution, allocation of administrative expenses, and an allocation of Plan earnings. Investment earnings are allocated based on the participant's share of the total net assets. Participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance less any loans outstanding.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The loans are secured by the vested balance in the participant's account. Loans are repaid through semi-monthly payroll withholdings, including principal and interest. Loans other than loans for a primary residence must be repaid within a five year period.

Notes To Financial Statements *(Continued)*

Vesting

Participants are immediately vested 100% in their contributions plus actual earnings (losses) thereon. Vesting in the employer's contributions is based on years of continuous service as follows:

Forfeitures

Forfeitures may be used by the Plan to pay future employer contributions or pay administrative expenses. Forfeitures which reduced employer contributions for the years ended December 31, 2024 and 2023 were \$24,870 and \$34,558, respectively. Forfeitures which reduced administrative expenses for the years ended December 31, 2024 and 2023 were \$31,453 and \$4,725, respectively. At December 31, 2024 and 2023, available forfeited nonvested accounts totaled \$17,056 and \$9,813, respectively.

In-Service Withdrawals

Active participants who reach age 59-½ may withdraw all or a minimum of \$1,000 of their fully vested accounts. Participants' employee and rollover contributions balance may be withdrawn at any time.

Active participants who experience a qualifying financial hardship may withdraw all or part of their fully vested account balance. Hardship withdrawals will be approved only if they conform to Plan and established Internal Revenue Code (IRC) safe harbors.

Administrative Expenses

The Participating Employers pay a portion of the administrative fees incurred. Only those fees paid from the Plan's assets are reflected in these financial statements.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in the Plan's interest in the 103-12 investment entity includes realized and unrealized gains and losses on those investments, interest, dividends, and investment-related expenses.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Document.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Payment Of Benefits

Benefit payments are recorded when paid.

3. Interest in the 103-12 Investment Entity

Plan investments are included in the investments of the AAAA Retirement Fund for Member Agencies (the Fund). The Fund is organized as a 103-12 investment entity as defined by 29 CFR 2520.103-12 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Use of the 103-12 investment entity permits the commingling of the Plan's assets with the assets of approximately 58 and 63 other member agencies as of December 31, 2024 and 2023, respectively. The Plan's interest in the Fund as a percentage of net assets of the Fund was 11.08% and 10.73% as of December 31, 2024 and 2023 respectively. Although the assets are commingled in the Fund, AAAA maintains supporting records for the purpose of allocating the investment income of the investment accounts to the various participating plans based on the Plan's percentage of net assets of the Fund.

5. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust

Valued at the NAV of units, or NAV equivalent, of the individual fund. The NAV, as provided by the trustee of the invested fund the , is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investment held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The common/collective trust held by the Plan files an annual report on Form 5500 as a direct filing entity. There were no unfunded commitments at December 31, 2024 or 2023.

The collective trust investment includes certain redemption restrictions. If the Fund chooses to redeem all or a significant portion of the collective trust, the issuer may require a 12-month wait period to redeem.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Income Tax Status

The Plan adopted the AAAA Benefits, Inc. non-standardized pre-approved profit-sharing plan, for which a favorable opinion letter was issued to AAAA Benefits, Inc. by the IRS on June 30, 2020. The Plan was restated effective January 1, 2022, however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party In Interest Transactions

Certain Plan investments are managed by AAAA Benefits, Inc. who is the Trustee and record keeper and, therefore, these transactions qualify as party in interest transactions.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions.

8. Plan Termination

Although none of the Participating Employers have expressed any intent to do so, they have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions. If the contract had been discontinued as of the last day of the reporting period a contract surrender charge and certain market value adjustments may be applied to the amount withdrawn.

9. Risks And Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

10. Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.
