We have performed audits of the financial statements of Four Seasons Heating and Air Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Four Seasons Heating and Air Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The company covered by the Plan is Four Seasons Heating and Air Conditioning, Inc., referred to herein as employer.

General

The Plan is a defined contribution plan covering substantially all employees of Four Seasons Heating and Air Conditioning, Inc. who meet certain age and service requirements. Excluded employees include union employees who are governed by a collective bargaining agreement, leased employees, nonresident aliens, and residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Pension Protection Act of 2006.

Contributions

Each year, participants may contribute a portion of their annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan allows for discretionary employer matching and profit sharing for all Plan participants equal to 50% of 6% of a participant's compensation. Contributions are subject to certain limitations.

Unless a participant makes an affirmative election, all participating employees are auto enrolled into the Plan at an initial rate of 3%. The Plan does not allow for the automatic escalation of deferrals.

Participant Accounts

Each participant's account is credited with participant contributions, employer matching contributions, employer profit sharing contributions and plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in employer contributions, plus earnings thereon, is based on years of credited service. Participants are 20% vested after two years of service; 40% after three years of service; 60% after four years of service; 80% after five years of service; and 100% after six years of service.

Payment of Benefits

Upon termination of employment or attainment of age 59½, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Benefits are payable either in a lump sum, partial withdrawals or in installment payments, as described by the Plan. Hardship distributions are permitted from the participant's pre-tax and Roth deferral accounts.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts may be used to reduce employer contributions as directed by the plan sponsor. During 2024 and 2023, \$75,318 and \$20,474 of forfeitures were used to reduce employer contributions. Forfeited nonvested accounts totaled \$10,437 and \$1,556 at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 and up to a maximum of the lesser of one-half of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve-month period. Participants may have only one loan outstanding at a time unless the participant has a loan for their principal residence. The loans are secured by the balance in the participant's account. Loans must be repaid within five years unless the loan is taken for the purchase of a primary residence. Loan repayments must be made each pay period on an after-tax basis in level payments of principal and interest. Loans bear interest at a reasonable rate of interest. Interest rates on loans outstanding as of December 31, 2024 and 2023 ranged from 3.50% to 8.50% and 3.25% to 8.50%, respectively.

Administrative Expenses

The Plan permits the payment of the Plan expenses to be made from the Plan's assets, unless the employer chooses to pay such expenses. Expenses paid using Plan assets will generally be allocated among the accounts of all participants in the Plan. In addition, expenses attributable to individual participants may be paid directly from the individual accounts.

Plan Amendments

On January 1, 2023, the Plan was amended to waive service and age requirements for former employees of Four Seasons Home Services, LLC and to recognize prior service for vesting and contribution.

On June 27, 2023, the Plan was amended to waive service requirements for former employees of Advantage Plumbing and Drain, Inc. and to recognize prior service for vesting.

On October 1, 2023, the Plan was amended to waive service requirements for former employees of Northwest Indiana Generator and to recognize prior service for vesting.

On November 3, 2023, the Plan was amended to waive service requirements for former employees of Merts Heating & Air Conditioning and to recognize prior service for vesting.

On October 1, 2024, the Plan was amended retroactively to January 1, 2022 to clarify conformity of the Plan's employer match definition to the Plan's operations.

On January 1, 2024, the Plan was amended to change the service requirement for eligibility from twelve months of service to three months of service. The Plan was also amended to exclude bonuses from eligible compensation.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES ESTIMATES

The Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements are as follows:

Use of Estimates

The preparation of financial statements in conformity with U.S. Generally Accepted Accounting Principles (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive group annuity contracts which are reported at contract value, see Note 7 for discussion of fair value measurements). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus accrued by unpaid interest. Interest income is recorded when received. Delinquent participant notes receivable are reported as taxable income to the participant upon default. The taxable amount is equal to the outstanding loan balance plus accrued interest through the date of default. Defaulted loans are included in notes receivable from participants at the unpaid principal balance until the participant has a distributable event and the loan balance is offset against other benefits.

Payment of Benefits

Benefits are recorded upon payment.

Administrative Expenses

The Plan pays certain administrative costs and are expensed when incurred. Other expenses are paid by the Plan Sponsor.

NOTE 3 - RISKS AND UNCERTAINTIES

The Plan invests in a variety of investments. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 4 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan administrator determined that the certification received from the Standard Insurance Company ("the Trustee") meets the requirements of ERISA Section 103(a)(3)(c). The Trustee certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

NOTE 5 - TAX STATUS

The employer has adopted a non-standardized plan pre-approved by the Internal Revenue Service (IRS). The IRS issued an opinion letter dated June 30, 2020, indicating that the form of the Plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code (IRC) Section 401. The Plan has since been amended and restated, but the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

In 2020, the Plan entered into a fully benefit-responsive group annuity contract with The Standard that invests contributions in the Standard Stable Asset D Fund. The Standard Stable Asset D Fund is a general product that seeks to provide liquidity and safety of principal, along with a competitive, guaranteed rate of return.

The crediting interest rate considers yield forecasts and other measures as determined by The Standard. The crediting rate is declared in advance and is reset quarterly. The fund's declared crediting rate will never be below 1% annually.

Certain events limit the Plan's ability to transact at contract value with The Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply.

The Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by The Standard, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

The balance in the Stable Asset D Fund totaled \$1,246,126 and \$762,805 at December 31, 2024 and 2023, respectively.

Because the group annuity contract as described above meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by the issuers represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 7 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Valued at the net asset value (NAV) of shares in each account held by the Plan at year end. The NAV is not a publicly quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value.

NOTE 8 - PARTIES-IN-INTEREST

The Standard, the main subsidiary of StanCorp Financial Group, acts as the custodian and trustee of Plan. The Plan invests in a stable value option and pooled separate accounts managed by The Standard; therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024 and 2023, fees paid by the Plan to StanCorp Financial Group for services provided by The Standard totaled \$ 55,261 and \$23,605, respectively.

Notes receivable from participants are also considered party-in-interest transactions. Certain officers of the Company are also administrators of the Plan.

NOTE 9 - EMPLOYER MATCH CONTRIBUTIONS RECEIVABLE

The employer contributions receivable of \$66,737 and \$36,122 at December 31, 2024 and 2023, respectfully, represents a provision for underfunded match contributions due from the employer that were discovered during year-end compliance testing and matching contributions related to the 2024 and 2023 plan year not remitted as of December 31, 2024 and 2023, respectively.

NOTE 10 - EXCESS CONTRIBUTIONS PAYABLE

At December 31, 2024 and 2023, amounts payable to participants totaling \$15,021 and \$117,915, respectfully, for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions and related income. The Plan distributed the 2024 excess contributions to the applicable participants in 2025 within the filing requirements. The Plan distributed the 2023 excess contributions to the applicable participants in 2024 within the filing requirements.

NOTE 11 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to the participants' accounts shall become 100% vested and all unallocated amounts shall be allocated to the accounts of all participants.

NOTE 12 - DELINQUENT EMPLOYEE DEFERRAL REMITTANCES

During the year ended December 31, 2023, the Company remitted late certain employee deferrals and loan payments to the Plan for a total amount of \$95,450.

During the year ended December 31, 2022, the Company failed to remit certain employee deferrals to the Plan for a total amount of \$3,028, resulting in a prohibited, nonexempt transaction. The Company also remitted late certain employee deferrals to the Plan for a total amount of \$60,020.

The accompanying Schedule of Delinquent Participant Contributions discloses these transactions in accordance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Company has fully corrected the late remittances including remitting foregone earnings to the Plan.

NOTE 13 - SUBSEQUENT EVENTS

In preparing these financial statements, the Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
