## INDEPENDENT AUDITORS' REPORT

To the Trustees  
Reiner Group 401(k) Plan  
Fair Lawn, New Jersey

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Reiner Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Reiner Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Reiner Group 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we

have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Basis of Accounting**

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Notes to Financial Statements

**Note 1 – Description of plan**

The following description of the Reiner Group 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of Reiner Group, Inc. ("the Company") and C.R. Wolfe Heating Corp., an affiliated company, who are age eighteen or older. Upon reaching the eligible age, employees may participate in the 401(k) portion of the Plan as well as participate in the employer matching contributions and additional profit-sharing amounts. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute a portion of their pretax annual compensation, as defined in the Plan, subject to statutory limitations under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may also elect to make Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a group annuity contract and various registered investment companies as investment options for participants. The Company may, at its discretion, provide a matching contribution, which is 20% of employees' deferrals up to 10% of their compensation. The matching Company contributions are invested in accordance with each participant's investment options as selected for their own contributions. Additional profit-sharing amounts may be contributed to the option of the Company's board of directors and are also invested in accordance with each eligible participant's investment options as selected for their own contributions. Profit-sharing contributions for the years ended December 31, 2024 and 2023 were \$700,000 and \$570,000, respectively. Contributions are subject to certain IRS limitations.

Participant Accounts: Each eligible participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at 1% plus the prime rate in effect at the time the loan is made (ranging from 4.25% to 9.50% for loans outstanding at December 31, 2024). Principal and interest is paid ratably through bi-weekly payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued, but unpaid interest. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as benefit payments based upon the terms of the Plan document. In addition, no allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Note 1 – Description of plan (continued)**

Payment of Benefits: On termination of employment for reasons other than death and upon death after commencement of distributions, the Plan may pay participants with vested account balances not exceeding \$5,000 a lump-sum distribution. For such participants with vested account balances exceeding \$5,000 the participant may elect to receive either a lump-sum or installment payments over a period of time. If death occurs prior to commencement of distributions and, unless waived by a participant's spouse or a different method has been chosen by the participant, the beneficiary may elect, for vested account balances in excess of \$5,000, to receive either a lump-sum or installments over a period of time. Withdrawals are also available in certain financial hardship situations.

Forfeited Accounts: The Plan provides that, subsequent to paying all administrative expenses, that (a) forfeitures attributable to matching contributions will first be used to reduce any qualified matching contributions and (b) forfeitures attributable to non-elective contributions will first be used to reduce any qualified non-elective contributions. The amount of forfeitures for the year ended December 31, 2024 amounted to \$21,708. During 2024, nothing was applied to offset employer contributions.

**Note 2 – Summary of significant accounting policies**

Basis of Accounting: The accompanying financial statements have been prepared on the modified cash basis of accounting, which is an acceptable alternative method of reporting under regulations issued by the Department of Labor. Investments are reported at fair value as prescribed by the Department of Labor. Dividend and interest income and routine contributions are recorded when received rather than when earned as required by accounting principles generally accepted in the United States of America (GAAP), and delinquent contributions, if any, are accrued when not received timely by the Plan. Discretionary profit-sharing contributions are accrued by the Plan. Unrealized appreciation or depreciation in the fair value of investments is recognized currently.

Use of Estimates: The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor, custodian and insurance company. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Note 2 – Summary of significant accounting policies (continued)**

**Risks and Uncertainties:** The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 3 – Fair value measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits – modified cash basis.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1 –** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2 -** Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3 –** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end registered investment companies that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The group annuity contract is valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only.

**Note 4 – Group Annuity Contract**

The Plan has a group annuity contract with Empower Annuity Insurance Company of America that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract since the contract was determined to be fully benefit-responsive. The contract is included in the financial statements at fair value which approximates contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet contractual obligations may be affected by future economic and regulatory developments. The fair value of the investment contract at December 31, 2024 and 2023 was \$2,408,854 and \$2,750,707, respectively. The crediting interest is based on a formula agreed upon with the issuer but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following:

- (a) Premature termination of the contract by the Plan
- (b) Plant closures
- (c) Layoffs

- (d) Complete or partial Plan termination
- (e) Bankruptcy
- (f) Mergers
- (g) Early retirement incentives
- (h) Amendments to the Plan's document
- (i) Failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA

The Plan administrator does not believe that any events which would limit the ability of the Plan to transact at contract value with the contract issuer and that would also limit the Plan's ability to transact at contract value with participants are probable of occurring.

Certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without consent of the issuer.

**Note 5 – Information prepared and certified by custodian**

Investments and notes receivable from participants aggregating \$44,097,239 and \$37,600,675 as of December 31, 2024 and 2023, respectively, and investment income of \$5,806,788 and interest income on notes receivable from participants of \$57,548 for the year ended December 31, 2024 included in the accompanying financial statements and supplemental schedule were obtained from data that has been prepared and certified to as complete and accurate by Empower Annuity Insurance Company of America, the custodian of the Plan.

**Note 6 – Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

**Note 7 – Tax status**

The Internal Revenue Service has determined and informed the Company by a letter dated May 18, 2001, that the Plan and related trust as then designed was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8– Administrative expenses**

Administrative expenses, consisting of custodian fees, investment advisory services and record keeping for participant accounts, including investment allocations, loans and benefit payments, are paid by the Plan. Other administrative expenses, including audit fees, are paid by the Company and excluded from these financial statements.

**Note 9 – Related party transactions and Party in Interest Transactions**

The Plan includes a group annuity contract and participant loans issued and managed by Empower Annuity Insurance Company of America and its subsidiaries. Certain subsidiaries provide administration and recordkeeping services to the Plan while another serves as Plan custodian. These specific investments issued by or managed by Empower Annuity Insurance Company of America qualify as party-in-interest transactions. Fees paid by the Plan to the related parties for investment management services related to these investments amounted to \$46,071 for the year ended December 31, 2024. Total administrative expenses for the year ended December 31, 2024 amounted to \$109,845. The Plan's participants have been receiving investment advisory services during the year from CFS Investment Advisory Services, LLC. These transactions qualify as party-in-interest transactions. The advisory fees paid to CFS Investment Advisory Services; LLC amounted to \$78,665 for the year ended December 31, 2024. These fees are paid out of the investment earnings and not from the Plan assets.

**Note 10 – Subsequent events**

Plan Management has evaluated all subsequent transactions and events after December 31, 2024 through October 9, 2025, the date the financial statements were available to be issued and have determined that there are no material subsequent events that would require additional disclosures in the financial statements.
