### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Wofford College Defined Contribution Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Note 1—Description of the Plan

The following description of the Wofford College Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan is a combined plan, consisting of a defined contribution retirement plan and a tax deferred annuity plan, established by Wofford College (the “College”) in June 1949, which was subsequently amended and restated effective January 1, 2018. The Plan covers all employees of the College, except students enrolled and attending classes offered by the College. The Plan provides employer contributions to all employees covered by the Plan over the age of 21 who have earned a year of eligible service, except members of a collective bargaining unit that have negotiated exclusion from coverage as part of the negotiated agreement and adjunct faculty.

*Administration* – The Plan is administered by the College which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. The finance committee of the Board of Directors of the College controls and manages the operation and administration of the Plan. Teacher’s Insurance and Annuity Association of America (“TIAA”) and College Retirement Equities Fund (“CREF”) serve as the “qualified institutions” of the Plan.

*Contributions* – For the year ended December 31, 2024, participants may contribute up to \$23,000 pre-tax annual compensation subject to certain Internal Revenue Code (“IRC”) limitations. There is no service requirement for an employee to defer a portion of their compensation as a pre-tax deferral. Participants direct the investments of their contributions into various investment options offered by the Plan. Once eligible, participants may also contribute amounts representing distributions from other qualified retirement plans, 403(b) tax sheltered annuity plans, government 457(b) plans, and traditional IRAs. Unless the employee is part of an excluded class of employees noted above, employees must complete one year of service with the College before the employee is eligible to receive contributions made by the College. Participants with hours of service with another institution of higher education will receive credit for time that they worked for the predecessor employer in order to satisfy any additional service requirements for the Plan. The College contributes 10% of eligible employee compensation, as defined by the Plan.

*Catch-Up Contributions* – If a participant is eligible to make deferrals and turns 50 before the end of any calendar year, the participant may defer an additional \$7,500 into the Plan as a pre-tax contribution subject to certain IRC limitations. If a participant has worked at least 15 years for the College, the participant may make a special catch-up contribution equal to the smallest of the three amounts listed: 1) \$3,000; 2) \$15,000 minus the amount of special catch-up contributions made in the prior years; and 3) \$5,000 times the number of years the participant has worked for the College minus the total amount of deferrals made while the participant worked for the College. Catch-up contributions are eligible for matching contributions made by the College. If a participant qualifies for both types of catch-up deferrals, the contributions will be allocated first as special catch-up contributions.

*Participant Accounts* – Each participant’s account is credited and/or reduced with the participant’s elective deferral contributions and distributions as well as allocation of (a) the College’s contribution, (b) Plan earnings (losses), (c) forfeitures, and (d) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in their contributions, including catch-up and special catch-up contributions, rollover contributions from other plans, and employer contributions plus actual earnings thereon.

### Note 1—Description of the Plan (continued)

*Investment Options* – Upon enrollment in the Plan, a participant may direct 100% of their allocation of contributions with TIAA and CREF. Within TIAA and CREF, participants may select between various investment options. Participants may transfer balances periodically as defined in the custodial agreement.

*Plan Loans* – Participants may borrow directly from TIAA and CREF a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account. Principal and interest is paid through an automatic draft of the participant's checking account or billed to the participant by the Trustee. Loans are held directly by TIAA and CREF and are not assets of the Plan. Loans outstanding under the Plan totaled \$0 as of December 31, 2024 and 2023.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance, less any current loans outstanding or \$50,000 reduced by the participants highest outstanding loan balance from the preceding 12 months. Loan terms range from one to five years or up to 25 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates ranged from 4.25% to 9.50% as of December 31, 2024. Principal and interest is paid ratably through monthly payroll deductions. Notes receivables outstanding under the Plan were \$51,673 and \$45,726 as of December 31, 2024 and 2023, respectively.

*Benefits Paid to Participants* – Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or an annuity. For termination of service for other reasons, distribution of the value of the participant's vested interest in their account will begin as soon as possible after the participant's request.

*Forfeited Accounts* – As of December 31, 2024 and 2023, the Plan had \$3 and \$26 in forfeited accounts, respectively. These amounts will be used to offset future College contributions. Forfeitures of \$3,029 were used during the year ended December 31, 2024.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Such estimates include those regarding fair value. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition* – Investments are valued at fair value, with the exception of fully benefit-responsive investment contracts, which are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Non-fully benefit-responsive contracts are reported at fair value within the financial statements.

*Reclassifications* – Certain reclassifications have been made to the December 31, 2023 statement of net assets available for benefits presentation to correspond to the current year's format. Total net assets available for benefits was unchanged due to these reclassifications.

### Note 2—Summary of significant accounting policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

*Administration Expenses* – Except as discussed in Note 6, Plan administration expenses are generally paid by the College, as provided by the Plan document, and are excluded from these financial statements. Certain administrative functions are performed by employees of the College. No such employee receives compensation from the Plan. Investment related expenses are included in net appreciation/depreciation in value of investments.

*Risks and Uncertainties* – Investment securities in general are subject to various risks, such as interest rate, credit, and overall market volatility. Due to the levels of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

*Benefits Paid to Participants* – Benefits paid to participants are recorded when paid.

*Contributions* – Participants may contribute to the Plan. Participant contributions are recorded each payroll period. Employer contributions are recorded when paid by the College.

*Other Income* – The Plan Sponsor has entered into an agreement with TIAA and CREF to create a revenue credit account ("RCA") to hold revenue sharing funds the Plan receives from TIAA and CREF pursuant to an agreement. These funds are available to pay qualified Plan administrative expenses or may be reallocated to Plan participants. The amount credited to the RCA is determined on a quarterly basis by TIAA and CREF and is reported as other income on the statement of changes in net assets available for benefits. At December 31, 2024 and 2023, the RCA balance was \$121,024 and \$108,967, respectively.

### Note 3—Information certified by the qualified institutions (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF, the qualified institutions of the Plan, have certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value, and fully benefit-responsive guaranteed investment contracts, at contract value and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in value of investments, interest and dividends, other income, and interest on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

At the request of the Plan Sponsor, the Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### Note 4—Fair value measurements

The Plan follows Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements*, which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds* – These investments are public investment vehicles valued using NAV provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and, therefore, considered to be readily determinable and classified within Level 1 of the valuation hierarchy.

*Pooled Separate Accounts (Real Estate Fund)* – These assets are not available in an exchange or an active market; however, the fair value is determined based on NAV of the underlying assets as traded in an exchange or active market. The Real Estate Fund (“REF”) generally invests in real estate properties and real estate related investments. The value of the fund is principally derived from the market value of the underlying real estate holdings or other real estate related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The fund sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated each day. Although the underlying assets of the REF cannot be quickly sold and converted to liquid assets, TIAA and CREF provides the REF with a liquidity guarantee to ensure funds are available to meet participant redemption, transfer, or cash withdrawal requests executed at quoted unit value. Based on this liquidity guarantee, the REF is classified within Level 1 of the valuation hierarchy.

*Guaranteed Investment Contract (Non-Fully Benefit-Responsive Contract)* – This investment is a guaranteed fixed income annuity backed by TIAA and CREF's claims paying ability whereby the annuity guarantees principal and a minimum interest rate, plus opportunity for additional amounts in excess of the guaranteed rate. The annuity contract is not traded, and significant other observable inputs are not available. This contract is reported at fair value, which approximates contract value, and is classified within Level 3 of the valuation hierarchy.

**Note 5—Guaranteed investment contracts with insurance company**

The Plan invests in traditional guaranteed investment contracts, which consist of guaranteed fixed annuity contracts with TIAA. Fully benefit-responsive guaranteed investment contracts include the TIAA Traditional Benefit Responsive, TIAA Traditional Benefit Responsive 2 and Plan Loan Default Fund. Non-fully benefit-responsive guaranteed investment contracts include the Retirement Annuity account (“RA”). TIAA maintains the contributions in the TIAA General Account. TIAA groups the premium dollars it receives over defined time periods into vintages, typically composed of one or more contiguous calendar months, for the purpose of determining the crediting rate to participants’ accounts. The crediting rate for each vintage is determined, in part, by the net investment earnings rate of the TIAA assets supporting that vintage, minus a charge for administrative expenses and an amount set aside for contingency reserves. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, which approximates fair value.

A portion of the guaranteed investment contracts are fully benefit-responsive; contract value is the relevant measurement attribute for that portion of the net assets available for benefits. The fully benefit-responsive portion, which totaled \$7,948,549 and \$4,196,226 as of December 31, 2024 and 2023, respectively, is included in the statements of net assets available for benefits at contract value which approximates fair value as reported to the Plan by TIAA. The non-fully benefit-responsive portion, which totaled \$15,305,295 and \$14,810,010 as of December 31, 2024 and 2023, respectively, is included in the statements of net assets available for benefits at fair value as reported to the Plan by TIAA. Fair value approximates contract value for all TIAA contracts held by the Plan.

Certain events limit the Plan's ability to transact at contract value with TIAA. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **Note 6—Party-in-interest transactions**

Plan investments are shares of mutual funds, a pooled separate account, guaranteed investment contracts, and interest-bearing cash managed by TIAA and CREF. TIAA and CREF are the certifying entities of the Plan's investments; therefore transactions with TIAA and CREF qualify as party-in-interest transactions.

Fees paid by the Plan for the investment management services of TIAA and CREF amounted to \$375,966 for the year ended December 31, 2024, included within net appreciation in value of investments in the statement of changes in net assets available for benefits. An additional \$18,975 related to investment advisory services is included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### **Note 7—Plan termination**

The College believes the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. Distribution of participant account balances will occur as soon as administratively feasible upon termination of the Plan.

### **Note 8—Tax status**

The Internal Revenue Service ("IRS") is developing a determination letter program for Section 403(b) plans; however, the procedures for a Section 403(b) plan determination letter program have not been issued. The Plan is designed through a prototype plan and the prototype sponsor, as well as the Plan's sponsor, believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

**Note 9—Subsequent events**
