## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## 1) DESCRIPTION OF THE PLAN

The following description of the Unified Business Technologies Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description and the Plan Document for a complete description of the Plan's provisions.

### General

The Unified Business Technologies, Inc. 401(k) Plan (the "Plan") is a defined contribution retirement plan intended to qualify under of the Internal Revenue Code (the "Code"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and is administered in accordance with applicable regulations issued by the U.S. Department of Labor (DOL) and the Internal Revenue Service (IRS).

The Plan was established by Unified Business Technologies, Inc. (the Company) and permits eligible employees of the Company and its adopting employers to participate. The Plan utilizes a calendar year for its plan with a year ending December 31, 2024.

### Participating Employers and Plan Structure

As of December 31, 2024, the following entities have adopted the Plan:

1. Unified Business Technologies, Inc. (the Company) – the Plan sponsor and principal employer, which maintains operational and fiduciary oversight of the Plan.
2. Joint Venture Entities:
  - o UV Sheltron, Inc.
  - o Agile Enterprise Corporation
  - o Amvet Solutions Inc.
  - o Azonika, Inc.

These entities have adopted the Plan under formal adoption agreements. UBT maintains substantial control over these entities for the purposes of the Plan, including centralized payroll administration, benefit plan administration, and HR oversight, and they are therefore treated as adopting employers under applicable IRS and ERISA guidance.

3. Addon Services LLC – a client of the Company for which the Company serves as a Professional Employer Organization (PEO) and provides payroll services. The Company has extended 401(k) Plan participation to the eligible common-law employees of Addon Services LLC pursuant to a written adoption agreement and in compliance with IRS guidelines.

Each employer has signed a formal agreement with the Company to participate in the Plan, and contributions of their employees are remitted by the Company through centralized payroll systems. While each employer retains authority over employee classification and eligibility, the Company is responsible for the day-to-day Plan administration, payroll integration, and fiduciary oversight.

## 1) DESCRIPTION OF THE PLAN (Continued)

### Administration

The Plan is administered by Unified Business Technologies Inc. (the Company). Principal Life Insurance Company is the custodian and record-keeper of the Plan. The custodian invests funds received from contributions, investment sales, interest, and dividend income and makes distributions payment to the applicable participants.

### Eligibility

For the purpose of elective deferrals and employer contributions, all employees of the Company and the participating Employers are eligible to participate as of the date of hire. Additionally, any employee who receives prevailing wages under the Davis-Bacon Act or similar law will become a participant as of that date he or she receives such wages.

### Contributions

Each year, participants may elect to contribute a portion of their compensation not to exceed limits established by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions from other qualified plans are also permitted at the discretion of the Plan administrator. Participants direct the investment of their contributions into various options offered by the Plan. Contributions are subject to certain limitations.

The plan also provides for employer matching and discretionary contributions. Beginning January 1, 2015, the employer made a contribution equal to a percentage of the eligible employees' prevailing wages under the Davis-Bacon Act or similar law which is the hourly contribution rate designated for employment classification for the project at which that work was performed. All employees enrolled in the 401(k) plan received a 401(k) match equal to 100% of the employee contributions, up to the first 6%. The total employer contribution for the prevailing wage rate employees and for the employer match was \$0 and \$546,952 for December 31, 2024 out of which \$118,035 was funded through forfeiture. The prevailing wage and employer match contributions were \$0 and \$619,538 for December 31, 2023, respectively out of which \$74,888 was funded through forfeiture.

### Vesting

Participants are immediately vested in their elective deferrals plus actual earnings thereon.

The following vesting schedule is followed for employer matching contributions:

### Vesting (Continued)

Notwithstanding the foregoing, a Participant shall at all times be 100% vested in that portion of his Employer Profit Sharing Contribution Account attributable to Prevailing Wage contributions as described above.

### Distributions

Distributions under the Plan are made in cash for the vested portion of the participant's account. Election of distribution form is limited by specific provisions of the Plan which depend upon the dollar value of the participant's account and a reason for distribution, termination, retirement, death, or disability. The Plan also allows for in-service withdrawals including hardship withdrawals, after age 59½ withdrawals and minimum required distribution after age 73.

### Hardship Withdrawals

Under certain conditions, as specified in the Plan Document, participants, while still employed by the participating employers, are permitted to withdraw a portion of their elective contributions account balance.

### Participant Accounts

Participants may elect to invest in any combination of the investment funds offered by the Plan and may change their elective deferral percentages as they want. Each participant's account is credited with the participant's contributions, employer contributions, employer match, and allocations of the Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the vested value of the participant's account.

### Notes Receivables from Participants

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances reduced by any outstanding loan balance. Loan terms range from 1-5 years. The loans are secured by the balance in the participant's account. The outstanding loan balance for the years ended December 31, 2024, and 2023 amounted to \$80,466 and \$148,252, respectively.

## 2) SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The financial statements are prepared using the accrual method of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Notes Receivable from Participants

The notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant or beneficiary suffers a deemed distribution within the meaning of Code Section 72(p), they will be deemed to have suffered a financial hardship and can request certain types of distributions as specified in the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Sponsor determines the Plan's valuation policies utilizing the information provided by the investment advisers, custodians and insurance company. See Note 4 for more details on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the participant accounts are charged directly to the participants account and are included in administrative expenses. Investment related expenses are also included in administrative expenses.

### Benefit Payments

Benefits are recorded when paid out of the Plan.

### Forfeitures

Forfeitures are first used to pay off plan expenses and then to use for employer contributions for the participants. The plan used \$28 for administrative expenses and \$118,035 for employer contributions out of the forfeiture balance during the year 2024. During 2023, the Plan used \$24 for administrative expenses and \$74,888 for employer contributions out of forfeiture balance. The balance of the forfeiture account was \$1,962 and \$0 as of December 31, 2024, and 2023 respectively.

### Excess Contribution Payable

Amounts contributed by or on behalf of participants in excess of the limits prescribed under Internal Revenue Code Sections 401(k), 402(g), and 415 are recorded as a liability with a corresponding reduction to participant contributions.

For the year ended December 31, 2024, excess contributions totaling \$10,787 were identified and corrected within the IRS-prescribed deadline, and no penalties are expected.

For the year ended December 31, 2023, excess contributions totaling \$15,195 were not corrected within the required time frame and the Company is in the process of making this distribution. The Plan Sponsor is responsible for filing the applicable Form 5330 and remitting any excise tax under IRC Section 4979. Corrective action has to be taken under the IRS Employee Plans Compliance Resolution System (EPCRS) to maintain the Plan's qualified status.

The excess contribution payments were \$25,982 and \$15,195 for the years ended December 31, 2024, and 2023, respectively.

### Recently Adopted Accounting Standards

Effective January 1, 2023, the Plan adopted accounting standards update (ASU) 2016-13, Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments (FASB ASC 326), which significantly changed how entities measure credit losses for most financial assets. The most significant change in the standard is a shift from the loss methodology incurred to an expected loss methodology. Financial assets held by the Plan that are subject to the guidance in FASB ASC 326 were contributions receivable. There was no material impact on the financial statements as a result of the adoption of ASU 2016-13.

## 3) CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedules, related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company, a qualified institution. (the custodian of the Plan).

## 4) FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

**Level 2:** Input other than quoted prices included within Level 1 that are observable for the assets or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is the description of the valuation methodologies used for assets measured at fair value:

Common Collective Trust: Common Collective Trust (CCT) are valued at the NAV which is not a publicly quoted price in an active market but is available to current investors via the employer website, or when plan participants access their account values. The NAV is the basis for current transactions and the CCTs can be redeemed at NAV as of the measurement date. Therefore, CCTs are believed to have a "readily determinable value".

Pooled Separate Accounts: Pooled Separate Accounts (PSA) are valued at Net Asset Value (NAV) which is the basis for current transactions and the PSAs can be redeemed at NAV as of the measurement date. Therefore, the PSAs are believed to have "readily determinable value".

## 4) FAIR VALUE MEASUREMENTS (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

## 5) ERISA BOND REQUIREMENTS

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets and is required to be at least equal to the lesser of 10% of the plan's assets at the beginning of the plan year or \$500,000. At December 31, 2024 and 2023, the Plan's sponsor maintained the required bond coverage.

## 6) TAX STATUS

The Plan uses a prototype plan utilized by Mandmarblestone, PC which is in possession of an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states the prototype plan satisfies the applicable provisions of Internal Revenue Code (IRC). The Plan itself is not required to and has not received a determination letter from IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## **6) TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The plan administrator believes it is no longer subject to income tax examinations prior to 2021.

## **7) PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contribution.

## **8) RISKS AND UNCERTAINTIES**

The Plan provides for various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

## **9) TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain Plan investments and administrative expenses are represented by investment contracts and mutual funds managed by Principal Life Insurance Company and Principal Global Investors Trusts Co. The custodian is the carrier as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Company for custodian services amounted to \$104,146 and \$86,625 for 2024 and 2023 respectively. These transactions and the fees paid to the Custodian are exempt from the prohibited transaction rules.

## 11) LATE REMITTANCES OF CONTRIBUTIONS TO THE PLAN

During the fiscal year ended December 31, 2024 and in prior years, the Company failed to remit to the Plan's custodian a portion of the salary deferrals within the period prescribed by the Department of Labor. The delays were due to administrative errors. The total amount of late payments not corrected as of December 31, 2024 and 2023, by the Company was \$106,843 and \$32,937, respectively, on which loss of earnings has been calculated by the Company and a correction was made subsequent to the year end. The late deferrals are disclosed in the supplemental information, Schedule H, Part IV, line 4a. (Schedule of Delinquent Participant Contributions).

## 12) SUBSEQUENT EVENTS

The Plan has evaluated other subsequent events through October 10, 2025, the date that the accompanying financial statements were available to be issued. No significant event was noted that required adjustment or disclosure in the financial statements.
