Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Reedman-Toll 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Reedman-Toll 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan, formed on October 1, 2004, is a defined-contribution savings plan covering all full-time employees of Reedman-Toll, L.P. (the Company) who have completed at least six months of service and are age 21 or older. Upon satisfying the requirements, an employee will become eligible to enter the Plan on the first day of the Plan quarter coinciding with or following the date that the participant meets the eligibility requirements. The Plan includes the following affiliated participating employers: Abington Auto World, L.P., Roberts Automobiles, L.P.; Springfield Auto World, L.P.; Reedman Toll Management Group, LLC; Springfield Auto World III, LLC; Springfield Auto World, II L.P.; and Stork Driver PA, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants may contribute up to 100% of after-tax compensation, as defined by the Plan. In no event may participant pre-tax and after-tax contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may make a discretionary matching contribution to each participant based on his or her elective deferral at a percentage determined by the Company. For 2024, the Company contributed 40% of the first 5% of each participant's compensation deferred for each pay period. Total discretionary matching contributions for the Plan year ended December 31, 2024 amounted to \$266,657, net of forfeitures.

Participant Accounts: Participants direct the investment of participant and employer contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or (losses) and may be charged with an allocation of administrative expenses, if any. Earnings or losses are credited to each participant's account based upon the performance of the respective investments selected by the participant and charges for specific participant transactions, as defined. Participants may change their investment options at any time. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options: Participants may direct the investment of contributions into various investment options offered by the Plan. If no investment election is made by a participant, the funds will be invested in a qualified default investment alternative designated by the Plan. Participants may change their investment allocation at any time.

Note 1. Description of the Plan (Continued)

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances, plus any accrued but unpaid interest. A participant may borrow from his or her fund account up to the lesser of (a) \$50,000 reduced by an amount defined in the Plan, or (b) 50% of the vested account balance. Loan terms range from one to five years or greater for the purchase of a primary residence. Each loan is secured by the balance in the participant's account and bears interest at a reasonable rate, similar to one a bank or other professional lender would charge for making a loan in similar circumstances. Interest rates on outstanding loan balances range from 4.25% to 9.50% as of December 31, 2024 and 2023, respectively. Principal and interest are paid ratably through weekly payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Vesting: Participants are vested immediately in their contributions, rollovers and transfer contributions, and earnings or losses thereon.

Vesting in the Company's matching contributions are based on years of service. After one year of service, a participant is vested at 20%. Vesting increases 20% per year thereafter until fully vested after five years of service. Participant accounts become fully vested upon retirement at age 65, permanent disability or death.

Payment of Benefits: On termination of service a participant or beneficiary may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant who meets the in-service distribution requirements may also receive a lump-sum distribution.

Forfeited Accounts: Forfeitures of terminated participants' nonvested employer matching contributions are used to reduce future employer matching contributions to the Plan. Forfeited nonvested accounts available as of December 31, 2024 and 2023, were \$34,490 and \$29,500, respectively. During the year ended December 31, 2024, forfeitures of \$23,368 were used to reduce employer matching contributions.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account. Participants are also charged an asset-based fee for recordkeeping. These fees are included in administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of the investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at the unpaid principal balances, plus any accrued interest. Delinquent loans are treated as distributions based upon the terms on the plan document surrounding defaulted loans.

Payment of Benefits: Benefits are recorded when paid.

Excess Contributions Payable: Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Reclassification: Certain prior year amounts have been reclassified to conform to current year presentation.

Subsequent Events: In preparing these financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued. See Note 10.

Note 3. Information Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (VRIAC), the Custodian of the Plan.

Note 4. Investments and Fair Value Measurements

All investments are participant-directed. The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.
- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The Plan's investments are held by VRIAC in pooled separate accounts and a fixed account. The following is a description of valuation methodologies used for Plan assets. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 4. Investments and Fair Value Measurements (Continued)

Pooled Separate Accounts, at Fair Value: Units of participation in pooled separate accounts are reported at the accumulated value of units held by the Plan at year-end as reported to the Plan by VRIAC. The accumulated unit value is determined daily by VRIAC and is based on the net asset value of shares in the underlying fund, the fund's dividends and the contract's separate account charges. The fair value of the underlying fund shares are generally based on level 1 input. Since the fair value hierarchy level to be used is to be the lowest level that would be significant to the measurement in its entirety, inputs used to determine the fair value of pooled separate accounts include other observable inputs that are considered to be Level 2.

Fixed Account, at Contract Value: The fixed account consists of a fully benefit-responsive fixed income investment contract option which guarantees a minimum rate of interest. All assets are invested in the insurance company's general account. The fixed account is stated at contract value, as reported to the Plan by VRIAC.

The preceding methods may produce a fair value or contract value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The Plan has invested in a group contract with VRIAC within which participants may direct their contributions into either pooled separate accounts or a fixed account (guaranteed interest) investment option. The pooled separate accounts consist of variable fund investment options, both institutional and retail, covering multiple assets classes. The fixed account provides a guaranteed rate of return that obliges VRIAC to repay the principal and a specified interest rate to the Plan.

The fixed account meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issue is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The contract features two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate, declared annually. Interest is credited on a daily basis. The crediting rate is based on a formula established by the contract issue but may not be less than 3.00%. There is no defined maturity specified in the contract.

The Plan's ability to receive amounts due in accordance with its fully benefit responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer, such as partial or complete termination of the contract, plan termination or merger, changes to the Plan's prohibition on competing investment options, bankruptcy of the Plan Sponsor or other plan sponsor events. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Balances as of December 31, 2024 and 2023, were \$563,906 and \$1,114,319, respectively.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Tax Status

The Plan has adopted a non-standardized pre-approved profit-sharing plan sponsored by Pennsylvania Pension Planners, Inc. The Plan Sponsor received an opinion letter from the Internal Revenue Service, dated June 30, 2020, that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended subsequently, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Related Party Transactions and Party-In-interest Transactions

Plan investments include shares of pooled separate accounts and a fixed account managed by VRIAC or its affiliates. VRIAC has contracted with the Plan to provide certain investment and administrative services and, therefore, these transactions qualify as party-in-interest transactions.

VRIAC provides certain administrative services to the Plan and receives revenue from mutual fund providers for services VRIAC provides to the funds. This revenue is used to offset certain amounts owed to VRIAC for its administrative services to the Plan. If the revenue received by VRIAC exceeds the amounts owed, VRIAC remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants, depending on the Plan's provisions. During 2024, \$38,591 was received from VRIAC and is reflected in net appreciation in the statement of changes in net assets available for benefits. \$38,590 was used to pay Plan expenses in 2024. The account balance as of December 31, 2024 and 2023, was \$79 and \$78, respectively.

Note 9. Risks and Uncertainties

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Note 10. Subsequent Events

In August 2025, the Plan entered into a participation agreement in the Great Gray Collective Investment Trust to switch the target date funds to the MyCompass American Funds target date funds, as the default investment option. The change in target date funds is expected to be effective in October 2025.
