Notes to Financial Statements

Note 1: Description of Plan

The following description of the Bank of Ireland Group U.S. 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which was adopted in 1996 and restated as of January 1, 2021. The Plan covers eligible employees, as defined, of The Governor and Company of the Bank of Ireland (the Employer and Plan Administrator) who elect to participate and are older than 20 years of age. There is no minimum service requirement for participants to make elective salary deferrals or to receive Safe Harbor matching contributions. Participants have to complete 500 hours of service in 6 consecutive months to qualify for discretionary employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Eligible employees may contribute to the Plan, through salary deferrals, a specified percentage of their compensation, as defined, up to a maximum dollar amount as prescribed by the Internal Revenue Service (IRS) regulations. Participants may designate all or part of their elective contributions as Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute funds from other qualified plans (rollover contributions) subject to certain requirements. The Employer's contributions are Safe Harbor matching amounts of 100% of the participant's first 3% of deferrals and 50% of the participant's next 2% of deferrals, but not in excess of 4% of the participant's compensation. In addition to the matching contribution, the Employer may also make additional discretionary contributions. There were no Employer discretionary contributions made in 2024 and 2023.

Vesting and Benefits

Participants are entitled to the vested portion of their participant account upon termination, death, disability, or retirement. All accounts, including salary deferrals, matching contributions, and discretionary contributions, are 100% vested immediately. A participant may elect to receive an in-service distribution from the Plan after attaining age 59½. Hardship withdrawals may be taken prior to attaining age 59½, for certain hardship events as defined in the Plan documents. A participant may elect to receive benefits in either a lump-sum payment or by a direct transfer to an annuity or another qualified plan. A participant may take a distribution of less than the entire vested account balance upon termination of employment. A mandatory distribution will be made for vested account balances less than \$5,000 (\$7,000 after January 1, 2024).

Investment Options

Plan assets may be invested in various guaranteed interest accounts and pooled separate accounts pursuant to a group annuity contract with John Hancock Life Insurance Company. Plan contributions are allocated based upon a participant's selected options. Earnings (losses) are allocated based on the account balances in each fund.

Note 1: Description of Plan (Continued)

Notes Receivable from Participants

Participants may borrow from their accounts amounts not to exceed \$50,000 or 50% of their vested account balances. Loans are secured by the balance in the participant's account and must be repaid, with interest, over a period not to exceed five years, or longer, if the proceeds are used to purchase a principal residence. The interest rate on participant loans is commensurate with local prevailing rates. Principal and interest are repaid through payroll deductions. Interest rates on loans outstanding ranged from 7.50% to 10.50% as of December 31, 2024, and from 5.25% to 10.50% as of December 31, 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Employer's Safe Harbor matching contributions and allocations of (a) the Employer's discretionary contributions, and (b) plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for fair value measurements.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

Note 2: Summary of Significant Accounting Policies (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are treated as benefit payments pursuant to the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid directly by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Plan expenses, such as loan and distribution fees, are charged to individual participant accounts based on the participant's use of specific Plan features and are included administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3: Investments

The Plan is a party to a group annuity contract with John Hancock Life Insurance Company under which all contributions are deposited to pooled separate accounts or guaranteed interest accounts with the insurance company.

Contributions to the guaranteed interest accounts are held in the John Hancock USA general account. These accounts guarantee the return of principal, plus compound interest earned over a defined 3-, 5- or 10-year term. Interest rates are established on the first day of each calendar month and apply to all regular ongoing contributions made to the guaranteed account in that month for all group annuity contract holders. At the end of each reporting year, a composite rate of interest is determined for each participant account, depending on the amounts contributed and the rate in effect on the day it is allocated under the participant account. The composite rate is the effective annual rate earned by all contributions to that guaranteed account during that reporting year for that participant. Contributions continue to earn interest based on the calculated composite interest rate for the duration of the guaranteed term. Composite rates for the guaranteed interest accounts ranged from 0.75% to 3.55% during the years ended December 31, 2024 and 2023.

The separate accounts consist of various investment options. The insurance company has title to all assets in the separate accounts. The Plan owns accumulation units in the various funds of the separate accounts.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for identical or similar assets in inactive markets, quoted prices for similar assets in active markets, observable inputs other than quoted prices or inputs derived principally from or corroborated by observable market data by correlation or other means; and Level 3 inputs consist of inputs to the valuation methodology that are unobservable and significant to the fair value measurement and have the lowest priority. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in valuation methodologies used at December 31, 2024 and 2023.

The guaranteed interest accounts are valued at fair value, which is determined by multiplying book value, which represents contributions made under the contract, plus earnings, less distributions and administrative expenses, by a formula that incorporates prevailing interest rates, as defined in the group annuity contract.

The pooled separate accounts are valued at the net asset value (NAV) of the units of participation in the accounts held by the Plan at year end as a practical expedient. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. The NAV is based on the fair value of the underlying investments held in the accounts. Each pooled separate account invests in a registered mutual fund with varying investment objectives. The units are valued daily and the unit values incorporate declared dividends, capital gain distributions and asset management charges. Participant transactions (issuances and redemptions) may occur daily at the latest NAV.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets as of December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA.

Note 6: Information Prepared and Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by John Hancock Life Insurance Company, the Custodian of the Plan.

Note 7: Party-in-Interest Transactions

The Plan investments are guaranteed interest accounts or units of pooled separate accounts managed by John Hancock Life Insurance Company or its affiliates. Administrative fees paid to John Hancock Life Insurance Company for the years ended December 31, 2024 and 2023 were \$92,299 and \$85,130, respectively. John Hancock Life Insurance Company is the custodian of the Plan's assets in the group annuity contract; therefore, transactions within these accounts are deemed to be party-in-interest transactions. Fees incurred by the Plan for investment management services are netted against net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan also has arrangements with various other service providers which qualify as party-in-interest transactions under ERISA. In addition, notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 8: Tax Status

Effective January 1, 2004, the Employer adopted a non-standardized pre-approved profit sharing plan which was restated on January 1, 2021. The Internal Revenue Service issued an opinion letter on the restated plan, dated June 30, 2020, indicating it is in compliance with the applicable sections of the Internal Revenue Code. The letter stated, in part, that an employer who adopts this Plan will be considered to have a plan qualified under Internal Revenue Code Section 401(a), provided the terms of the Plan are followed. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
