INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Opinion

We have audited the accompanying financial statements of Howard Leasing, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Howard Leasing, Inc. 401(k) Profit Sharing Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

NOTE A – DESCRIPTION OF PLAN

The following description of the Howard Leasing, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan effective January 1, 2016, covering all participants employed by the participating employers served by Howard Leasing, Inc. (Adopting Employer) (Plan Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended by the applicable sections of the Internal Revenue Code (IRC). The Plan was amended and restated effective April 1, 2022.

Eligibility

Each participating employer may elect its eligibility and participation requirements when signing the Multiple Employer Plan Adoption Agreement. Employees of a participating employer may elect to begin making contributions into the Plan on January 1, April 1, July 1 or October 1 or immediately following eligibility. Employees covered under a collective bargaining agreement are not eligible to participate.

Contributions

Participants may contribute to the Plan on a pretax or after tax basis at a minimum of 1% of their annual compensation up to the maximum amount allowed by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Roth contributions and rollovers are permitted. Each participating employer makes their own election on whether or not to match a percentage of participant contributions. Employers may also make a Safe Harbor matching contribution election. Contributions are recorded in the period the Adopting Employer makes the payroll deductions from the participants. Any contributions made by the participating employer are recorded in the same period.

Participants direct the investment of their contributions into various investment options offered by the Plan. The participants may change their investment elections at any time.

Discretionary Non-elective Profit Sharing Feature - Each year the participating employer may make a discretionary contribution. Profit sharing contributions are allocated to participant accounts based on a tiered formula using employee compensation. The participant must be employed as of the last day of the Plan year to receive the profit sharing contribution.

Notes Receivable from Participants

Participants are able to obtain loans from the assets of the Plan using their vested individual account balances as collateral. Participants are limited to two outstanding Plan loans at any time. Loan amounts cannot exceed the lesser of \$50,000 or 50% of the participant's vested account balance and must have a minimum amount of \$1,000. Each loan shall bear interest at a variable rate of return, noted as the prime rate plus one percent, determined at the time of the loan. Principal and interest is paid ratably through payroll deductions. At December 31, 2024 and 2023, interest rates ranged between 4.25% and 9.50%.

NOTE A – DESCRIPTION OF PLAN – CONTINUED

Participant Accounts

Each participant's account is credited with the participant's contribution, employer contribution (if any), and plan earnings (losses), and charged with an allocation of administrative expense. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their voluntary pre-tax and after-tax contributions plus actual earnings thereon, as well as any rollover contributions, and any Safe Harbor matching contributions. Additionally, participants become fully vested in all of their accounts in the event of attaining normal retirement age, death or becoming disabled while employed with the participating employer.

Vesting in any participating employer matching contributions in participant accounts is based on the adopting employer's election, or on their years of continuous service (based on a minimum of 1,000 hours) with a vesting period to attain 100% vesting of no more than six years.

Payment of Benefits

Upon termination of service, (due to termination, retirement, death or disability or reaching age 59 ½) a participant may elect to receive a distribution equal to the value of his or her vested account balance, as described in the Plan.

Upon reaching normal retirement age of 65, participants are entitled to all of their accounts under the Plan. The Plan follows Internal Revenue Service (IRS) guidance for minimum distributions for participants reaching age 72. Hardship withdrawals may be made in accordance with the Plan and IRS regulations. Benefit payments can be paid as a lump sum, rolled into an IRA account, or another 401(k) plan pursuant to the Plan. Participants reaching age 59 ½ or older may take partial benefit payments. For terminated participants with account balances of \$5,000 or less, the plan administrator may instruct participants to receive a distribution in a lump sum payment.

Forfeitures

Forfeitures may be used to pay Plan administrative expenses, reduce the participating employer matching contribution, and/or as a non-elective contribution. The forfeitures for the non-vested portion of the discretionary profit sharing contribution can also be allocated to participants. At December 31, 2024 and 2023, there were \$8,404 and \$8,997, respectively, of forfeited accounts on hand and available for use. During 2024, forfeitures totaling \$5,183 were used to reduce the employer contributions paid during the Plan year.

Plan Termination

Although it has not expressed any intent to do so, the Adopting Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated by the adopting employer, each participant's benefits become fully vested.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, and follow the Financial Accounting Standards Board (FASB), Accounting Standards Codification, (ASC).

Investment Valuation and Income Recognition

The Plan's Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments sold during the year have been included with unrealized gains and losses for the year as net appreciation (depreciation) of investments in the statement of changes in net assets available for benefits. Net appreciation (depreciation) of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year, which totaled \$375,750.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Administrative Expenses

The Plan Sponsor will serve as the administrator of the Plan for no compensation. The Plan Sponsor may be reimbursed from the trust for reasonable, direct expenses incurred administering the Plan and the Plan may pay a reasonable trustee fee, except to the extent the trust properly pays for such expenses.

Change in Legislation

In December 2022, Securing a Strong Retirement Act (Secure 2.0) was passed into law. The provisions of Secure 2.0 continue the themes and reforms that began with the 2019 Secure Act. Certain provisions became effective in 2024, noting additional provisions will become effective in 2025 and forward. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

Date of Management’s Review

Subsequent events were evaluated through October 8, 2025 which is the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. The plan recognizes transfers of assets into and out of levels as of the date or change in circumstances causes the transfer. There were no significant transfers between level 1 and level 2, and no transfers into or out of level 3 during 2024 and 2023.

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan include open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds may also be valued as determined by an independent pricing service, based on methods which include consideration of: yields or prices of securities of comparable quality, coupon, maturity and type; indications as to values from dealers; and general market conditions.

NOTE C – FAIR VALUE MEASUREMENTS – CONTINUED

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D – TAX STATUS

The Adopting Employer on behalf of the Plan has adopted the Slavic Integrated Administration, Inc. Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan). The Plan has been designed to qualify under Section 401(k) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform to the listing of 401(k) plans that have been pre-approved by the Internal Revenue Service (IRS). The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 401(k). The IRS has determined by a letter dated June 30, 2020, that the Pre-Approved Plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code Section 401.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress. The Plan’s three previous years remain open to inspection by the Internal Revenue Service.

NOTE E – PARTIES-IN-INTEREST TRANSACTIONS

The Adopting Employer provides accounting and administrative services to the Plan at no charge, and may also absorb significant Plan expenses. The Plan allows for participants to take loans, which are secured by participant account balances, which qualifies participant loans as party-in-interest transactions.

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
