Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

December 31, 2024

1. Description of Plan

The following description of the Arclin 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary Plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor, Arclin U.S.A. LLC (Arclin or the Company).

Arclin Surfaces LLC and Arclin Surfaces – East Longmeadow Co. (collectively, Surfaces) is an adopting employer of the Plan.

General

The Plan is a defined contribution plan covering substantially all employees of the Company and Surfaces who have three months of service (except leased and temporary employees, those covered by a collective bargaining agreement, and those employed or transferred to an affiliated employer outside of the U.S., which does not adopt this Plan). Eligible participants are automatically enrolled in the Plan unless they affirmatively decline to participate.

The U.S. Pension Committee (Committee) is responsible for the general administration of the Plan. Charles Schwab Bank is the trustee (Trustee) and record keeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants may contribute up to 100% of pretax annual compensation or on an after (or Roth) basis as defined in the Plan document, limited to \$23,000 in 2024. If automatically enrolled, a participant's deferral is set at 6% of eligible compensation until changed by the participant. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions of \$7,500 for 2024. The Company contributes 70% to 100% of the first 4% to 6% of compensation that a participant contributes to the Plan.

Arclin 401(k) Savings Plan

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching and any discretionary contributions, and allocations of Plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

A participant is 100% vested after five years of credited service for the Company's matching contributions plus earnings thereon. An Arclin participant that was employed by the Company on January 1, 1984, or with an account attributable to PAYSOP contributions, as defined in the Plan document, is 100% vested.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. Forfeited balances are used to reduce future Company contributions. Available forfeited balances as of December 31, 2024 and 2023, were \$31,446 and \$4,540, respectively, and forfeitures used to reduce Company contributions for 2024 were \$109,494.

Investment Options

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Participants who are automatically enrolled have their contributions invested in the applicable lifecycle fund based on their age until they change their election. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan term may not exceed five years, except for the purchase of a primary residence. A participant may not have more than two loans outstanding at any point in time except for loans that were grandfathered where the participants are allowed to pay off their loans pursuant to the original loan terms. The loans bear interest at a rate commensurate with local prevailing rates at the date of issuance as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions. If the loan is not repaid within a reasonable time following termination, it will automatically be offset against the participant's vested account balance and treated as a distribution to the participant.

Payment of Benefits

On termination of service, due to death, disability or retirement, a participant may elect to receive either a lump-sum distribution equal to the value of the participant's vested interest in his or her account, or elect to keep their funds in the Plan (unless the account balance is less than \$5,000, then it must be distributed).

In-service withdrawals are available in certain limited circumstances, as defined by the Plan document. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan document. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS) and a participant must exhaust all available distributions prior to requesting a hardship withdrawal.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. The expenses that are paid from the Plan assets are shared by all participants either on a pro rata basis or an equal dollar basis. Loan establishment fees are also charged to the participant's account. All other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

1. Description of Plan (continued)

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

The Committee is responsible for determining the Plan's valuation policies and analyzing information provided by the trustee that is used to determine the fair value of the Plan's investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Investments

Certain investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, investment earnings (interest, dividends, and capital gain distributions), and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by Charles Schwab Bank, the Trustee of the Plan.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Notes to Financial Statements (continued)

4. Fair Value Measurements (continued)

- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in markets that are not active.
 - Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals).
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan:

Mutual funds and money market fund: valued based on quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end. The NAV is a quoted price in an active market.

Collective trust funds (CTFs): the CTFs primarily comprise of high-quality investments contracts that are valued at the NAV of units of the underlying collective trusts. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Notes to Financial Statements (continued)

4. Fair Value Measurements (continued)

Self-directed brokerage accounts: this is a personal choice retirement account that allows participants to invest their account balances mainly in the following:

- *Common stocks:* valued at the closing price reported on the active market on which the individual securities are traded.
- *Mutual funds and unit investment trusts:* valued based on quoted market prices in active markets, which represent the NAV of shares held by the Plan at year-end.

^(a)The CTFs are stable value funds. The investment objective of the funds is to provide maximum current income while maintaining stability of principal. Upon receipt of a Plan level liquidation request, the fund may schedule liquidation up to 12 months from that date in order to ensure that securities liquidations will be carried out in an orderly business manner. In addition, assets in the fund cannot be transferred directly to competing funds but instead must be first transferred to a different non-competing plan investment option for a period of 90 days.

5. Related-Party and Party-in-Interest Transactions

Charles Schwab Bank provides certain administrative services to the Plan pursuant to a services agreement between the Company and Charles Schwab Bank. Charles Schwab Bank receives revenue from mutual fund and CTF service providers for services Charles Schwab Bank provides to the funds. This revenue is used to offset certain amounts owed to Charles Schwab Bank for its administrative services provided to the Plan.

If the revenue received by Charles Schwab Bank from such mutual fund or CTF service providers exceeds the amount owed under the service agreement, Charles Schwab Bank remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of participants. During 2024 and 2023, there were no excess amounts. The Plan or the Company may make a payment to Charles Schwab Bank for administrative expenses not covered by sharing of the excess revenue.

6. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS dated September 21, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Notes to Financial Statements (continued)

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

8. Subsequent Events

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued. The Company is not aware of any events or transactions that would materially affect the financial statements and supplemental schedule as presented.
