In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Arvest Bank Group Welfare Benefits Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with the modified cash basis of accounting as described in Note 2.

## Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Arvest Bank Group Welfare Benefits Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

## Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States. Our opinion is not modified with respect to that matter.

## Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

#### Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1) Description of plan:

A general description of the Arvest Bank Group Welfare Benefits Plan (Wrap Plan) is provided in the following paragraphs. Participants should refer to the wrap plan document, summary plan description (SPD) and component plan documents for a more complete description of the Wrap Plan's provisions.

General -

Effective January 1, 2024, Arvest Bank Group, Inc. (Employer) adopted the Arvest Bank Group Welfare Benefits Plan and combined SPD, which consolidates all employee welfare benefit programs of the Employer under a single plan document and SPD for administrative and reporting purposes. The Wrap Plan incorporates by reference the terms of the underlying component plan documents, insurance policies, and benefit guides, which collectively define eligibility, benefits, limitations, and claims procedures for each program. The Wrap Plan is intended to qualify as a "welfare plan" under Section 3(1) of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Wrap Plan provides medical, dental, vision, life, accidental death and dismemberment, long-term disability, short-term disability, cafeteria plan, employee assistance, and various voluntary benefits to eligible employees and their dependents, generally defined as the participating employees' spouses and eligible children, once the employee completes the Wrap Plan's waiting period of 45 days. Coverage becomes effective on the first day of the month following completion of the waiting period.

Contributions -

The Wrap Plan is funded by employer contributions, participant contributions, and contributions from former participants electing COBRA coverage. The contribution rate, including the rate for COBRA coverage, varies according to the type of coverage selected, as defined in the Wrap Plan. Participant and employer contributions are recorded throughout the year via payroll deductions, or in the case of employees on unpaid leave of absence and former participants electing COBRA, when the payments are received by the Wrap Plan.

Trust agreement -

The Board of Directors of Arvest Bank Group, Inc. have authorized the execution of the Arvest Bank Group, Inc. Employees Health Benefit Trust (Trust) for the purpose of receiving contributions from the Employer and its employees. The trustees have contracted with third parties to administer the Wrap Plan.

Excess insurance coverage -

The Wrap Plan has reinsurance coverage which, in general, reimburses the Wrap Plan for claims paid and incurred during the policy period over \$525,000, per covered participant. Additionally, aggregate reinsurance coverage is provided when the total of the covered claims exceeds \$310,000 as determined by the provisions of the reinsurance agreement.

Payment of benefits -

The Wrap Plan provides benefit payments to or on behalf of eligible participating employees and their eligible dependents for covered claims, as applicable. Participant claims are processed by UMR, Inc.; Optum Financial, Inc.; Delta Dental; RxBenefits, Inc.; PrudentRx, LLC; and Newtopia, Inc.; however, the responsibility for payment to participants and to third-party service providers is retained by the Wrap Plan.

Note 1) Description of plan: (continued)

Plan termination -

Although it has not expressed any intent to do so, the Employer has the right under the plan documents to terminate the Wrap Plan at any time, subject to the provisions of ERISA. In the event of termination, assets held by the Trust will be used to provide for benefits payable as of the date of such termination and for payment of expenses of the Wrap Plan, including expenses of termination. Any assets remaining after such benefits and expenses will be distributed in accordance with the requirements of Section 501(c)(9) of the Internal Revenue Code (IRC) and the regulations thereunder. If the Wrap Plan is terminated, the termination shall not affect the rights of any participant to claim benefits that are payable prior to the date of termination.

Note 2) Summary of significant accounting policies:

Basis of accounting -

The financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States. Consequently, investment income and contributions are recognized when received, disbursements are recognized when made, and securities investments (if any) are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets and changes in net assets of the Plan in conformity with accounting principles generally accepted in the United States.

Estimates and assumptions -

The preparation of financial statements requires the trustees to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations, and changes therein, liabilities for claims incurred but not reported, eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Cash equivalents -

The trustees consider all highly liquid short-term securities purchased with an original maturity of three months or less to be cash equivalents. However, no such securities were owned by the Wrap Plan during 2024 or 2023.

Administrative expenses -

The Wrap Plan pays administrative expenses that consist primarily of administrative fees paid for regulatory compliance and to third-party service providers for claims processing.

Recent accounting pronouncements -

The trustees have evaluated all recent Financial Accounting Standards Board Accounting Standards Updates issued through October 13, 2025, and determined that no new pronouncements effective for 2024-2025 materially impact the Wrap Plan's financial statement disclosures. The trustees will continue to monitor and disclose any new standards as they are issued and become effective.

**Note 3) Party-in-interest transactions:**

Party-in-interest transactions include relationships with fiduciaries, employees of the Wrap Plan, third-party service providers and the Employer, whose employees are covered by the Wrap Plan. The Wrap Plan maintains certain cash and investment accounts at Arvest Bank, which is the Employer. Fees paid by the Wrap Plan for claims processing totaled \$3,191,170 for UMR, Inc.; \$65,592 for Optum Financial, Inc.; \$276,379 for Delta Dental; \$498,555 for RxBenefits, Inc; \$84,763 for PrudentRx, LLC and \$271,025 for Newtopia, Inc. for the year ended December 31, 2024. Arvest Bank also provides the Wrap Plan with certain accounting and administrative services for which no fees are charged. These transactions are exempt from being prohibited transactions under ERISA.

**Note 4) Concentrations of credit:**

At December 31, 2024, and at various times throughout the year, the Wrap Plan maintains cash balances with Arvest Bank in excess of the federal deposit insurance limit. Arvest Bank is a well-capitalized commercial bank, and in the trustees' opinion, the associated risk is minimal.

**Note 5) Tax status:**

The Trust established under the Wrap Plan to hold the Wrap Plan's assets is qualified pursuant to Section 501(c)(9) of the IRC as a Voluntary Employee Beneficiary Association. Accordingly, the Trust's net investment income is ordinarily exempt from income taxes. The Trust obtained a favorable tax determination letter on August 19, 1988, from the Internal Revenue Service (IRS), and the trustees believe that the Trust and Wrap Plan, as amended, are currently designed and being operated in compliance with the applicable requirements of the IRC.

The Wrap Plan does not recognize a liability for uncertain tax positions. The trustees have analyzed the tax positions taken by the Wrap Plan, and have concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Wrap Plan is subject to routine audits by the IRS; however, there are currently no audits in process for any open tax periods. The trustees believe the Wrap Plan's annual return is no longer subject to income tax examinations for plan years prior to 2021.

**Note 6) Benefit obligations:**

Due to the Wrap Plan's use of the modified cash basis of accounting, certain claims relating to the years ended December 31, 2024 and 2023, were not paid or accrued as of December 31, 2024 and 2023. Health and dental claims payable include the Wrap Plan's liability for claims incurred but not reported, and the Wrap Plan's liability for claims reported but not yet processed. Such amounts total approximately \$4,941,000 and \$4,167,000 at December 31, 2024 and 2023, respectively. The Wrap Plan's liability for claims incurred but not reported are estimates which are based upon actual claims paid subsequent to year end and claim run-off experience and are subject to uncertainty.

**Note 7) Fair values of financial instruments:**

The Wrap Plan's only financial instruments are its cash and interest-bearing deposits. The carrying value of such financial instruments is their fair value.

**Note 8) Reconciliation of financial statements to IRS Form 5500:**

Net assets available for benefits at December 31, 2024 and 2023, as disclosed in IRS Form 5500 were \$2,740,588 and \$5,705,973, respectively. These amounts are identical to that reported in the statements of net assets available for benefits.

Decrease in net assets available for benefits for the year ended December 31, 2024, as disclosed in IRS Form 5500, totaled \$2,965,385. This amount is identical to that reported in the statement of changes in net assets available for benefits.

Contributions for the year ended December 31, 2024, as disclosed in IRS Form 5500, totaled \$62,240,725. This amount is identical to that reported in the statement of changes in net assets available for benefits.

Benefit payments for the year ended December 31, 2024, as disclosed in IRS Form 5500, totaled \$62,658,609. This amount is identical to that reported in the statement of changes in net assets available for benefits.

**Note 9) Transfer of assets to the Arvest Bank Group Welfare Benefits Plan:**

Effective January 1, 2024, the Employer consolidated its previously separate welfare benefit plans into the Wrap Plan. In connection with this consolidation, all assets and obligations of the prior welfare benefit plans were transferred to the Wrap Plan as of the effective date. The purpose of this transfer was to streamline plan administration, ensure compliance with ERISA Section 3(1), and facilitate the filing of a single consolidated Form 5500 for the plan year. For accounting purposes, the transfer of assets and obligations was recognized as of January 1, 2024, with no gain or loss recognized, as the transaction represented a transfer between plans under common control and did not affect the underlying benefit obligations to participants.

**Note 10) Subsequent events:**

The trustees have evaluated subsequent events through October 13, 2025, the date which the financial statements were available for release. The trustees are not aware of any subsequent events that would require recognition or disclosure in the financial statements.
