Scope and Nature of ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Suffolk Credit Union Capital Accumulation Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

Opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Suffolk Credit Union Capital Accumulation Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time and part-time employees of Suffolk Credit Union and Credit Union Services, LLC (the “Company”), who have completed six months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Administrative Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Effective January 2024, the Plan was amended, the Plan sponsor’s name was changed to Suffolk Credit Union, and the Plan’s name was changed to Suffolk Credit Union Capital Accumulation Plan.

Contributions

Each year, participants may contribute up to 100% of their annual eligible compensation, as defined by the Plan, not to exceed the threshold amounts permitted under the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan is currently invested in common collective investment funds, mutual funds, and a fixed deferred annuity contract and offers these investment options for participants. Effective January 1, 2023, the Plan included an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company contributes 100% of the first 3% of base compensation that a participant contributes to the Plan plus 50% of the amount of base compensation that a participant contributes to the Plan that exceeds 3% up to a maximum of 5% of base compensation. These safe harbor matching contributions are 100% vested. The Company may also elect to make a profit sharing contribution to each participant’s account based on his or her eligible compensation and length of service. Participants direct the investment of their contributions and all employer contributions into various investment options offered by the Plan.

Contributions (continued)

For the year ended December 31, 2024, the Company made employer matching contributions to the Plan of \$485,158; and reported an employee profit-sharing contribution to the Plan of \$409,985; of which no amounts were reallocated from the Plan's forfeited nonvested accounts (see Note 1 for forfeited accounts). The profit-sharing contribution was remitted to the Plan in 2025. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching and profit sharing contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and rollover contributions plus actual earnings thereon. Participants are 100% vested in the Company's "safe-harbor" contributions plus any earnings generated on those funds. Other employer contributions to the Plan, plus any earnings they generate, are vested based upon years of continuous service. Participant's vest in the Company's profit-sharing contribution, if any, based on the schedule below:

Notes Receivable from Participants

Participants may borrow from their investment fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's accounts. The loans bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a certain period, as defined by the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$143,000 and \$84,000, respectively. These accounts will be used to reduce future Company contributions. No amounts were used from forfeited nonvested accounts to reduce the Company's profit sharing contribution remitted in 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, the custodian and the insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024 and 2023, there were no allowance for credit losses reported related to the notes receivable from participants. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events Evaluation by Management

Plan management has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification 820, "*Fair Value Measurements and Disclosures*", provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Deferred Group Annuity Contract: Investments in fixed deferred group annuity contracts are valued at contract value which approximates fair value and guarantees protection of principal with a set rate of return. Participants in the contract do not participate in the performance of the general account, but the investment performance of that portfolio supports the contract's minimum guaranteed interest rate, any additional amounts, and payout obligations. Any administrative or investment fees are deducted from credited interest rates. Withdrawals are subject to a market value adjustment.

Common Collective Investment Funds: Investments in common/collective investment funds are valued at the NAV of units of a common fund. The NAV, provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Fully Benefit-Responsive Deposit Administration Group Annuity

The Plan has a fully benefit-responsive Deposit Administration Group Annuity ("DAGA") operated by CMFG Life Insurance Company ("CMFG") that is comprised of fixed group annuity contracts. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relative measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2024 and 2023, contract value approximates fair value.

4. Fully Benefit-Responsive Deposit Administration Group Annuity (*continued*)

The traditional investment contract held by the Plan is a fixed deferred group annuity. It provides guaranteed protection of principal and interest with a set rate of return and provides contractual protection against a change in the participant's account value due to interest rate volatility. The guarantee in this contract is backed by CMFG Life Insurance Company and supported by its general account. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The interest rates are reviewed quarterly and are subject to change. All interest rate changes are declared in advance. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The contract cannot be terminated under normal circumstances by the insurance company. The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA, or (e) termination of the contract. The Plan administrator does not believe that any events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers or the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misrepresentation, or (d) a material amendment to the agreement without the consent of the issuer. The fixed group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The average yield earned by the contract was 2.05% based on actual earnings and based on interest rates credited to participants for the years ended December 31, 2024 and 2023. As of December 31, 2024 and 2023, the contract value was \$347,513 and \$464,178, respectively.

5. Common/Collective Trust

At December 31, 2024 and 2023, certain assets of the Plan were invested in the Morely Stable Value Fund Class 3.

The Morely Stable Value Fund Class 3 invests in a blend of asset classes from within the Bloomberg U.S. Aggregate Bond Index, focusing on short to intermediate maturities and providing diversified exposure to investment grade debt from the government, credit and structured sectors of the bond market.

The NAV per unit of the trust is determined each business day. Issuances and redemptions may be on such days, based upon the NAV per unit as of the valuation date last preceding the date on which such order to contribute or redeem assets is received. The trustee of the trust, in its sole discretion reserves the right to value any contribution or redemption as of the next succeeding valuation date or another date as the trustee deemed appropriate. The investments valued at NAV have no unfunded commitments at December 31, 2024 and 2023.

6. Related-Party and Party-In-Interest Transactions

Certain Plan investments include shares in the Schwab Government Money Fund which is managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the custodian of the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

7. Due to Plan Sponsor

During the 2024 plan year, the Employer determined that certain participants received overpayments related to Employer contributions amounting to \$4,051. These amounts were used to offset a future deposit in March 2025.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

9. Tax Status

The Plan is a volume submitter profit sharing plan with Cash or Deferred Arrangement ("CODA"). The Internal Revenue Service (IRS) issued an opinion letter dated November 30, 2020, that the prototype non-standardized profit-sharing plan is acceptable with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and related trust is tax-exempt.

9. Tax Status (*continued*)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and the net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate Charles Schwab Trust Bank, and CMFG Mutual Life Insurance Company, qualified institutions.

11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Investment Concentrations

At December 31, 2024, three investments in mutual funds held by the Plan amounted to approximately \$5,180,000 or 33%, of total assets held for investment. At December 31, 2023, three investments in mutual funds held by the Plan amounted to approximately \$4,227,000 or 33% of total assets held for investment.
