Opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of The Burke Group Welfare Benefit Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions, which is available from the plan administrator.

General

The Plan, as amended, is a multiple-employer plan that provides health and other benefits to all eligible participants and dependents of the Burke Group. The participating employers are Burke Group engineering and surveying companies with some level of common ownership and include the following: Emerald Site Services, LLC, Thomson Surveying Ltd., Camplin Environmental Services, Inc., Mackie Consultants, LLC, Spaceco, Inc., Christopher B. Burke Engineering, Ltd., Christopher B. Burke Engineering, LLC, Land and Water Resources Inc., and Kenig Lindgren O’Hara & Aboona Inc. (the “Companies”). The benefits offered through this plan are administered by Christopher B. Burke Engineering, Ltd.

During January 2023, the Plan was notified of Emerald Site Services, LLC termination of its participation in the Plan. Termination was effective March 1, 2023.

Certain Plan assets are held in a voluntary employees’ beneficiary association (“VEBA”) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Benefits

The Plan provides health benefits (medical, dental, vision, and prescription drugs), life insurance, short- and long-term disability benefits, and accidental death and dismemberment benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”).

Insured Benefits

The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and dismemberment benefits (basic, supplemental, and spousal), and short- and long-term disability benefits. The Companies purchase annual insurance contracts for these insured benefits. Premiums for basic life insurance and basic accidental death and dismemberment insurance programs are paid to the insurance company from the general assets of the Companies. Premiums for all other insured benefits are paid from the assets of the VEBA trust.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Self-insured Benefits

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only ("ASO") arrangements. Claims are paid by either the Plan's VEBA trust or the general assets of the Companies.

The Plan utilizes a pharmacy benefit manager ("PBM") to help control drug costs. The PBM pays rebates to the Plan based on the Plan's actual utilization pattern of specific drugs. There is an inherent lag in between the periodic capture and calculation of rebates due to the Plan and receipt of such funds.

The Plan has a health reimbursement arrangement ("HRA") that is funded solely through the Companies' contributions. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses up to a maximum dollar amount for a coverage period. Amounts remaining at the end of the year can generally be carried over to the next year. The employer is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical expenses; and remaining amounts are not portable upon termination once the employee leaves the employer.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. The Companies pay the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop-loss insurance. The Companies make contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded on a pay-as-you-go basis.

Stop-loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Cash

Cash includes all cash balances and highly liquid investments having original maturities of three months or less.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits

Premiums paid by either the Companies or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid.

Benefit Obligations

Benefit claims currently payable include the Plan's liability for claims incurred but not reported as of December 31, 2024 and 2023, and claims reported but not yet processed as of December 31, 2024 and 2023. The Plan's liability for claims incurred but not reported is estimated based on the expected time period from the date such claims are incurred to the date that the related claims are submitted and paid.

Stop Loss

Premiums for stop-loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop-loss refunds totaling \$63,290 for the year ended December 31, 2024, have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Rebates

Rebates due from the Plan's PBM are recorded when earned. Rebates due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$244,134 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Health Reimbursement Arrangement

Included in the accompanying statements of net assets available for benefits are amounts available to reimburse participants for qualifying medical expenses as of December 31, 2024 and 2023, totaling \$82,794 and \$60,882, respectively. Claims incurred before plan year-end that were submitted after year-end (but before the date defined by the plan agreement) totaled \$42,862 and \$36,326 relating to 2024 and 2023, respectively. Forfeited amounts were used by the Companies to offset the Companies' contributions in the year forfeited.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Companies on behalf of the Plan.

NOTE 3 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

NOTE 4 - PLAN TERMINATION

Although they have not expressed any intention to do so, the Companies have the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Companies or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 6 - TAX STATUS

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service ("IRS") dated October 6, 1997, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code ("IRC"). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - CONCENTRATION OF CREDIT RISK

There is a concentration of credit risk arising from cash balances in excess of federally insured limits of \$250,000. The plan administrator believes the Plan is not exposed to any significant loss.

NOTE 8 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.



