Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of PKG Contracting, Inc. Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about PKG Contracting, Inc. Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule of Delinquent Participant Contributions and Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 – DESCRIPTION OF PLAN

The following description of the PKG Contracting, Inc. (“Company”) Retirement Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors oversees governance of the Plan. The Board also determines the appropriateness of the Plan’s investment offerings and monitors investment performance. The Plan covers all employees who meet the following minimum requirements:

- a) age 18 (for employee elective deferrals and employer match – effective as of January 1, 2023), this changed from age 21 (for employee elective deferrals and employer match – prior to January 1, 2023)
- b) one year of service and 1,000 hours (for employer match)
- c) 250 hours worked during three (3) consecutive months (for employee elective deferrals).
- d) long-term part-time employees (LTPT) – you will be considered LTPT who has not entered the Plan as regular participant, but who is credited with 500 hours for at least three consecutive years beginning after December 31, 2020 (with the same age requirement as other participants)

Coverage begins on the first day of the month in which a participant meets the age and service requirements.

The Plan was originally established on January 1, 2003. The Plan’s year-end is December 31.

The Plan has been restated for the law changes and regulations, which is required by the Internal Revenue Service for all qualified plans every six years and there was a new determination letter obtained for a Non-standardized Pre-Approved Profit-Sharing Plan/Money Purchase/CODA that was obtained for the Plan’s TPA. The letter is dated June 30, 2020. The Plan has been restated with an effective date of January 1, 2021.

Contributions

Employees who meet the minimum requirements may begin making contributions to the Plan. A participant may contribute up to the maximum elective deferral of \$23,000 and \$22,500 for 2024 and 2023, respectively. If the participant is age 50 and older, an additional \$7,500 catch-up contribution is allowed for both 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants may direct contributions in a variety of mutual funds. The Plan includes an auto-enrollment feature whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate with a default deferral rate set at 6.0% of eligible compensation. Contributions are automatically invested in a designated fund based on the projected participant’s retirement age until changed by the participant. The Company contributes 50% of the first 6% of eligible compensation that a participant contributes to the Plan.

Contributions (continued)

The Company will make a prevailing wage contribution on behalf of each participant who performs services subject to the Service Contract Act, Davis-Bacon Act or similar federal, state, or municipal prevailing wage statutes. The prevailing wage contribution will be an amount equal to the remaining balance of the participant's actual pay rate, including fringe benefits, versus the wage scale/pay rate and fringe benefits for a participant's employment/job classification. The Company keeps track and has a record of the contribution rate(s) applicable to the prevailing wage calculation for each participant.

The Company can also make a discretionary profit-sharing contribution each year on behalf of all employees who meet the minimum requirements for the current year, and are employed at the end of the year. If the Company elects to make a profit-sharing contribution, it must be made by the due date of the Company's income tax return, including extensions. The Company has elected not to make a discretionary contribution for 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings, as well as their prevailing wage contributions thereon. Vesting in the Company's contribution portion of their accounts and earnings thereon is based on years of continuous service as follows:

2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

Participants become fully vested upon death, disablement, plan termination, or attainment of normal retirement age.

Notes Receivable from Participants

The Plan does not provide for participant loans.

Payment of Benefits

Upon retirement (normal retirement age is 65), attaining age 55 (early retirement age), or severance of employment as defined by the Plan, employees may request distribution of their vested balance in the form of a lump-sum distribution, single sum distribution, or installments for a specified term. Upon death of a participant, a death benefit equal to the value of all of the employee's accounts is paid to the employee's beneficiary. Active employees who become totally disabled become fully vested and are eligible to receive benefits in the form described above. Minimum distributions generally begin between 72 and 75, depending on when the participant was born.

Forfeitures

If the participant is not fully vested at the time of employment termination, the nonvested portion of the participant's account is forfeited. These funds may be used to reduce employer contributions. The Plan document also allows for forfeitures to reduce or pay plan expenses. For 2024 and 2023, forfeitures were deposited into the Holding account and used mostly to pay plan expenses and also a portion was used to offset the employer matching contribution. At December 31, 2024 and 2023, forfeitures totaled \$ 21,836 and \$ 4,772, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

These financial statements are prepared under the accrual method of accounting.

Investments held by the Plan are required to be reported at fair value. The Plan has no Fully Benefit Responsive Investment Contracts that would have to be reported.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between the market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and are reported as part of the net appreciation (depreciation) in fair value of investments, which also includes the Plan's gains and losses on investment bought and sold during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The Plan pays substantially all of the costs to administer the Plan for the year ended December 31, 2024 and 2023.

Date of Management's Review

Subsequent events were evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – CERTIFICATION OF INVESTMENT INFORMATION

Bell Bank, the trustee of the Plan, has supplied the Plan administrator with two certifications as to the completeness and accuracy of all investment information reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, Statement of Changes in Net Assets Available for Benefits for the period November 13, 2024 and the second period November 14, 2024 thru December 31, 2024, and the Supplemental Schedule of Assets (held at end of year) as of December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used when Level 1 or Level 2 inputs were not available. Level 1 inputs were available for all investments so there were no Level 2 or Level 3 inputs used.

Level 1 Fair Value Measurements

The fair value of the money market account and mutual funds are based on quoted net asset values of the shares as reported by the fund. The mutual funds held are mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The fair values of common stock, corporate bonds, and U.S. Government securities are based on the closing prices reported on the active market where the individual securities are traded.

NOTE 5 – RELATED PARTY TRANSACTIONS

For the years ended December 31, 2024 and 2023, the administration fees were paid by the Plan and are included in administrative expenses, which totals \$ 29,381 and \$ 32,314, respectively. Fees related to the distributions paid to participants during the years ended December 31, 2024 and 2023 are also included in administrative expenses. Fees paid by plan participants totaled \$ 2,865 and \$ 1,533 for the years ended December 31, 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The Internal Revenue Service has determined and informed Capital Group Retirement Plan Services by a letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – RECONCILIATION WITH FORM 5500

There are no reconciling differences with the 2024 Form 5500.
