Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Summit Radiology, P.C. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Plan Description

General

The Summit Radiology, P.C. Profit Sharing Plan (the "Plan") is a defined contribution retirement plan sponsored by Summit Radiology, P.C. and its related participating employer, Synergy Radiology LLC (collectively the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information.

Eligibility

Effective January 1, 2024, to be eligible to participate in elective deferrals, employees must have completed one month of service and have attained age 21. To be eligible to participate in the safe harbor match and profit sharing contributions of the Plan, employees must have completed one year of service and have attained age 21. Participants may enter the Plan on the first day of the month coinciding with or following the date eligibility requirements have been met.

Contributions

Participants may make voluntary pre-tax and Roth contributions up to 100% of compensation limited to the applicable limit under the Internal Revenue Code. The Plan provides for an automatic savings increase provision in which a participant's contribution rate will increase by 1% per year up to a maximum of 4% of eligible compensation until an affirmative election is made by the respective participant.

The Company makes a safe harbor match of 100% of participant contributions up to 4% of eligible compensation. The Company may also make a discretionary profit sharing contribution. For the year ended December 31, 2024, the discretionary profit sharing contribution was approximately \$1,400,000.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company safe harbor match, an allocation of the Company's profit sharing contribution (if any), Plan earnings and administrative expenses. Allocations of the Company's profit sharing contribution and Plan earnings and administrative expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into a variety of investment options offered by Charles Schwab Trust Bank, the custodian of the Plan. All amounts in participant accounts are participant-directed. Participants may change their investment options daily.

Note 1. Plan Description (Continued)

Vesting

Participants are immediately vested in their elective (voluntary) contributions and Company safe harbor contributions and income or loss thereon. Vesting in the Company's profit sharing contribution is based on years of service. A participant becomes 50% vested after two years of service with full vesting after three years of credited service.

Notes Receivable from Participants

The Plan allows participants to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Only one loan can be outstanding at any time. Loans are typically for terms up to 5 years, but may be for a longer period if the purpose of the loan is for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with current prevailing rates (determined at origination). Loans outstanding at December 31, 2024, mature through June 2029 and bear interest at rates ranging from 3.25% through 8.50%.

Forfeitures

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their profit sharing contributions. These forfeitures are used to reduce Company contributions, added to Company contributions or pay Plan expenses. Forfeitures used to reduce Company contributions amounted to approximately \$25,000 for the year ended December 31, 2024. At December 31, 2024 and 2023, there was approximately \$0 and \$500 available to be used to reduce future Company contributions, add to Company contributions or pay Plan expenses.

Benefit Payments

Benefit payments are payable as a single lump-sum payment or installments. The full value of a participant's account is payable upon retirement, death or disability. The Plan allows hardship distributions, as defined in the Plan document. Additionally, rollover funds are always available for distribution.

Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Note 2. Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Payment of benefits to participants is recorded when paid.

Operating Expenses

Certain accounting and legal expenses of maintaining the Plan are paid by the Company. Other operating expenses including loan fees, recordkeeping fees, custodial fees and investment advisor fees are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan Administrator has evaluated events and transactions for possible recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, as custodian, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule, schedule of assets (held at end of year), as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.

Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.

Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued \$1 per share held by the Plan at year end.

Mutual funds: Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party Transactions

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation. Administrative expenses for legal, accounting, and other services are rendered by parties-in-interest and are paid by the Company.

Note 6. Income Tax Status

The Plan, which is a prototype plan, obtained an opinion letter on August 1, 2023, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code ("IRC") and therefore not subject to tax. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6. Income Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Subsequent Amendment

Effective January 1, 2025, the Plan was amended and restated. Significant changes include the removal of the safe harbor match, the addition of a safe harbor contribution of 3% of eligible compensation, the addition of a discretionary employer match, eligibility for deferrals is one year of service to align eligibility for all contribution types, the removal of auto escalation for deferrals, and the option for forfeitures to be added to employer contributions was removed.

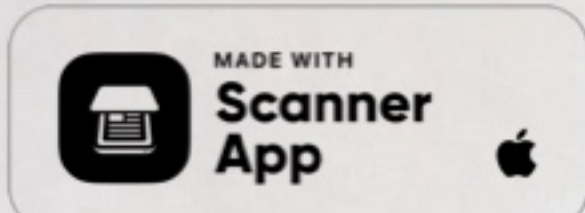
