Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of assets (held at end of year) and Schedule H, Line 4a – Schedule of delinquent participant contributions as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A -- Description of the plan and significant accounting policies

The following description of the Lemman U.S.A. Inc. Profit Sharing/401(K) Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Lemman U.S.A., Inc ("the company") adopted the Great-West Trust Company, LLC Non-Standardized Defined Contribution Pre-Approved Plan, effective July 9, 2021. The initial effective date of the Plan was January 1, 1988.

General

The Plan is a defined contribution plan covering all eligible employees of Lemman U.S.A, Inc. who have completed 30 days of service and are age 21 or older. To be eligible for the non-elective safe harbor and discretionary employer contributions, an employee must complete 1,000 hours of service during the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(K) Committee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

The Plan's federal identification number is 39-1539537, and the Plan's number is 001.

Contributions

Each year, participants may contribute up to 50% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan has an automatic escalation feature in which the auto enrollment percentage increases by 1% on May 1 of each year to a maximum of 5%. The company contributes 3% of eligible employee compensation as a non-elective safe harbor contribution. The company also has the right to make additional contributions based on a uniform percentage of participant compensation. There were no discretionary contributions made in 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$102,219 and \$80,458, respectively. These accounts may be used as additional discretionary non-elective employer contributions or to pay Plan expenses. In 2024, employer non-elective safe harbor contributions and plan expenses were reduced by \$0 from forfeited nonvested accounts.

Contributions receivable

Contributions receivable are written off when they are determined to be uncollectible. The allowance for credit losses is estimated based on expected credit losses considering the Plan's historical losses, existing economic conditions, and the financial stability of the company.

Participant accounts and "rollovers"

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's non-elective safe harbor and discretionary contribution, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocation of company contributions are based on participant compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

Vesting

Participants are vested immediately in their contributions and non-elective safe harbor contributions plus actual earnings thereon. Vesting in the company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested on a 6-year graded schedule. Participants who leave the Plan because of death or disability, as defined in the Plan, are considered 100% vested in all amounts.

Benefits

On termination of service due to death, disability or retirement (age 65), or other reasons, a participant with a vested account balance valued at less than \$5,000 shall receive the value of the vested interest in his or her account as a lump-sum distribution. For accounts exceeding \$5,000, the participant may elect a lump-sum distribution, installment payments, a life annuity; defer such distribution to any valuation date subsequent to his or her termination, but no later than the valuation date of his or her normal retirement date; or elect to rollover the distribution to another qualified plan. The Plan permits in-service distributions at age 59½. The Plan also permits hardship distributions if certain criteria are met.

Participant loans

Participants may not borrow from their fund accounts.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(K) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The plan sponsor and employer pay most of the administrative expenses of the Plan, which are excluded from these financial statements. The major administrative expenses are recordkeeping and investment advisory fees.

Subsequent events

These financial statements have not been updated for subsequent events occurring after October 14, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

NOTE B -- Information certified by the asset custodian and trustee

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and interest and dividends, net appreciation and other income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, the asset custodian of the Plan.

This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Stable value collective fund. A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.
- Index collective trust fund. Index funds that are composed of stocks, mutual funds, short-term investments, etc. The underlying investments for the fund have observable (Level 1 and Level 2) inputs, including quoted market prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the net asset value of the separate account is not publicly quoted. Net asset value of the separate account is used as the practical expedient to estimate fair value.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

NOTE D -- Party-in-interest transactions

JPMorgan Chase Bank, N.A. ("JPMorgan") is the recordkeeper and is therefore designated as fiduciary and party-in-interest. The plan regularly invests in mutual funds for which JPMorgan Chase Bank, N.A. or its affiliates are the issuing parties. These party-in-interest transactions occur in the course of ordinary business and are exempt transactions.

Fees paid during the year for recordkeeping to JPMorgan and investment advisory services to Global Retirement Partners LLC and Wealth Advisory Services LLC, parties-in-interest were based on customary and reasonable rates for such services.

JPMorgan provides certain administrative expenses to the Plan pursuant to a Master Plan Services Agreement (MSA) between the company and JPMorgan. JPMorgan receives revenue from mutual fund service providers for services JPMorgan provides to the funds. This revenue is used to offset certain amounts owed to JPMorgan for its administrative services to the Plan.

If the revenue by JPMorgan from such mutual fund service providers exceeds the amounts owed, JPMorgan remits the excess amount on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses. During 2024, there were excess amounts of \$65, which is included in other income on the Statements of Changes in Net Assets Available for Benefits.

NOTE E -- Plan termination

Although it has not expressed any intent to do so, the company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their allocated employer discretionary contributions.

NOTE F -- Tax status

The Great-West Trust Company, LLC Non-Standardized Defined Contribution Pre-Approved Plan, that the Plan adopted effective July 9, 2021, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been restated since the date of the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE G -- Concentration of market risks

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
