SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT OF THE 2024 FINANCIAL STATEMENTS

We have performed an audit of the financial statements of 403(b) Thrift Plan for Employees of United Neighborhood Health Services, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. RESPONSIBILITIES OF MANAGEMENT FOR THE 2024 FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of 403(b) Thrift Plan for Employees of United Neighborhood Health Services, Inc. (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant directed defined contribution plan, covering substantially all eligible employees of United Neighborhood Health Services, Inc. (the "Employer"). The Employer is a non-profit organization as determined by Section 501(c)(3) of the Internal Revenue Code (the "IRC"). Therefore, the Plan is subject to the provisions governing 403(b) plans of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The purpose of the Plan is to provide retirement benefits for participants and their beneficiaries. The Plan, originally effective January 1, 2014, has been amended and restated subsequent to its effective date to modify certain Plan provisions and comply with applicable tax regulations. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On March 31, 2023, the Employer entered into an Agreement and Plan of Merger (the "Agreement") with Salvus Center, Inc. ("Salvus"). Employees of Salvus became eligible for the Plan effective January 1, 2024. These participants, if employed as of December 31, 2023, are also eligible for prior service credit in the Plan for service completed with Salvus for purposes of eligibility and vesting in all contributions.

Effective January 1, 2024, the Plan was amended to become a multiemployer plan. As of the date of the auditors' report, no additional employers have joined the Plan.

Eligibility

All employees, other than non-resident aliens, are eligible to participate in the Plan beginning immediately on the first of the month upon hire, as defined in the plan document. The Plan includes automatic enrollment for all new employees after 30 days of employment with a required pre-tax salary deferral of 1% of eligible compensation, unless electing otherwise.

Participants, other than pro re nata ("PRN") employees, are eligible for Employer matching contributions after completing six months of service, as defined in the plan document. Employer matching contributions begin on the first of the month following the satisfaction of the eligibility requirements.

The Plan allows for Employer discretionary base contributions to eligible participants. Eligibility requirements are the same as the Employer matching contributions. There were no such contributions made during the year ended December 31, 2024.

Contributions

Each year, participants may elect to defer up to 100% of their compensation, as defined in the plan document. Participants may also contribute amounts representing distributions from other qualified plans. Participants may change their salary deferral percentage at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

Employer matching contributions are allowed under the Plan, and are calculated using a discretionary rate as determined by management. The matching rate was up to 3% in both 2024 and 2023.

Contributions are subject to certain limitations in accordance with applicable regulatory requirements.

Participant accounts

Each participant's account is credited with the participant's contributions, allocations of Employer contributions and plan earnings, and reduced by an allocation of administrative expenses, any distributions and plan losses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in Employer contributions is based on years of continuous service. Participants vest at 20% after one year of service, 60% after two years of service and become 100% vested after three years of service, as defined in the plan document. Participants become fully vested upon death, total and permanent disability, and reaching normal retirement (age 65).

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at variable rates which are commensurate with prevailing rates as determined by the Plan Administrator. Loan terms are for a maximum of 5 years, or longer if used for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024 and 2023, all outstanding loans had an interest rate of 5.85% and 4.60%, respectively.

Payment of benefits

Benefit distributions equal to a participant's vested account balance are payable to the participant or their beneficiaries upon normal retirement, death, disability or termination of employment. The method of distribution shall be determined by the Plan Administrator in accordance with the provisions of the Plan.

In-service withdrawals

In-service withdrawals are permitted by participants who have reached the age of 59 and 1/2. Earlier withdrawals may also be made in the case of financial hardship, as determined by the Employer.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

Forfeitures

Forfeitures result from termination of employment under circumstances which do not entitle the participant to be fully vested in his Employer contributions and are available to be used to reduce Employer contributions. Forfeitures of \$8,730 were used to reduce Employer contributions during 2024. There were no forfeiture balances remaining at December 31, 2024 or 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the Custodian. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measure of that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. See Note 5 for discussion of investments at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the Employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses as incurred.

No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefit payments are recognized in the year paid.

Expenses

Substantially all expenses of maintaining the Plan are paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Recent regulatory update

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

Events occurring after reporting date

The Plan has evaluated events and transactions that occurred between December 31, 2024 and October 13, 2025, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN

Except for the fair value of the investment contract, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified by Mutual of America Life Insurance Company, the Custodian of the Plan. The contract value of the investment contract was certified by the Custodian.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

NOTE 4 - FAIR VALUE

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using unadjusted quoted prices from active markets for identical assets), Level 2 (not traded on an active market, but for which observable market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value:

Separate accounts	Valued based on net asset value (NAV), which is determined daily, of the units of participation in the account held by the Plan. On a daily basis, the units of participation are revalued to reflect the performance of the underlying mutual funds less any fees and charges. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no participant redemption restrictions for these investments; the notice period is applicable only to the Plan. If the Plan initiates a full redemption of the account, the issuer reserves the right to require 30 days notification in order to ensure that security liquidations will be carried out in an orderly business manner.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

The description of the significant investment strategies for each category of investment in the separate accounts follows:

- (a) These funds seek current income along with preservation of capital. They invest primarily in investment-grade, publicly traded debt securities which include bonds issued by the U.S. Government, its agencies, and U.S. corporations.
- (b) These funds seek long-term growth of capital with investments in common stocks of companies with medium market capitalization. Investments would include domestic and foreign issuers.
- (c) These funds seek capital appreciation by investing in growth stocks issued by companies with small-sized market capitalization believed to possess growth potential.
- (d) This category seeks to provide long-term capital appreciation primarily through investing in stocks of companies located outside of the United States. Stocks selected are believed to possess above-average growth potential.
- (e) These funds seek current income and capital appreciation appropriate for the asset allocation associated with the target retirement dates. As the target retirement dates approach, the funds move towards preservation of capital and production of income.
- (f) These funds invest in a mix of equity funds and fixed funds to achieve a specific proportion of asset classes or to vary the composition in response to changes in the economy and investment markets. They seek a mix of current income and capital appreciation.
- (g) These funds invest primarily in common stocks that seek investment results that correspond to the performance of the S&P 500 Index.
- (h) These funds seek long-term capital appreciation through investments primarily in common stocks of large and medium-sized growth companies.
- (i) This fund seeks current income to the extent consistent with maintenance of liquidity, investment quality and stability of capital.
- (j) This fund seeks to provide a high level of income and moderate long-term capital appreciation by tracking the performance of publicly traded equity REITs and other real estate-related investments.
- (k) This portfolio seeks to obtain high total return with reduced risk over the long-term by allocating the assets among stocks, bonds and short-term investments. It may invest in securities of domestic and foreign issuers.
- (l) Large-blend funds are fairly representative of the overall U.S. stock market in size, growth rates, and price. Stocks in the top 70% of the capitalization of the U.S. equity market are defined as large cap. The blend style is assigned to portfolios where neither growth nor value characteristics predominate. These portfolios tend to invest across the spectrum of U.S. industries and, owing to their broad exposure, the portfolios' returns are often similar to those of the S&P 500 Index.

NOTE 5 - INVESTMENTS AT CONTRACT VALUE

The Plan holds investment contracts that meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. The following represents the disaggregation of contract value between types of investment contracts held by the Plan:

With traditional investment contracts, the Plan owns only the contract itself; the underlying assets are owned by the contract issuer. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers. The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0.15% or more than 3.00% in any event. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date. The credited interest rates at December 31, 2024 and 2023 were 2.85% and 1.60%, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Such events include the following: (1) failure to timely remit payment of administrative charges, (2) a breach of the terms under the contract, (3) discontinuance of the applicable class of annuity contract or (4) failure to transmit and receive information and data through appropriate means.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligations under the contract, (3) a material misrepresentation or (4) a material amendment to the agreements without the consent of the issuer.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in investment securities which are exposed to various risks, such as interest rate, credit and overall market risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

At December 31, 2024 and 2023, the Plan had a concentration of investments in four accounts, which represented approximately 57% and 58%, respectively, of total investments.

NOTE 7 - INCOME TAX STATUS

The Plan has adopted a 403(b) prototype plan (Prototype). The Prototype received its latest opinion letter on March 2, 2020, in which the Internal Revenue Service ("IRS") stated the Prototype, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not applied for a separate determination letter.

The Prototype has been amended and restated since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan and Prototype are designed and have been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been provided in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

NOTE 8 - NONEXEMPT TRANSACTIONS

During 2024 and 2023, the Employer failed to remit timely \$21,741 and \$79,568, respectively, of participant contributions to the Plan. To comply with ERISA requirements for timely remittance of participant contributions, the Employer is required to segregate employee contributions from its general assets as soon as practicable. Late remittances constitute loans from the Plan to the Employer, which are prohibited transactions. The Employer is required to report these transactions to the Department of Labor and pay the specified penalty taxes. Additionally, the Employer is required to calculate lost earnings for those participants affected during the year and remit such amounts to the Plan. In management's opinion, the amount of such lost earnings is not significant and has not been accrued in the accompanying financial statements.

NOTE 9 - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Plan investments are held by the Custodian, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, rather than a direct payment.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

These party-in-interest transactions are exempt from the prohibited transactions provisions of ERISA and the IRC.

NOTE 10 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.
