INDEPENDENT AUDITOR'S REPORT

To the Board of Directors and Participants
Nisshinbo Automotive 401(k) Plan
Covington, Georgia

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nisshinbo Automotive 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Nisshinbo Automotive 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America;

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Nisshinbo Automotive 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Nisshinbo Automotive 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards ("GAAS") will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Nisshinbo Automotive 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Nisshinbo Automotive 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally

accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF PLAN

The following is a brief description of the Nisshinbo Automotive 401(k) Plan (the "Plan"). Participants or other interested parties should refer to the Plan Agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan adopted by Nisshinbo Automotive Manufacturing, Inc. (the "Company"), effective January 1, 1999, to provide deferred tax benefits, savings, and matching employer contributions to eligible employees. The Plan was restated on January 1, 2022, and is subject to certain provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company is the Plan administrator, and the President of the Company is the trustee of the Plan. The Standard Insurance Company ("The Standard") acquired the recordkeeping business for retirement plans from Securian Financial Group ("Securian") on December 1, 2022. As a result of this acquisition, Securian fully transitioned the recordkeeping and administration of the Plan to The Standard in 2023. The underlying insurance contracts issued by Minnesota Life Insurance Company ("Minnesota Life") remain in effect. The Standard has taken over the administrative function, but the guarantee and obligations of the insurance product remain with Minnesota Life. The Plan administrator and trustee are responsible for overseeing the operations of the Plan. As such, the Company, utilizing the recommendations of advisors, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

B. Eligibility

Employees are eligible to participate in the Plan at the age of 21 and after the completion of 2 consecutive months of service. The entry date of the Plan is the first day of the Plan quarter (January 1, April 1, July 1, or October 1) coinciding with or following the date on which the employee met the eligibility requirement. Union employees, leased employees, part-time employees, and expatriate employees (Japanese employees hired by the Company) are excluded from participation in the Plan.

C. Contributions

Contributions to the Plan include employee elective deferrals including Roth 401(k) deferrals, employer matching contributions, employer profit sharing contributions, and employee rollover contributions. Eligible employees may contribute up to the maximum amount allowed by law, and as defined by the Plan, subject to certain limitations for highly compensated individuals. Unless participants elect to not defer or to defer another amount or percentage of

compensation, participants meeting the eligibility requirements, as described above, are automatically enrolled at 6%. Participants who attained age 50 before the end of the Plan year may make additional catch-up contributions. The Company may make discretionary matching or profit-sharing contributions to the Plan. For the year ended December 31, 2024, the Company matched 50% of the first 6% of compensation deferred each pay period.

D. Participant Accounts

Participants' accounts are maintained by The Standard and are credited with the participant's contributions, the Company's contributions, and an allocation of the investment income (loss) and charged with fees upon receiving loans or distributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions plus actual earnings thereon, is based on years of continuous service. A participant is fully vested in the portion of his/her account attributable to any Company discretionary matching and profit-sharing contributions after six years of continuous service as follows:

<u>Years of Continuous Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 year but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 years or more	100%

Notwithstanding the above, a participant becomes fully vested upon death, disability, or attainment of normal retirement age.

F. Notes Receivable from Participants

Participants may borrow from their account balances at a minimum of \$1,000 and maximum of 50% of their vested account balance. A participant may have only one loan outstanding at any time. The loans, which are collateralized by the balance in the participant's account, bear interest of 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

G. Payment of Benefits

Upon separation of service due to retirement, termination, death or disability, a participant or representative may elect to receive the value of the vested balance in his or her account as a lump-sum distribution, substantially equal installments, or a partial withdrawal. In addition, a participant may request a distribution from their fully vested pre-tax or Roth elective deferral accounts upon a hardship or once they attain the age of 59 1/2.

H. Forfeited Accounts

Amounts forfeited by participants who are terminated from the Plan prior to being 100% vested are used to reduce employer contributions. Total unused forfeited balances as of December 31, 2024 and 2023 were \$6,972 and \$20,030, respectively. During the year ended December 31, 2024, \$52,812 of forfeitures were used to reduce employer contributions.

2. SUMMARY OF ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

B. Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 3 for discussion of fair value measurements.

D. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

E. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

F. Payment of Benefits

Benefits are recorded when paid.

G. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants or beneficiaries are charged directly to the participant account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of registered investment companies.

H. Subsequent Events

Subsequent events have been evaluated by management through October 2, 2025, the date these financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability,
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

There have been no changes in the methodologies used on December 31, 2024 and 2023. The following is a description of the valuation used for the assets measured at fair value:

- *Unallocated contract:* The Plan has a guaranteed return account with Minnesota Life Insurance Company. The guaranteed return account is reported at contract value as this is the relevant measurement attributable to fully benefit-responsive investment contracts. Contract value is the amount Participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for information on the guaranteed return account.
- *Pooled separate accounts:* The Plan has pooled separate accounts consisting of mutual funds. The fair value is based on quoted net asset values of underlying investments held by the separate accounts. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Each pooled separate account provides for daily redemption at the published NAV per unit with no advance notice requirements.

The preceding methods described produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. MINNESOTA LIFE GUARANTEED RETURN ACCOUNT

The Plan entered into a fully benefit-responsive investment contract with Minnesota Life Insurance Company, which totaled \$577,616 and \$720,869 at December 31, 2024 and 2023, respectively. The general account assets are invested in the general assets of Minnesota Life Insurance Company, which are predominantly high-quality fixed income investments (bonds, mortgages, private placements). The account is reported at contract value and credited with interest at the rate specified in the contract. All benefit payments prior to contract liquidation are made at book value (principal invested plus interest earned). There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the ability of the Plan to transact at contract value such as: (1) complete or partial plan termination or merger with another plan, (2) Plan sponsor events such as bankruptcy, spin-offs, divestitures, layoffs, or retirement incentive programs, (3) the liberalization of Plan withdrawal or transfer rules, or (4) the failure of the trust to qualify for exemption under ERISA. Upon occurrence of any of these events, a market value adjustment may apply. The Company does not believe the occurrence of any such events, which limit the Plan's ability to transact at contract value with participants, is probable.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by The Standard or affiliates; therefore, these investments and investment transactions qualify as party-in-interest transactions. Administrative expenses paid by the Plan to The Standard for contract administrator fees totaled \$25,945 for the year ended December 31, 2024. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. An unrelated service provider was paid \$32,609 from the Plan for consulting and other professional services.

Notes receivable from participants also qualifies as an exempt party-in-interest transaction.

6. INFORMATION PREPARED AND CERTIFIED BY A QUALIFIED INSTITUTION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. For 2024 and 2023, respectively, The Standard and Minnesota Life, qualified institutions, certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value, investments at contract value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivables from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their employer contributions.

8. TAX STATUS

Effective January 1, 2022, the Plan adopted a non-standardized defined contribution pre-approved plan designed by Minnesota Life Insurance Company, which the Internal Revenue Service had determined, by a letter dated June 30, 2020, is designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the letter. However, the plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The following is a reconciliation of net assets available for plan benefits per the financial statements to the Form 5500 as of December 31, 2024 and 2023:



