## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Engendren Corporation 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Engendren Corporation 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - The Engendren Corporation 401(k) Plan, ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The preparation of these financial statements includes the plan administrator's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 6, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - Engendren LLC d/b/a IEA, LLC is the plan sponsor, employer and the plan administrator. MAP Retirement, Inc. is the third party administrator and performs various compliance tests as tax counsel. John Hancock Life Insurance Company (U.S.A.) ("John Hancock") is the investment agent that has custody of plan assets and maintains investment and participant records. Strategic Retirement Partners is the plan's investment advisor. One officer of the plan sponsor is the trustee.

**Investments** - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the investment account summaries and prospectuses for more information.

At the end of each business day, John Hancock determines the fair value of the investments held in its sub-accounts and allocates the fair value to the participants. The net appreciation (depreciation) in the fair value of the John Hancock sub-accounts, including investments bought, sold or held during the years, is reflected in the statements of changes in net assets available for benefits.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

*John Hancock sub-accounts* - The sub-accounts are valued at the net asset value ("NAV") as provided by John Hancock, which is generally based on the fair value of the underlying investments held by the sub-account less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the sub-account will sell the investment for an amount different than the reported NAV.

- (a) The objective of these funds is to seek capital appreciation and current income utilizing a risk profile that is consistent with the target date of the funds.
- (b) The objectives of these funds are to provide for capital appreciation and/or income consistent with the risk and return of the fund type summarized above. These funds utilize various U.S. and foreign equity market segments to accomplish their objectives.

### 2. DESCRIPTION OF THE PLAN

The following description of the plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

**General** - The plan was established on January 1, 1992 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - The plan covers all employees who have completed 250 hours in a three month period and have reached age nineteen. An employee can enter the plan immediately following completion of eligibility requirements.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made as follows:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan permits Roth elective deferral contributions. After meeting eligibility requirements, employees are automatically enrolled in the plan and have 4% of compensation withheld as deferral contributions. These participant deferral percentages automatically increase by 1% each year thereafter until they reach a maximum of 10%. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer matching contributions may be made at the employer's discretion. The current employer matching program is equal to 50% of the first 6% of employee compensation contributed to the plan as elective deferral contributions, funded coinciding with the employer's payroll.
- d. Non-elective contributions may be made at the employer's discretion. There were no non-elective contributions in 2024 or 2023.

**Participant accounts** - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage monthly. Participants can stop making contributions at any time.

**Vesting** - Participants are always 100% vested in their elective deferral and rollover contributions and related earnings. Participants begin vesting in discretionary employer matching and non-elective contributions and related earnings prior to January 1, 2022, upon one year of service at which time they are 33% vested. The participant then vests at the rate of 33% for each year thereafter until year three when they are 100% vested. Participants begin vesting in discretionary employer matching and non-elective contributions and related earnings after January 1, 2022, upon two years of service, at which time they are 25% vested. The participant then vests at a rate of 25% for each year thereafter. Upon death, disability, attainment of early retirement age (defined as the later of 55 years of age or the tenth anniversary of an individual's participation in the plan) or normal retirement age while employed, participants become 100% vested.

**Payment of benefits** - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability, attainment of normal retirement age. Participants generally receive their distribution in the form of a single lump sum payment. In-service withdrawals can commence upon attaining the age of 59 ½. Hardship withdrawals are permitted under certain circumstances.

**Administrative fees** - Certain administrative fees of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for loan and distribution fees and nonparticipant directed charges for service, administrative and advisory fees. The nonparticipant directed charges are allocated to participants on an account value basis.

**Forfeitures** - Forfeited nonvested accounts, which are held in a noninterest-bearing cash account, are used to reduce employer contributions, pay plan fees or restore participant balances previously forfeited. Forfeitures used to reduce employer contributions were \$17,000 and \$25,000 in 2024 and 2023. Unapplied forfeitures were \$44,000 and \$13,000 as of December 31, 2024 and 2023.

**Notes receivable from participants** - Participants can take out loans against their accounts with the approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. The repayment term cannot exceed five years unless the loan is for the purchase of a primary residence. Participants may only have one loan outstanding at a time. As of December 31, 2024, the notes receivables from participants had various repayment schedules through November 2029 with interest rates ranging from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

### 3. PARTY-IN-INTEREST TRANSACTIONS

The plan investments are managed by John Hancock. John Hancock is the investment agent as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. Direct fees paid to John Hancock by the plan were \$33,000 in 2024 and \$29,000 in 2023.

In addition, John Hancock provides certain administrative services to the plan pursuant to a services agreement between the plan sponsor and John Hancock. John Hancock receives revenue from mutual fund service providers for services John Hancock provides to the funds. This revenue is used to offset certain amounts that would otherwise be owed by the plan to John Hancock for its administrative services to the plan. If the revenue received by John Hancock from such service providers exceeds the amount owed under the services agreement, John Hancock remits the excess, in the form of service credits, to the plan on an annual basis. Such service credits are allocated to the accounts of the participants. There were no such service credits received by the plan in 2024 and 2023.

Activity related to notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the company has the right to terminate the plan subject to the provisions of ERISA and subsequent amendments. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

### 5. INCOME TAX STATUS

The plan adopted an FTWilliam pre-approved profit sharing plan. The pre-approved profit sharing plan received a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

### 6. INFORMATION CERTIFIED BY JOHN HANCOCK

Management has obtained certifications from John Hancock, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values of such, noninterest-bearing cash and notes receivable from participants as of December 31, 2024 and 2023;
- b. Net appreciation (depreciation) in fair value of investments and interest income on notes receivable from participants during 2024 and 2023;
- c. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023; and
- d. The report of individual participant accounts as of and for the years ended December 31, 2024 and 2023.
