1. Plan Description

The following description of the Service Express, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all employees of Service Express, LLC (the Company or Plan Sponsor) who are age 21 or older. Empower Trust Company, LLC (Empower) is the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Subject to certain limitations, employees participating in the Plan may elect to make voluntary contributions through salary reductions on a pre-tax or Roth after-tax basis. The Company may make discretionary matching contributions or discretionary contributions to the Plan. All employees participating in the Plan are eligible to receive the discretionary matching contributions. Employees must be employed on the last day of the Plan year to be eligible to receive any discretionary employer contributions. The discretionary matching contribution is in the form of a matching amount equal to a uniform percentage of each participant's eligible compensation. Company contributions are determined annually at the option of the Company's Board of Directors. In 2024 and 2023, the Company made a discretionary matching contribution in an amount equal to 50% of elective deferral contributions up to 6% of compensation. The Company did not make a discretionary contribution in either 2024 or 2023. Participants may also contribute amounts representing rollovers from other qualified plans.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, allocations of the Plan's earnings or losses, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant's account is debited for transaction and managed account expenses.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are immediately vested in all Company contributions and earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts amounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate reasonably equivalent to prevailing market interest rates. Principal and interest must be paid over the term of the loan through payroll deductions not to exceed five years, unless used to purchase a principal residence up to 15 years. Interest rates on

notes receivable outstanding as of December 31, 2024 range from 8.25% to 13.25%. Each participant may not have more than one loan outstanding at any time.

Payment of Benefits

Participants are entitled to receive as benefits the entire vested amount allocated to them at termination, total disability, or death. Benefit distributions are payable in either a lump sum or as a rollover to another qualified plan. Account balances below certain thresholds, as defined by the Plan, will be distributed automatically in a lump-sum payment. Withdrawals may also be made upon attainment of age 59½ and circumstances of financial hardship as defined by the Plan.

Forfeitures

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are first used to restore any prior forfeited balances that are required to be restored, with the remainder used to pay administrative expenses or reduce employer contributions. In 2024 and 2023, forfeitures used to either pay administrative expenses or reduce employer contributions were \$16,020 and \$89,030, respectively. As of December 31, 2024 and 2023, there were unallocated forfeitures in the amount of \$20,294 and \$21,283, respectively.

Administrative Expenses

Expenses paid by the Plan represent fees associated with certain fund expenses, the issuance of notes receivable from participants, and certain other administrative fees related to withdrawals or transfers. These expenses are allocated to specific participants who enter into these transactions. All other Plan expenses are paid by the Plan.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual method of accounting.

Subsequent Events

Subsequent events have been evaluated by management through October 14, 2025, the date these financial statements were available to be issued, for events requiring recording or disclosure in the Plan's financial statements.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains or losses on investments bought and sold, as well as held during the year.

Contributions Receivable

Employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and are measured at the unpaid principal balance plus unpaid accrued interest. Defaulted loans, if any, are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

3. Fair Value Measurements

In accordance with Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, the Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

Level 3 - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following valuation methodology was used to measure the fair value of the Plan's investments:

Mutual Funds - These assets are valued at quoted market prices in an exchange and active market, which represent the net asset value (NAV) of shares held by the Plan.

Collective Investment Trusts (CIT) - These assets are valued at the NAV of the shares held by the Plan at year-end, which is provided by the trustee and is determined based on the fair value of the underlying investments held by the fund less their liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The CIT provides for daily redemptions by the Plan at reported NAV with no advance-notice requirement. There is no restriction in place with respect to the daily redemption of the CIT. There are no unfunded commitments related to the CIT. The fund is a direct filing entity.

The Plan's valuation method may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation method is appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

5. Related Party and Party-in-Interest Transactions

Participant loan and distribution processing fees are paid to Empower by participants. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts.

The Plan is administered by the Company. Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their accounts.

7. Income Tax Status

The Plan has adopted a pre-approved plan document sponsored by The W. L. Burmeister Company. The Internal Revenue Service (IRS) has provided an opinion letter dated June 30, 2020, that states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Transfers from Other Qualified Plans

Effective July 2024, the ServiQ 401(k) Plan (ServiQ Plan) merged into the Plan. The net assets of the ServiQ Plan totaling approximately \$81,000 were transferred.

Effective January 2023, the Trident Computer Resources, Inc. 401(k) Profit Sharing Plan (Trident Plan) merged into the Plan. The net assets of the Trident Plan totaling approximately \$3,574,000 were transferred.

Effective June 2023, the assets and liabilities of the Insperity 401(k) Plan (a multiple employer PEO plan) attributable to the current and former employees of iTech Solutions Group, LLC merged into the Plan. The net assets totaling approximately \$908,000 were transferred.
